

### **2019 Show Information & Conditions**



- 1. Nominations to be RECEIVED no later than Wednesday 6<sup>th</sup> March 2019.
- **2.** Late entries will be only accepted by 4pm the day before the class is run.
- 3. Copies of NRHA member confirmation for owners and riders plus a copy of the horse licence and a copy of the receipt of payment MUST be received with the entry form, please. Failure to supply this information at the time of entry will incur an additional Office fee charge.
- 4. For Sanctioned events, owners and riders must be current financial members of the National Reining Horse Association. All horses must be licensed with the NRHA. Any transfers of ownership need to be completed by the NRHA prior to showing. A copy of horse competition license and copy of NRHA membership card must accompany entry form or entries will not be accepted. Copy of NRHA membership can be obtained by logging onto the NRHA membership page and click on Print Membership Confirmation. Please send entries in PDF Format
- 5. A copy of the Biosecurity Horse Health Declaration must accompany entries.
- 6. The working order will be drawn and will be as per program with the exception of late entries, which will run first.
- 7. All sanctioned classes will be run in accordance with the NRHA Handbook.
- 8. Horses that are entered for both events in concurrent run class will only have one run and the score will count for both events and will therefore <u>only pay one Judges Fee upon nomination</u>.
- 9. By way of making an entry you are assuming responsibility for and binding owner, rider and/or agent to the terms and conditions as set out. The indemnity and consent form accompanying entry form must be completed and signed or entries will not be accepted.
- 10. Management reserves the right to alter this program once final entry numbers are known.
- 11. Reining Australia eligibility caps are used throughout the Show. It is the responsibility of the **owner/or rider** to be aware of the official earnings of the horse/or rider as recorded by Reining Australia. Please check this on the Reining Australia website whilst completing entry forms.
- 12. RA Green Rider all Riders must be enrolled in the RA Green Rider Program. Only one level can be entered not both.
- 13. Only financial RA/QRHA members are permitted to ride on the grounds for the duration of the show.
- 14. All Youth riders aged 13 years and under MUST wear an approved safety helmet at all times whilst mounted refer Reining Australia policy on the RA website. Any youth aged 18 years and under must not ride or handle any Stallion refer RA policy on the website
- **15.** DOGS must be kept at campsites. **No dogs allowed in marshalling area or in vicinity of Grandstand.** All dog droppings must be picked up, especially in the stable area.
- 16. No smoking in the main arena grandstand. Please use designated smoking areas.
- 17. All competitors riding on the grounds must have saddles and bridle and correct footwear at all times.
- 18. Only current members of NRHA & Reining Australia (R.A) & QRHA or an Affiliate Club are permitted to ride a horse on the showgrounds. For insurance purposes, anyone riding astride a horse must be covered by membership even if not competing. An employee must submit a Certificate of Currency of Insurance that covers any employee riding but not competing.
- 19. QSEC is a No Glass Venue.
- 20. During the show, 2 x QRHA Committee Members appointed to address grievances or issues raised will be visible wearing Hi Vis Vests. All grievances, queries or concerns must ONLY be addressed to these Committee members (Must have both members present). Grievances will require lodgment of written grievance details on QRHA Grievance documentation available from the office.
- 21. Management reserves the right to decline any nominations deemed incomplete or incorrect in any way

### **QRHA NON SANCTIONED EVENTS – MUST BE A MEMBER OF QRHA & RA**

BEGINNER RIDER/HORSE: Restricted to riders who have not won more than 3 Reining events

(sanctioned/non-sanctioned) as at 1st January 2019 JUNIOR REINING HORSE: For horses five years & under. SENIOR REINING HORSE: For horses six years and over.

Western attire and Saddlery not compulsory in these non-sanctioned classes however a long-sleeved shirt and hat or helmet required (no caps). Riders may use one or two hands on the reins or change from one handed to two handed throughout the performance. Any legal headgear is allowed.

hydration (pinch test) time of 1-2 seconds.

#### DECLARATION BY OWNER OR PERSON IN CHARGE OF HORSE/S

I declare that the aforementioned horse/s named has/have been in good health, eating normally and not showing signs of illness during the 3 days leading up to attendance at this event. I give my authorisation for the designated Event Organising Committee Representative to call for veterinary inspection of the horse/s named above and in my care should they be showing signs of illness at any time during the course of the event. I agree to pay any veterinary fees incurred as a result of this.

#### I AGREE TO ENSURE THAT:

- 1. I will not bring a sick horse to QSEC grounds.
- 2. In the event that my horse does become sick whilst at QSEC or that I call a Vet for any purpose to visit my horse whilst at QSEC, I will advise QSEC staff immediately
- 3. I wash my hands regularly and observe good biosecurity practices whilst at QSEC.
- 4. If required, before movement, all horses will be shampooed, rinsed and allowed to dry, and their hooves will be picked clean of all solid material and washed with shampoo.
- All vehicles/equipment accompanying the horses will be in a clean condition at the commencement of travel to QSEC.
- 6. The information contained in this Horse Health Declaration is true and correct to the best of my knowledge.
- 7. I agree to abide by all conditions and directions of QSEC or the event organiser.
- 8. I acknowledge that failure to comply with the above may result in refusal of entry to the venue; disqualification or other disciplinary action as decided by QSEC or the event organisers.
- 9. I acknowledge that there is a possibility that horses might become infected with disease agents as a result of any movements and if necessary horses and premises may be quarantined in accordance with any legislation covering such occurrences including policies and procedures in effect at that time.
- 10. In the event of horse movement restrictions, each owner/person in charge will be responsible for the care, maintenance and cost of their horse/s, including feeding and watering.
