Dear Irish Draught and ID Sport Horse Owner,

If you would like to have your Irish Draught Horse or Irish Draught Sport Horse inspected this year, please send the following application to the registration office. If you have more than one horse, please copy the form as many times as you need. If your horse is located at an address significantly different from the Owner address - please provide the location of the horse for determining inspection sites.

Please send in the application and the inspection fee by May 1. The number and location of the inspection sites will be determined based on paid applications postmarked no later than May 1, 2019. Registration need not be complete to send in an application for inspection. However, completed registration will be required prior to inspection. Applications postmarked after July 15, 2019 must include a \$75.00 late fee per horse. **No applications will be accepted in the 3 weeks preceding inspections, and all paperwork must be complete and fees paid by that time.**

The 2019 Inspection Fees are as follows:	Members	Non-Members
Geldings (at least 2 years old)	\$100	\$150
Mares (at least 2 years old*)	\$300	\$350
Stallions (at least 3 years old)	\$550	\$575
Deferred Horse fee	\$100	\$125

\*purebred mares must be 3 years old.

**Remember, inspection sites will be determined by the number and location of paid applications received by the May 1, 2019 deadline. We anticipate inspections will be held between September 10 - 20, 2019.**

**Rules for Inspection**

- 1) Fees will not be returned in the case of a horse failing inspection.
- 2) **The horse's IDHSNA papers MUST be submitted to the inspection officials at the time of inspection.**
- 3) Horses presented for inspection must be clean and well groomed. Purebreds coming forward for inspection should NOT have the hair on their fetlocks trimmed or clipped.
- 4) The owner and/or handler presenting a horse for inspection shall not communicate with any member of the inspection team before, during or after the inspection, except with the designated technical delegate.
- 5) **All horses must be DNA typed**
