



#### Lou and Josh clarify Tenorio Ada attack ad

# FOR IMMEDIATE RELEASE October 1, 2018

Lou Leon Guerrero and Josh Tenorio today are setting the record straight regarding misrepresentations of the truth in the latest advertisement released by the Tenorio Ada campaign.

"This latest attack by the opposition continues to highlight their flagrant disregard for the truth," Lou Leon Guerrero said.

Today's false advertisement claims that Lou Leon Guerrero was against a home for foster children. In fact, their ad said "Lou said NO." That is a misrepresentation of the statements of Lou Leon Guerrero who indicated her concern was for the safety of the foster children in that area. In her written testimony to then Vice Speaker Benjamin Cruz, proposing to locate a home for foster children in Tamuning, Lou opposed the cliffside location stating, "My main objection concerns the SAFETY of the children and the environment of where we place them. The property is on a cliff line that drops right down into the reef and the deep blue ocean." Additionally, Lou points out the property "fronts a heavily trafficked road with cars travelling way above the speed limit." She concluded, "It would be a tragic event if a child wanders off to explore, leaves the supervised site and travels off to the cliff side area, loses footing and falls. Or while playing outside, the child dashes out to the road and gets hit by a speeding car."

Leon Guerrero stated that she supports the Rigalu Foundation and the efforts of Sister Brigid Perez to build the foster home for the children but simply wanted it to be in a safe location.

"This latest false attack ad by the Tenorio Ada campaign is even more offensive considering my family's commitment to the Rigalu Foundation," she said.

#### Background:

- Bill 332-32, introduced on May 6, 2014, is relative to a land exchange to build a Foster Home facility and identified Chamorro Land Trust property situated in Oka Point, Tamuning.
- Substitute Bill 332-32 was passed on December 17, 2014, had a provision that required the legislature to approve or reject by resolution within 90 days of its passage or it shall be deemed approved.
- Resolution 21-33, was then introduced on February 23, 2015, calls on the government of Guam to identify "a suitable lot to effectuate an exchange of government-owned









property reserved for the Department of Public Health and Social Services for government-owned property owned by the Chamorro Land Trust commission pursuant to P.L. 32-226." A legislative public hearing was held on April 24, 2015. The final version of this resolution in its passage, rejected the proposed Tamuning site.

### Reason for opposition:

- There was public opposition to the use of the Oka property citing safety of the children, access to the proposed facility, and even security issues. This opposition garnered the attention of the Tamuning Mayor and members of the Tamuning Municipal Planning Council.
- Lou Leon Guerrero, in a letter addressed to Vice Speaker Benjamin Cruz on December 17, 2014 expressed that her main objection to the Oka point location is "SAFETY of the children and the environment of where we place them. The property is on cliff line that drops down into the reef and the deep blue ocean. It fronts a heavily trafficked raod with cars traveling way above the speed limit. When deciding where to erect this facility it is critical that the surroundings be assessed and all possible safety concerns be mitigated, addressed and resolved. It will be a tragic event if a child wanders off to explore, leaves the supervised site and travels off to the cliff side area, loses its footing and falls. Or, while playing outside, the child dashes out to the road and gets hit by a speeding car."
- BOTA campaign runs a political advertisement depicting Lou Leon Guerrero that she said 'No when Foster Children needed a home."

The proposed land is property that is held in Chamorro Land Trust situated in Oka Point Tamuning. Lattended the first Tamuning Municipal Planning Council and voiced my concern in using this location for the Foster Home Facility. There were other individuals there who pointed out several issues ranging from the use of prime government real estate that could generate income to the government to protecting Chamorro land use inventory. My main objection concerns the SAFETY of the children and the environment of where we place them. The property is on a cliff line that drops right down into the reef and the deep blue ocean. It fronts a heavily trafficked road with cars travelling way above the speed limit. When deciding where to erect this facility it is critical that the surroundings be assessed and all possible safety concerns be mitigated, addressed and resolved. In the course of this due diligence Lask that the safety issues of our children be further examined and scrutinized. Please do not be haste in your decision.
