- **Contest Rules and Regulations:**
  - Contestants must agree to abide by all rules of the Railroad Days Baby Show contest that are in effect now or as announced later. Contestants agree that the time, manner, and method of judging shall be solely at the discretion of the Railroad Days Organization. The decision of the judges will be final.
  - Contestant must be a resident of Randolph County. Parents, please provide a copy of personal mail or utility bill to verify residency.
  - Contestants shall be between the ages of 0 to 24 months. Please provide a photo copy of contestant's birth certificate for age verification. Age categories are as follows:
    - 0 – 3 month girls and boys
    - 3 – 6 month girls and boys
    - 6 – 9 month girls and boys
    - 9 – 12 month girls and boys
    - 12 – 15 month girls and boys
    - 15 – 18 month girls and boys
    - 18 – 24 month girls and boys
  
- (Age is determined by birth date. Example: If a child is 6 months and 1 day old, they will be put in the 6 – 9 month category, not the 3 – 6 month category.)
  
- Completed entry forms and documentation must be received by **June 13, 2018**. Photo copies of age and residency documentation are permissible. A complete entry will include:
  - \$3.00 Entry Fee
  - Completed official entry form
  - Copies of documentation for age and residency
- The winners will remain for a short time immediately following the contest for publicity photos.
