The Los Angeles Intellectual Property Law Association ("LAIPLA") announces its 2016 Diversity Fellowship that is open to law students meeting at least the following criteria:

- Expected to graduate from law school in <u>2017 or 2018</u>;
- Have an interest in practicing intellectual property ("IP") law in the Los Angeles area (involving copyrights, trademarks, trade secrets, and/or patents);
- Are from a "diverse background," which is defined broadly as those who are underrepresented in the IP bar and includes, but is not limited to, women, racial and ethnic minorities, individuals who identify as LGBT, and those who are differently abled;
- Possess "potential to succeed" as an IP attorney, which is defined broadly to include, but is not limited to, history of leadership, previous work experience, experience in overcoming difficulties, etc.

For 2016, LAIPLA is proud to announce that there will be two Diversity Fellows selected. This year, the Diversity Fellowship is graciously sponsored by SHEPPARD, MULLIN, RICHTER & HAMPTON LLP and LEWIS ROCA ROTHGERBER CHRISTIE LLP ("Sponsors"). LAIPLA FELLOWSHIP

As one of the two LAIPLA Diversity Fellows, you will have the unique opportunity to work with one of the Hosts for the summer:

Requirements and Guidelines:

1. Each Fellow will be expected to work during regular workday hours at the respective Host. The work schedule will not exceed 40 hours a week for 10 weeks. The \$5,000 stipend will be issued by LAIPLA to each Fellow as follows: \$2,500 at the beginning of the Fellowship, and \$2,500 around halfway through the completion of the Fellowship.

2. The Fellowship is a distinct and unique opportunity. It cannot be used to satisfy school credit or any other program or project.

3. Once applications have been reviewed, representatives from LAIPLA will contact potential candidates for an interview. For finalists, an in-person interview may be required. These interviews will take place within the next few weeks after the deadline of March 27, 2016. Once the Fellows are selected, each successful candidate will be contacted by LAIPLA representatives about one week after the interviews are completed.

4. LAIPLA will make the final selection. The selection process will include input from representatives from the Sponsors, LAIPLA Board members, and members of the Hosts.

5. In the event that either selected Fellow is unable to begin his/her fellowship, other applicants may be subsequently contacted to fulfill the Diversity Fellowship.
