Veterans Day Recognition Event to Be Hosted At Cultural Arts Center

In a unanimous vote, Mayor Patrick J. Furey and members of the Torrance City Council approved a \$5,000 expenditure recommended by the Social Services Commission for a Veterans Day Recognition Event to be hosted in the Torrance Cultural Arts Center on November 10.

"Just a brief history of the recent events that the City has held in honor of Veterans Day: In 2015 the Armed Forces Day Committee did recommend a \$5,000 expenditure, which the Council did approve, for a Veterans Day Program coordinated by the City," Staff Liaison to the Social Services Commission Viet Hoang said. "It was held in conjunction with U.S. America Vietnam War 50th Commemoration Commemorative Partner Program."

In the past, members of the Council have shown support for military veterans events--in particular those that provide a direct benefit to local veterans. Hoang reminded the Council that last year the body agreed to subsidize \$470 in rental fees for the Nakano Theater in order to host a Veterans Day celebration event, which was actually coordinated by the Vietnam Veterans of America, South Bay Chapter 53. This year's event will include a program and lunch, and the commission is working to use this as an opportunity to attract the different community organizations that serve veterans in the Torrance community.

"I was a part of the 2015 and 2016 celebrations and I am looking forward to this time 2017," said Councilman Milton S. Herring. "I'm also glad to see that it will be a lunch instead of a breakfast. Although veterans don't mind waking up early, the senior ones might like to sleep a little later."

During the most recent commission meeting in June, staff was directed to contact several organizations dedicated to serving veterans, including the Department of Veterans Affairs and the California EDD. Hoang shared that a number of other organizations will be invited

California Lawmakers Want More Clarity About DNA Evidence

No one knows how many rape-testing kits are sitting in police department evidence rooms in California when they should be in a DNA lab being analyzed. One California assemblyman is intent on learning the exact number and why evidence in reported sexual assault cases isn't in a database used by investigators statewide. The measure introduced by Assemblymember David Chiu, D-San Francisco, is aimed at reducing the number of untested sexual assault evidence kits throughout California. The bill for the first time requires law enforcement agencies to report to the California Department of Justice annual data on sexual assault evidence kit collection and testing, providing "greater transparency for survivors, policy makers and the criminal justice system," according to a press release from Chiu's office.

The Assembly has unanimously approved the measure, which is moving toward vote in the State Senate. The bill sailed through two state Senate committees last month, yet is opposed by the California State Sheriff's Association on the grounds that a new DNA evidence reporting requirement places a financial burden on local law enforcement. The push for more clarity and accountability with the DNA evidence comes amidst a national campaign to better manage sexual assault evidence and reduce a backlog of untested kits.

"The neglect of sexual assault kits with no explanation of why they were not analyzed simply adds to the trauma endured by survivors seeking justice," said Alameda County District Attorney Nancy O'Malley, who supports the measure. Participation by police and sheriffs wouldn't pose a burden or be time-consuming, O'Malley believes. The additional reporting in Chiu's bill can be accomplished with "a few extra keystrokes" in the statewide DNA tracking system for sexual predators, she explained.

The bill's author says there is no comprehensive data available in California about the number of sexual assault evidence kits that local law enforcement agencies collect annually or how many kits are analyzed. No comprehensive data exists either about why some sexual assault evidence kits are not analyzed, according to Chiu.

"There is a significant public interest in knowing the percentage of rape kits that are analyzed to identify the perpetrator's DNA profile, as well as the reason for any untested rape kits not being analyzed," the bill's language explains. "Currently, there is no mandatory statewide tracking mechanism to collect and report these metrics. It is the intent of the Legislature in enacting this section ... to correct that."

The cost to test DNA evidence in a rape case can reach \$5,000, and a 2014 report by the California State Auditor revealed that each year kits go unanalyzed by DNA laboratories for a variety of reasons. Chiu says the scope of the problem, however, cannot be properly estimated due to "a lack of effective tracking at the local level."

Women and men who report sexual assaults often know their attackers, according to statistics cited in a paper by Dean Kilpatrick with the National Violence Against Women Prevention Research Center. In nearly 80 percent of the cases reported to police, the victim and the accused perpetrator had an intimate relationship. Kilpatrick defined that connection as a current or former spouse, live-in partner, dating partner, boyfriend or girlfriend. About one in four sexual assaults are committed by strangers, a National Women's Study found. Even when the accused attacker's identity is known, there is good reason to enter their DNA in the state's sexual assault tracking system, according to Chiu.

Forensic analysis often helps identify repeat offenders. That can only occur if city police and county sheriff departments input sexual assault evidence into the Sexual Assault Forensic Evidence Tracking system, or SAFE-T. Lawmakers created the database in 2015 without requiring police, sheriffs and other law enforcement agencies to log in every rape kit they collect. Chiu's measure would make it mandatory, along with an explanation why investigators chose not to send off a kit to a public or private DNA-testing lab for analysis.

The state collects and stores DNA data of people who are arrested on suspicion of committing crimes, under a voter-approved initiative from 2004. Prop. 69 expanded the

SBWIB Awarded Grant for Pre-Apprenticeship Development in Engineering

The South Bay Workforce Investment Board (SBWIB) has been awarded \$240,000 by the California Workforce Development Board to continue developing its new Aero-Flex Pre-Apprenticeship (AFPA), which creates a career pathway for engineering. The funding will be utilized to expand the pilot program; designed as an employer-driven earn and learn model that will build a workforce pipeline to help meet the needs of area aerospace employers.

The AFPA is a customizable program allowing each individual employer to design or “flex” the program’s curriculum to meet the needs of industry and of each participating manufacturer. Program participants will gain career knowledge in engineering, gain valuable work experience, connect with top employers ready to hire, gain industry association membership and more. Partnering employers will be able to flex the curriculum to their needs, build their workforce pipeline, receive funding to support training and recruitment and have access to a pool of talented job seekers ready to work. The program timeframe is 6-12 weeks and consists of work readiness

training, industry specific occupational skills training and on-the-job work-based learning, provided by Aero-Flex member employers.

The AFPA provides an innovative and customizable framework that allows employers to easily invest in pre-apprentices with flexibility to respond to their priorities, labor market changes and innovations in the field. AFPA will be shared regionally throughout the Los Angeles Basin to bring together additional employers, workforce development partners, community colleges and others.

The SBWIB is expecting to enroll up to 100 Aero-flex Pre-Apprentices with this funding. Additionally, students will be provided \$500 stipends for their participation and successful completion of the program.

Current partners include El Camino College, West Los Angeles College, Tooling U-SME, Training Funding Partners and AMP So/Cal. Some of the employer partners include Northrop Grumman, L-3 Communications, Magnetika, Impresa Aerospace, Space Vector, Ten Tech, Space Vector, Verisurf and Zodiac Aerospace.

South High Volleyball Team Loses to Eventual Champs

The South High boys’ volleyball team was young and there was no doubting that fact. A youthful roster with nine junior players certainly had no problem taking the Pioneer League by storm, though. Under head coach Aaron Saldana, the Spartans’ regular season was full of win streaks and impressive runs that led the team to a division championship and back into the CIF Southern Section Division 2 playoffs. Though the Spartans’ postseason was cut short when the team lost to this year’s eventual CIF champions, South showed dominance with its size and timely hitting that will surely play a factor once again in an inevitable championship run next season.

The South High Spartans volleyball team has seemingly called the CIF playoffs home for as long as anyone can remember now. Beginning the regular season in the way that the Spartans began theirs gave fans of the team a glimpse into how they consistently make their dominance look so easy on a year-in and year-out basis. Two dominating sweeps over the Damien Spartans (2-0) and the Mission Viejo Diablos (2-0) got South High off to a flawless start. It was the team’s play toward the middle of the season and just before league play, however, that really demonstrated what a terror it would be to all rivals from the Pioneer League. Throughout a 10-game stretch at the beginning of March, the Spartans lost just one game to the Tesoro Titans and won all nine others by a total of 22 sets to just four combined for all of their opponents.

If domination like that didn’t impress many people, then what South High did in divisional play must have really opened some eyes. The Spartans’ rivals stood no chance. Not only did the team win every set and match that it played against Leuzinger, but also roughed up on its inner-city rivals as well. The second place West High Warriors lost both matches by scores of 3-0 and 3-1. The third place North High Saxons lost both matches by a combined 6-0. Torrance High would rather not have even showed up for their matches, losing both by scores of 3-0. The Spartans finished Pioneer League play going 8-0 with first place and a championship in the books before the CIF playoff matchups were set in stone.

Neither the playoffs nor the Simi Valley Pioneers could slow South High down from the 14 wins in 15 games accumulated just before the postseason. Once those playoffs finally did begin, though, the Spartans made quick work of the Pioneers before sweeping through the San Gabriel Matadors in the second round

and the Woodrow Wilson Bruins in the CIF quarterfinals. South’s winning ways had brought the team all the way to the semifinals where it would face off against a dominant Notre Dame Knights (32-8-1, 9-3) squad.

For once, at the most inopportune time, the Spartans got a taste of their own medicine. Junior setter Kohl Kutsch came to play, as he had done all season long, but opposing setter Christopher Hall simply proved to be too much to handle. Kutsch’s 25 assists and three kills were bested by Hall, who put together a whopping 40 assists of his own in a 25-17, 25-19, 25-21 straight-set victory over South. “I just don’t think we were as mentally prepared as we should have been,” a dejected Kutsch explained after the match. “They played harder today. They played better and did one hell of a job.”

South kept things close in the third and final set when Luke Krzmarzick slammed seven kills to the Fritz Burns Gymnasium floor at Notre Dame, but even his effort was not enough to overcome a superior Knights team. Notre Dame went on to finish things up in its next game during the CIF final as well, beating the Calabasas Coyotes to take home the championship trophy. The Knights also went on to make it into the championship game of the regional finals, losing to Clovis by a final of 3-1.

Despite the team’s early exit from the playoffs, the Spartans have a lot to look forward to in what will inevitably be another impressive and successful volleyball season next year. Not only will the six-foot-three Kutsch be returning to lead the team, but he’ll also be followed by junior libero Cory Hutchison and the aforementioned junior opposite Krzmarzick, as well as well six other juniors who will all be in their prime to form what will undoubtedly be one scary club. “We thought we would be standing on top, but we have a lot to look forward to next year,” Kutsch said. “We’re getting our core back and we have to come back with a lot more firepower. We have to do it next year.”

The Spartans (29-6, 8-0) will have 15 players coming back next season in order to get the job done. A CIF championship is surely something that is never promised, but if the Spartans had one year in which they might be favored to do it, it will be next year. As a team that consistently dominates the Pioneer League, Coach Saldana and the rest of the Spartans are chomping at the bit to get back on the volleyball court and avenge their loss in the CIF semifinals of what was an otherwise extremely successful 2017 season.

Torrance High School Celebrates Its Centennial

September 11, 2017 marks Torrance High School's 100th year. Located on Carson Street in the heart of downtown Torrance, the city's first high school was listed on the National Register of Historic Places in 1983. Its beautiful architecture has attracted Hollywood film companies, and counts *Buffy the Vampire Slayer*, and *Beverly Hills 90210* among its film credits. This past week I met with Torrance High School Centennial Committee members Debbie Hays and Karen Gebhard, who were filled with anticipation for the upcoming celebratory festivities. The rededication and ribbon-cutting of Torrance High School, sponsored by Valfour Beatty (who is responsible for the renovation at the school), will take place on Monday, September 11.

But the celebration begins on Friday, September 8 with a football game at Zamperini Stadium. This event will not only include current football players and cheer teams, but all former (not old) football players, coaches, band members, cheer team, pep squad and drill team members. Preparation

1. Heat oven to 325 F. Toss hazelnuts and pine nuts with 2 tablespoons olive oil; spread on small baking sheet. Toast in oven until golden brown.

State Travel Ban to Texas Will Do Little to Help LGBT Community

At the beginning of the year, California lawmakers decided to establish a ban on state-funded travel to the Lone Star State in response to an adoption law that will allow discrimination against members of the LGBT community seeking to adopt children. Without getting lost in details, the Texas law will allow child welfare providers the right to deny referrals for things like contraceptives, drugs or devices, and the ability to refuse to contract with other organizations that don’t share their “sincerely held religious beliefs.” In essence, the law allows any religious zealot to say no to whomever they please. Discrimination of any kind should never be tolerated and without a doubt we should stand and fight against it. However in this case, I do question the effectiveness of this symbolic protest.

Californian leaders’ opposition to Texas’ HB 3859 isn’t about far-left political ideology, but about equality. However, the state travel ban, which also includes Alabama, Kansas, Kentucky, Mississippi, North Carolina, South Dakota and Tennessee, is more of a symbolic measure that does little, if anything, to address the issue at hand. Lawmakers in the Golden State should work a lot harder to have an impact where it matters most: in Texas’ pocketbook. Yes, the lack of state officials traveling to Texas will have some financial impact, but not enough to pressure lawmakers to reconsider their choice. Lately, many businesses in California have been closing shop to relocate to Texas (Toyota Headquarters leaving Torrance). California’s

leaders need to keep businesses from leaving, but more importantly they need to find a way to entice other companies to make California their home. Not an easy task, but becoming a business destination will have a bigger impact on a state like Texas than a ban on state-funded travel.

The more appealing our state is to businesses, tourist and future residents, the more we can fight old ideas of religious-based discrimination. In addition, when Californians visit states where LGBT members are victims of discrimination, it is a learning opportunity for both our elected officials and the demographic being targeted. Plus, few things have a bigger impact on changing minds like financial consequences do. Remember last year when North Carolina presented its controversial Bathroom Bill regarding transgender individuals using government facilities? Due to that attack on the LGBT community a year ago, the NBA relocated its annual All-Star game, which was scheduled to take place in Charlotte. As a result, the city and state lost an estimated \$100 million during the course of the weekend. That doesn’t include money lost from concerts and other shows canceled because of the law.

Is it possible for California lawmakers to have such a strong impact on Texas’ pocketbook? Probably not, to be honest. But cutting off state-funded travel to the state does more harm than good. You don’t abandon a friend in a time of need, and right now the LGBT community in Texas needs the help of all of its friends. •

Traveling Trump Triumphs at G-20 Gathering

President Trump, who returned last week-end from the G-20 summit held in Hamburg, Germany, is now set to board his big plane and jaunt across the pond again. as well, given that the commission's goal is to have up to 10 organizations represented at the event, with booths provided so that they can announce their services to veterans in attendance. One concern addressed by Councilman Mike Griffiths, who expressed absolute support for the event, was the commission's inability to request meal donations from restaurants that do business with the City, despite the City being capable of doing business with companies that donate all the time.

"When staff did check with the City Attorney's office regarding that, there is one thing that the City Attorney's office did recommend--that we evaluate whether there might be a conflict with any provider," said Hoang. "That is not to say no unequivocally, but the City Attorney's office did recommend that rather than accepting any donations of food unequivocally, that staff evaluate the extent to which there might be a conflict."

While the explanation did little to convince Councilman Griffiths, Mayor Furey ensured that it is better to side with caution. "The cleanest way to do anything is to pay for it. We have it in the budget to pay for it and therefore we do it that way, rather than ask an organizations

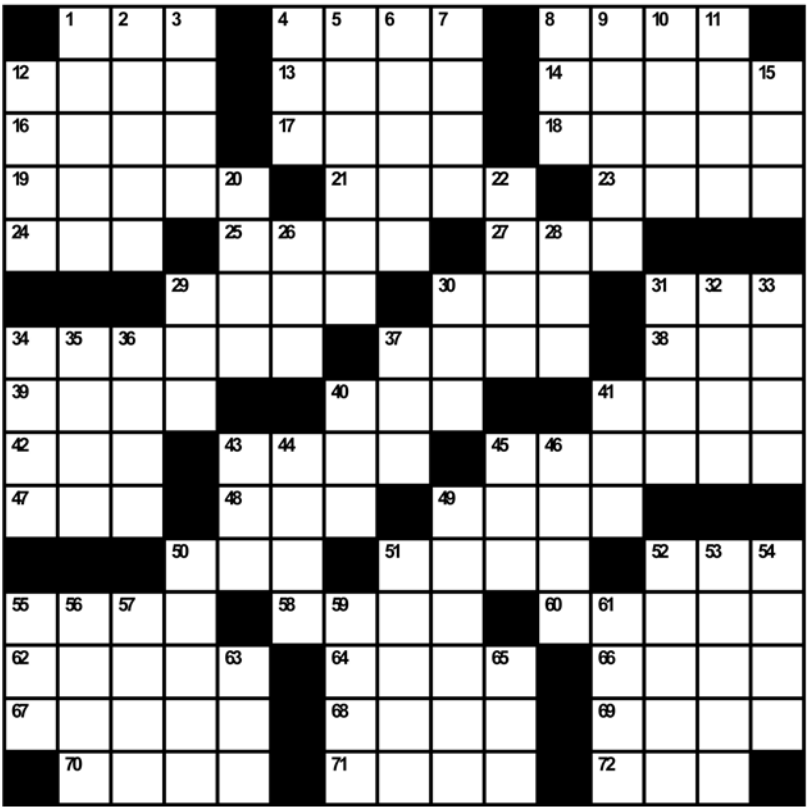
or businesses in our community to donate for various causes," said Furey. "It's a very good cause, but sometimes it takes a period of time to make a methodology of just calling people and asking them to donate."

Made up of seven governing members, the Social Services Commission is responsible for addressing a variety of issues, including the needs of the city's homeless population, adults with developmental disabilities, children with special needs and military veterans. As of its last meeting, the commission and staff began working to secure the necessary arrangements for the event. As the November 10 date approaches, the commission will return to future Council meetings and inform the community on the different ways in which it can participate in recognizing the community's military veterans.

"I want to commend and congratulate the Social Services Commission on the excellent way that they are moving forward to bring the various agencies and the various sectors of the community together around homelessness, special needs adults as well as veterans," said Councilman Herring. "I am happy to see that we are moving forward with our veterans celebration in November." •

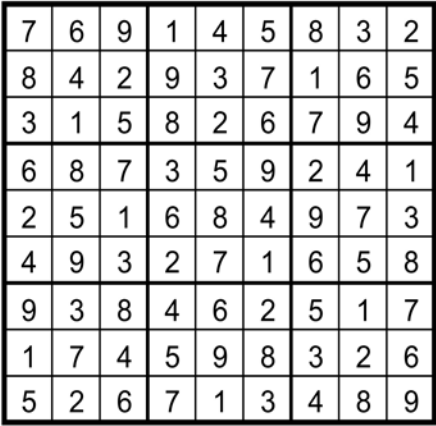

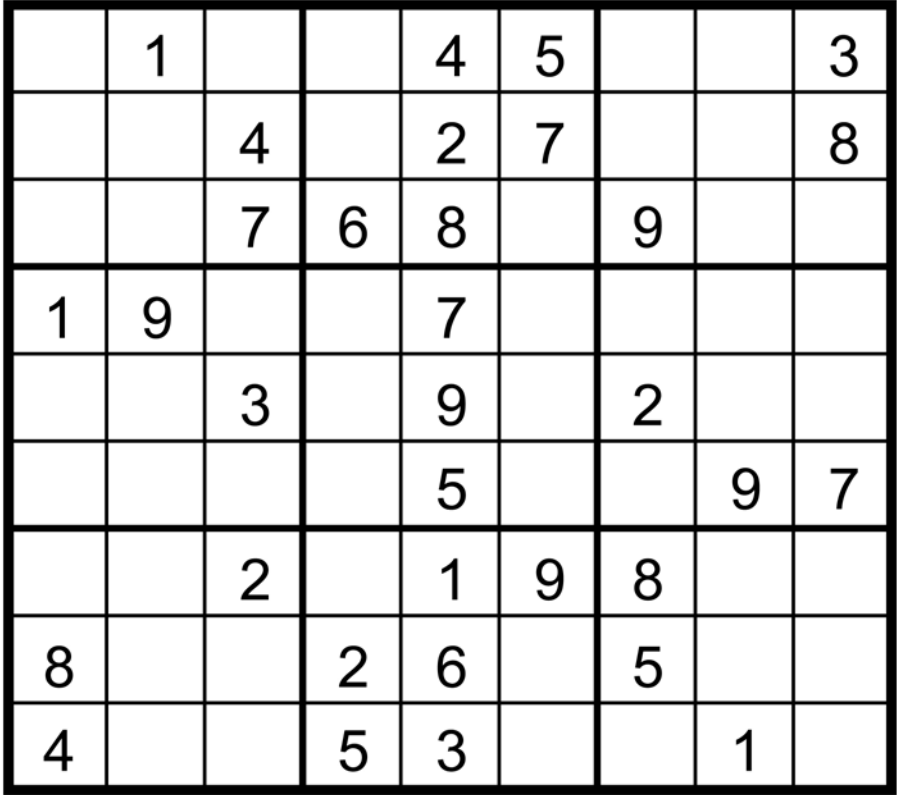

collection and use of criminal offender DNA samples and palm print impressions. The state Department of Justice reported in May that 917 “hits” were made by investigators who were looking at suspects. A “hit” connects a suspect with prior offenses or crimes.

Chiu’s bill would require law enforcement agencies to inform the California Department of Justice within 120 days of taking the DNA samples. There is an additional reporting duty on the DNA labs to explain why they haven’t tested a sample within 120 days of receiving it, and if the evidence goes unprocessed beyond that time. If approved by the Senate and signed into law, Chiu’s bill would not cover untested evidence taken before January 1, 2018.

A spokeswoman with the state Department of Justice said that the DNA crime labs have reduced any backlogs using grant money from the New York District Attorney’s Office. The Department of Justice and its Bureau of Forensic Services examines approximately 2,000 sexual assault kits per year. DNA is being tested in less than 30 days, and the state is further improving testing with a program called Rapid DNA Service, or RAD.

The state’s top law enforcement agency says that 46 California counties use the expedited testing service. Los Angeles County is not one of them, and along with large areas of Orange County and San Diego use other public DNA labs as part of their sexual assault investigations.

The costs to expand testing and reporting aren’t specified, however, Chui’s bill says the state by law must reimburse local cities and counties for complying with the order. The current effort to identify and track sexual predators is being funded with a \$1.6 million grant from the Manhattan District Attorney’s Initiative to eliminate backlogs of untested rape kits. Former Attorney General Kamala Harris, now a U.S. senator, announced the award in September 2015 to give law enforcement an assist in identifying and stopping serial offenders.

“DNA testing results use a ‘smart on crime tool’ that we’ve used in cutting edge ways in California,” Harris said. “Evidence of sexual assault is too important to sit dormant for months while victims await justice. This grant will allow us to use our Rapid DNA Service Team’s technology to assist more of our law enforcement partners across California in eliminating their sexual assault kit backlogs.”

California has touted its progress with rapid testing of DNA evidence at state labs, first announcing in 2012 that its RADS team had eliminated the backlog of untested kits at the state-run labs. Last week, a Department of Justice spokeswoman confirmed that 46 counties that participate in RADS also were caught up on their DNA rape case testing. RADS has caught the attention of the U.S. Justice Department, which presented then-Attorney General Kamala Harris and her staff with an award for innovation in victims’ services. •
