- The Management Board shall be vested with the conduct and management of the business and the affairs of the Foundation.
- No remuneration can be granted to the Management Board members.
- Expenses will be reimbursed to the Management Board members on production of the necessary proof.
- The Foundation shall be represented by the Management Board, in so far as not otherwise provided for by law.
- Furthermore, the Foundation may be represented by two members of the executive Management Board acting jointly, of which at least the chairman is one of them.
- The Management Board may grant to and confer upon other persons powers of attorney for the representation of the Foundation at law and otherwise within the limits defined in those powers of attorney.

integration, and it involves every individual in the society. The entirety of this policy covers the first five years of the foundation. Our aim is to contribute to the society for the benefit of the public.

Mission: We are a foundation, existing to contribute to a complete and sustainable integration of refugees and asylum seekers together with their host communities, as well as creating a platform for cultural exchange for all. We also provide other types of humanitarian and developmental assistance to whenever possible. For the next 5 years, our focus will be on sustainable community integration and growth, through education and research, women and youth empowerment.

Vision: Our vision is to become the international body that pioneers sustainable local integration in communities around the world; increasing the awareness of its importance, developing projects, and leading research in this field. We also hope to be among the top foundations, providing other forms of humanitarian and development assistance within The Netherlands and beyond. All aimed at building a closer and more integrated community where everyone feels at home.

Beneficiaries: Our beneficiaries or target group include asylum seekers and refugees, less privileged population, other members of communities where we are present.

In Europe, we hope to reach and impact every member of the society, especially with socio-cultural integration. In Africa and Asia, our target group will also include individuals without jobs, widows with low or no income, youths from low income families, and orphans.

To achieve our mission and vision, we organize different types of activities, projects and events. Since our existence, we have been very active in the field of local integration in The Netherlands. We have created 5 main projects namely;

- Integration Chatroom (ICR)
- Games from Around the World (GAW)
- Language lessons and book clubs
- Bike Tours for integration purposes
- Integration through education (My University Cares Too) Project.

All these projects have been recurring, weekly, every other month, every 3 months and during summer period respectively. My University Cares Too (MUCT) is an educational project launched on 18th April 2018, with the assistance of Erasmus University Rotterdam. It assists refugees and asylum seekers with information to access education in The Netherlands, and to build a network within the student community. They are all focused on local integration of refugees and their host communities. We expect that MUCT will grow into an international project, extending to other EU countries and beyond.

Those who have participated in these projects have represented our target audience in The Netherlands, Dutch and foreigners, including refugees. Other activities and events we organize include bike tours, educational symposiums, conferences and special talks.

Beyond our activities in Netherlands and the region, we have now begun to encourage our volunteers to give assistance in different locations they find themselves in, and this will include assisting orphaned and less privileged population in Africa and Asia, with education and health

related challenges. We are now in the process of raising funds to support educational and empowerment programs in these regions.

For the first year of its existence, the foundation has focused its resources in The Netherlands, and has achieved some of its goals and aim. In the second year until February 2018, our plan is to make more local impact, by extending our work beyond Zuid-Holland, reaching to other parts of The Netherlands, and at the same time a commencement in building relationships with other like-minded entities around Europe and in some parts of Africa, as we prepare to grow our reach through the help of volunteers in these other locations.

1. Its own fundraising activities: anniversary fundraising, charity sales and donation boxes at our events, which began on 10th February 2018.
2. fund organizations such as Wijdoenmee.nu and a local church in The Hague
3. Financial support from Leiden University, The Hague University of Applied Sciences and Erasmus University Rotterdam. These funds were not paid into our accounts or given in cash but were used to make logistical and entertainment payments for activities we worked together on as partners or sponsors.

6. Expected income for 2018-2020 will come from the above and new sources, including the EU and Orajne fonds.

We are in the process of applying for subsidies and grants from national and international bodies such as the European Union, Orajne funds and municipality funds. Ensuring that the bodies we apply to, are in sync with the foundation's mission. These funds will help us to compensate our volunteers and hire staff members for the continuity of our projects and for the benefit of the people and communities we serve.

No staff member has been remunerated since its existence, since they have all volunteered their experience, services and time. We have as well done our best to reduce costs by taking on many tasks ourselves, using our own resources, as well shopping on discount whenever we see the opportunity.

When the foundation engages in ventures that generate income, it will solely for achieving the purpose of the foundation, and not for making profits.

Following the articles of association of the foundation, and in keeping with the need for transparency and accountability, we conduct a yearly review of our income and expenditures, to give our donors and the public insight into our financial integrity.

Our board members are not remunerated simply for being board members. Our articles of association make provisions that allows refund for expenses made by board members for the foundation, or other kinds of financial allocation for carrying out the foundation's work such as payment for transport and other logistical support. It is worthy of note that sometimes the exact amount spent on projects may vary from what is reflected in the accounts, since many times, supporters and partners make expenses on behalf of UID with their own finances and as thus, are not always reflected in our books.

All the foundations income and expenses follow strict rules, guaranteeing that we spend to achieve the aims of the foundation, and that we take care to only receive donations from non-controversial and non-discriminatory sources. This is done in accordance with the rules of The Kingdom of The Netherlands. The foundation publishes its annual financial records publicly on its website.

ANBI requirement upon liquidation (Article 16 of UID's Articles of Association)

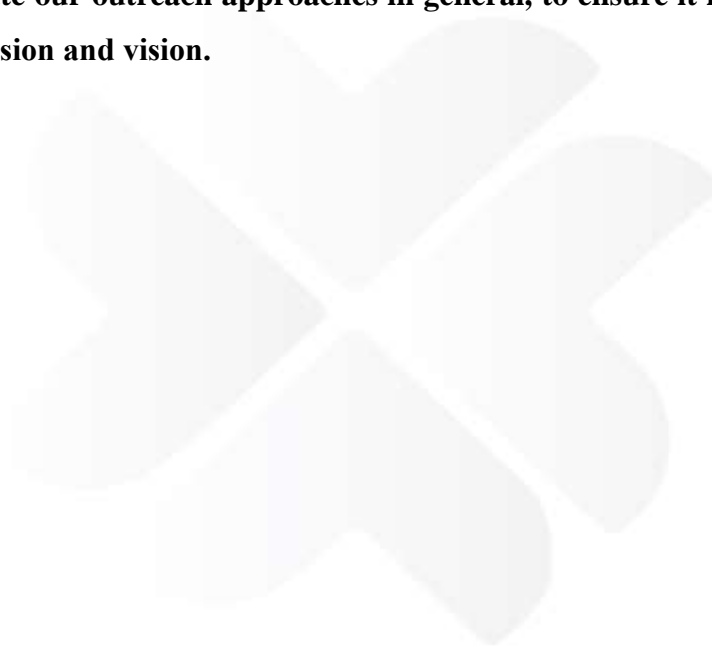
