I received word from Attorney Patrick McSweeney that the City of Richmond officials signed the Memorandum of Agreement (MOA) between the City of Richmond and the Sons of Confederate Veterans. It was explained that the City of Richmond officials needed to sign the document first and then the SCV. The MOA signed by the city officials was sent to me, I signed it and sent it on to C-I-C McMichael for his signature. The signed document has been received by Attorney McSweeney and will be distributed to the appropriate agencies.

The signed MOA gives the Virginia Division SCV the authority to maintain the Confederate section of Oakwood, do improvements on this section and install upright markers for our Confederate heroes. Their final resting place will be marked with their names instead of numbers. We hope to order and install 75 upright stones a month depending on how quickly the Veterans Administration can complete them and send them to us. The VA asked that we order only 10 upright stones for a trial run and after that, we should be able to order 75 at a time.

The first set of 10 upright markers have been ordered from the Veterans Administration. Compatriot John Kindred sent me a list of the names and units of the first 10 stones. This list, and others as they are ordered, will be placed on the Virginia Division Web site and sent out on the Virginia Courier, as well as being placed in the Confederate Veteran Magazine. We do not have an installation date yet, as that will be determined by how long it takes to receive the stones but the installation date will be announced once the stones have arrived.

As you can see, the first set of 10 stones includes Confederate soldiers from Alabama,

Florida, North Carolina and South Carolina. This is a project that will require the help of SCV units from across the Confederation. It will take years to install the stones according to the planned schedule that has been established. Again, this project is not merely a Virginia Division project. It is a National SCV project involving each and every member. We need your support and your monetary donations to see this project through, restoring dignity and honor to our Confederate Veterans whose final resting places have been too long neglected. Please consider joining the Friends & Descendants of Oakwood Confederate Cemetery and help in this endeavor. As per our Memorandum of Agreement, we must install the stones in order by section and row. Keep an eye on the Virginia Division Web site, Confederate Veteran Magazine and messages from the Virginia Courier for updates and announcements regarding installation dates and the names of the veterans in the group to be installed. Individual stones that have previously been placed by family members will be incorporated into the design of the upright stones (they will not be removed). The existing small numbered markers will also be incorporated into the design of the upright stones.

## HOMESTEAD VETERAN'S DAY HERITAGE VIOLATION

Sons of Confederate Veterans Headquarters Columbia, TN

The Sons of Confederate Veterans (SCV) has been informed that they may not march in the Homestead, Florida Veteran's Day Parade with the Confederate Battle Flag. The SCV is quite surprised by this anomaly. The SCV honors and respects the members of the VFW, in fact many veterans are members of both. All across the nation the SCV and VFW have worked together in harmony on many occasions to honor America's Veterans.

However, the SCV condemns the decision by the local chapter of the Veterans of Foreign Wars in Homestead, the sponsor of the parade, as the Confederate Battle Flag is a banner which denotes the valor and bravery of some of America's most renowned veterans - the Confederate Soldier. By denying the SCV participation in the parade the Homestead post of the VFW has shown that it is no longer an organization that supports the memory of Veterans but is instead more interested in promoting an agenda of political correctness.

For the last 90 years Confederate Veterans have been recognized as US Veterans by the United States Congress. The actions of the VFW show that they believe they have the authority to re-define who qualifies to be recognized as a veteran in defiance of congressional statue. Further, the actions of the VFW, in denying the SCV entry into the parade, are repugnant to the sacrifice made by many millions of veterans who have fought to preserve the Rights of Americans as established in the Constitution.

This arbitrary action of the Homestead VFW Post is an affront to Southerners of all colors and ethnic backgrounds whose ancestors served honorably in the military of the CSA, and today continue to lead the nation in voluntary service and casualties suffered by U. S. forces in conflicts around the world.

In these times all Americans should be drawn together, and American veterans equally recognized, rather than be torn apart by a small group who wishes to inject controversy and disruption into the rightful recognition of ALL American Veterans. It is also greatly disappointing that the local Veterans of Foreign Wars post is allowing itself to be used in this manner.

The SCV urges the community in Homestead, Florida to express their rightful disappointment that the memory of one group of American Veterans, Confederate Veterans, are being are being disparaged by the Veterans of Foreign Wars.

#### HOMESTEAD VETERAN'S DAY PARADE

Dear Friends and Compatriots:

I'm glad to report that there isn't much to report. Today, I got off a twelve hour night shift and loaded my flags up. I arrived in Homestead at about 10:00 am and found a business I thought might be southern sympathetic and asked permission to park my pick up next to the parade route and they agreed.

I popped down the tailgate and secured one of my 4X4 square infantry battle flags and a 3x5 Navy flag to the side of the bed, with a lawn chair on the tail gate I had an <u>excellent</u> view of the parade and they had an excellent view of me.

## **Occurrences:**

One police officer walked by and we waived, we recognized each other from the Rodeo. Two police officers walked by and kept on going, not even giving me a second look. One person from the Navy stopped and we talked for a few minutes about the military. A family and I talked for a few minutes about how important it is to teach your children Southern History at a young age as the schools don't. The most pleasant conversation was with an Army Major about the package I had. In it I have obituaries and photos of 3 friends that came home in body bags from Nam and one from Desert Storm. I told him I take my memories and dead friends to the Veterans Parade as much as I can (almost

every year). It's my way of remembering them. I think if he weren't in public and if he were in uniform it would have brought tears to his eyes, instead he was just speechless for a minute. No one from the news media stopped by or was even visible.

#### **Observations:**

The parade was less attended than in past years. Participants were also less or at least not as big. It was over in less time than in previous years. Walked down to the church and the reviewing stand was less crowded than in previous years, I guess less VIP's or dignitaries.

Of the people on the side of the road that I could identify, there was one black family with children, one couple and one black police officer seen. There were seven Mexican families and four groups of males. I believe three Cuban families and two Cuban couples. Two Anglo families and several other Anglo folks scattered. The **Latins** far out numbered everyone.

This was my very uneventful day. I went and conquered in my own small way and hardly anyone noticed. I got home at about 4 pm and finally got some sleep. We may not have been in the parade but at least we were represented on the side. Is there hope for next year? I doubt it.............

Active SCV members have recently received a post card, under the signature line of the Commander in Chief, inviting them to call a toll free number to update their personal information if they would like to be listed in the new 2010, Sesquicentennial SCV Membership Directory. This is a legitimate project approved by the GEC earlier this year.

This directory will be different from those previously published in 2001 and 2006 as there will be an opportunity for members to upload a photograph of either themselves or their ancestors. Members who agree to provide their information to be published will also be afforded an opportunity to reserve and purchase a directory. A member may also choose to not be included in the directory, and no member's personal information will be included without his express permission. If a member who does not want to be included may simply decline to call or respond by email if he receives an email invitation.

The Harris Connect Company which is the directory publisher, at the request of the SCV, purposely did not send notices to our members who are under 18 years of age. This decision was based upon feedback and comments from parents when the 2006 directory was published who did not want their minor children contacted by outside parties. ## **Beauvoir Announces Ground-Breaking for New Library:**

Beauvoir, the Jefferson Davis Home, will conduct a groundbreaking ceremony for the new Jefferson Davis Presidential Library and Museum on at 2 PM on Sunday, December 6, 2009 (the 120th anniversary of Jefferson Davis' death).

The original Jefferson Davis Library opened in 1998 and was severely damaged in Hurricane Katrina on August 29,2005. Due to the damage caused by Katrina, the original library had to be demolished. The Combined Boards of Beauvoir have approved and signed a contract with J.C. Duke Contractors of Mobile for the construction of the Jefferson Davis Presidential Library.

The construction of the new library is estimated to be 550 days(18 months) in duration and the new building will be a 25,500 sq. ft. structure.

The public is invited to attend the ground-breaking of the new library on Sunday December 6, 2009 at Beauvoir.


