Terms and conditions

In registering for a Steven Adams Camp, the campers and their parents or guardians agree to the following terms and conditions:

Health and safety

1. The Steven Adams Camps will be managed and run in accordance with the health and safety policies and procedures of the relevant venue. Camp participants are required to abide by any instructions and notices by the venue and venue staff.
2. The camp participants will be cared for under these policies and procedures while they are inside the venues during the stated camp times. The parents and guardians are responsible for the camp participants outside of the stated camp times and if the participants leave the venue. For the avoidance of doubt, parents or guardians should remain with their children until the stated start time of the camp and be ready to pick up their children prior to the stated end time of the camp. If any participant needs to leave before the end of the camp, the parent or guardian must notify camp administrators before departing the venue.

Camp participants must be fit to participate

3. I/we warrant that my child is in good health and that, to the best of my knowledge, there is no reason he or she cannot or should not participate in the kind of physical activity involved in the camps. I acknowledge further that that my child is not currently under the care of a physician for an injury or illness that would prevent his/her safe participation in the camp
4. On behalf of myself and my child, I understand that one of the risks of participating in the Steven Adams Camps, is the risk of injury inherent in physical and basketball activity. To minimize the risk of injury to my child and other camp participants, I agree to instruct my child to obey all safety rules and any other rules, regulations or restrictions set forth by any of the individuals associated with the camp. I further agree to instruct my child to fully report and/or disclose any problems related to his/her health or physical condition to the camp coaches or administrators as soon as the problem arises or becomes noticeable.
5. in the event any accident, illness, injury or other medical condition arises in connection with my child's participation in the Steven Adams Camps, I hereby authorise the camp administrators or venue staff to obtain medical treatment for my child as may be deemed reasonably necessary by any such parties.

I/we hereby consent to my child being video recorded and photographed at the camp(s) and agree that Steven Adams Camps, Sports Pathways and Goodman Fielder (Meadow Fresh brand) has the right to use the footage and photographs on social media and for educational, marketing, future promotional or other purposes at their discretion.

Code of Conduct

7. I/we acknowledge and agree that camp participants are expected to abide by the Code of Conduct and that the camp administrators may expel a camp member at their discretion for non-compliance with the Code of Conduct and that no refund will be given.
8. In registering for the Steven Adams Camps, camp participants will be expected to conform and abide by the standards set out below. Each participants will:
 - 8.1. Obey all instruction from venue staff and camp coaches and administrators;
 - 8.2. Conduct themselves in a respectful and dignified manner and treat all parties with respect;
 - 8.3. Play for fun and also try their best in all activities;
 - 8.4. Act at all times to protect the principles of fun, safety and fairness;
 - 8.5. Support other camp participants and will not use negative language or actions aimed at other camp participants;
 - 8.6. Refrain from offensive behaviour and language;
 - 8.7. Treat the facilities with respect and care;
 - 8.8. Remain in the venue unless a parent or guardian is available to take them from the venue and camp administrators are advised;
 - 8.9. Otherwise conduct themselves in a professional and positive manner.

Cancellation
