



## Apple Pie Trail Ciderfest 2018 Contest

THE "Apple Pie Trail Ciderfest" CONTEST (THE "CONTEST") IS INTENDED TO BE CONDUCTED IN ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE ONTARIO LAW. THE CONTEST IS OPEN TO LEGAL RESIDENTS OF ONTARIO ONLY. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

**1.ELIGIBILITY.** To be eligible for this Contest, an individual must:

- be a legal resident of Ontario;
- be of the age of majority in Ontario or older at time of entry;

Employees of the Apple Pie Trail, Blue Mountain Village Association Inc., Blue Mountain Resorts Ltd. and Alterra Mountain Company, employees of Apple Pie Trail member businesses (collectively, the "**Sponsors**"), their respective affiliates, subsidiaries, related companies, advertising and promotional agencies, and the household members and/or the immediate family of any of the above, are not eligible to participate in the Contest.

Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to Sponsors for the purpose of this Contest must be truthful, complete, accurate and in no way misleading. Sponsors reserve the right, in their sole discretion, to disqualify any entrant should any entrant at any stage supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

**2.CONTEST PERIOD.** The Contest begins at 9:00 a.m. Eastern Daylight Time ("**EDT**") on Thursday, June 7, 2018 and closes at 8:00 p.m. EDT on Sunday, June 17, 2018 (the "**Contest Period**").

**3.HOW TO ENTER.**

- Each entrant must submit his/her Ciderfest passport with at least 4 out of the 6 passport stamps to be entered to win. The contest page of the Passport must be filled out with the entrant's name, address, phone number, and email address.
- Limit of one (1) Entry per person.
- All Entries, become the sole property of the Apple Pie Trail. All Entries must be received no later than the end of the Contest Period. Entry forms will be declared invalid if they are late or incomplete.
- There is no purchase necessary to enter the Contest. To enter without purchasing a Ciderfest Passport, entrants must submit a photo of themselves at each of the six Passport stops along with a 500 word essay about what they think about the history of apple growing in this region.

## 4. PRIZE.

- There will be one (1) Grand Prize Winner (“**Grand Prize Winner**”) consisting of a prize package valued at \$300 CDN, including gift certificates from local Cider Houses.
- There will be two (2) secondary prizes: one (1) \$100 CDN in gift cards for participating Apple Pie Trail locations, and one (1) \$50 CDN gift card for Oliver & Bonacini Café Grill Blue Mountain.
- Prizes will be distributed within fourteen (14) days after the Prize Winners have been successfully contacted by the Sponsors, acknowledged compliance with the Contest Rules.
- Prizes must be accepted as awarded and cannot be substituted or redeemed for cash, except in the Sponsors’ sole discretion. Sponsors reserve the right, in their sole discretion, to substitute a prize of equal or greater value if the Prizes cannot be awarded for any reason.

- The Grand Prize winner and two Other Prize Winners will be notified by email no later than four (4) days after than the contest draw and must respond within ten (10) business days of notification to the contact number provided in the notification email. In order to win, the selected entrant will have to answer, unaided, a time limited, arithmetical, skill-testing question posed during a telephone interview, in person or by mail. If the selected potential Winners do not respond in accordance with the Contest rules or the selected potential Winners do not comply with the Contest rules, he/she will be disqualified and will not receive the Prize and another potential Prize Winner may be selected in the Sponsors’ sole discretion.
