TOXIC

HANDLING PRECAUTIONS

Personal Protection: When mixing or applying, avoid contact with skin and eyes. Wear full protective clothing, gloves and goggles. Do not eat or drink while using. Wash hands and face before meals and after work. Wash protective clothing after work.

Equipment: Apply using accurately calibrated and maintained equipment. Flush spray equipment thoroughly with water after use.

Storage: Store in original container tightly closed and in a locked, dry, cool, well ventilated area away from fertilisers, feed, seeds and foodstuffs. Keep out of reach of children. Store in accordance with NZ 8402 Management of Agrichemicals. As a HSNO class 9 substance certain quantities may require secondary containment and signage. See the **PRODUCT SAFETY CARD** for further information.

Spillage: Move non-essential people from the area. Wear appropriate protective clothing and prevent material from entering waterways. Absorb spills with inert material and place in waste containers. Sweep up solids without creating dust. Wash area with water and absorb with further inert material. Dispose of waste safely (such as to a suitable landfill).

Product Disposal: Ensure unwanted product is used by another operator strictly in accordance with label directions.

Container Disposal: Triple rinse container and add residue to spray tank. Dispose of container at your local AGRECOVERY container collection site. Do not use container for any other purpose.

GENERAL INFORMATION

PRONTO® is a systemic insecticide (chloro-nicotinyl group) which acts on the nervous system of insects after direct contact or ingestion.

It provides protection of Cereals from aphids and grass grub larvae, forage brassicas from aphids, Argentine stem weevil, springtails (Sminthuridae family) and wheat bugs, grass seedlings from grass grub larvae and black beetle adults, maize and sweetcorn seedlings from Argentine stem weevil and black beetle, potatoes from aphids and pumpkins and winter squash from aphids, Argentine stem weevil, grass grub beetle, Lucerne flea and springtails.

PRONTO® controls thrips in onions as a foliar spray, and the control of cabbage and lettuce aphids in lettuce and vegetable brassica seedlings (cell transplants) as a drench. For best results on cell transplants, soil should be moist and the spray mix lightly watered in after application.

IMPORTANT - RESISTANCE MANAGEMENT

PRONTO® contains the  imidacloprid. Resistance to pesticides can develop from excessive use. To minimise this risk, avoid using this insecticide exclusively all season, avoid excessive spraying and endeavour to alternate with insecticides from other groups within the crop and in subsequent seasons for a sprayed paddock. Use strictly in accordance with label instructions. Maintain good cultural practices

MIXING

Prior to mixing or decanting ensure the container is well shaken or rolled to re-suspend the formulation.

PRONTO® can be applied in conjunction with a fungicide seed treatment, or to seed previously fungicide treated.

As seed treatment may alter the flow rate of the seed, the planter must be calibrated to ensure seed treated with **PRONTO®** is applied at the desired plant population.

AT THE TIME OF TREATMENT THE SEED MUST BE DYED A DISTINCTIVE COLOUR.

CONTAINERS OF TREATED SEED MUST BE LABELLED WITH THE FOLLOWING:

- 1 Seed treated with **PRONTO®** must not be used for human or animal consumption.
- 2 Treated seed may be harmful to seed eating birds, and should be properly sown and completely covered by the soil.

- 3 Excess seed is not to be left in areas accessible to birds.
- 4 Withholding Period: Stock must not graze cereals, forage brassicas, maize, sweetcorn or pasture within 42 days of planting. (This statement must be in bold print on the labels of treated seed containers.)

Apply to high quality, undamaged seed through a properly calibrated seed treatment machine to ensure even coverage.

USE RATES It is an offence to use this product on animals.

CROP	PEST	RATE
CEREALS	Grass grub larvae	90ml in 10lra water per 100kg of seed.
FORAGE BRASSICAS	Aphids, Argentine stem weevil, Springtails, Wheat bug	12.24ml/kg of seed, higher rate will give increased aphid protection.
GRASS SEED	Black grub larvae, Black beetle adults	500ml in 1 litre water/100kg of seed.
MAIZE & SWEETCORN	Argentine stem weevil, Black beetle	500ml in 2-3 litres of water per 100kg. Some sweetcorn varieties may exhibit temporary phytotoxic effects, particularly under dry conditions
POTATOES	Aphids	50ml in 2-3 litres of water/1000kg of seed. If storing treated potatoes, ensure they are completely dry.
PUMPKINS & WINTER SQUASH	Aphids, Argentine stem weevil, Grass grub beetle, Lucerne flea, Springtails	50ml in 10-20mls of water per kg of seed.
FOLIAR / DRENCH APPLICATION		
ONIONS	Thrips	130 ml in 500-600L of water/ha. Apply when monitoring of thrips levels indicate the threshold level has been reached. Repeat applications at 7-10 day intervals with a maximum of 4 applications. The addition of a wetting agent is suggested. Ensure good spray coverage.
VEGETABLE BRASSICAS (cell transplants)	Cabbage aphids	5ml/2.5 litres of water per 1000 plants. Apply evenly to seedling trays 1 day before ONDO transplanting.
LETTUCE (cell transplants)	Lettuce aphid	12.17ml/2.5 litres of water per 1000 plants. Apply evenly to seedling trays 1 day before transplanting.

WITHHOLDING PERIODS

Cereals, forage brassicas, Pasture, Maize and Sweetcorn 42 days
 Onions 7 days
 Vegetable brassicas (cell transplants) 70 days
 Lettuce (cell transplants) 35 days
