- 26 Military Ships
- 25 Federal Military Helicopters
- 5k troops

  - On 9/27, the 101st were loading up and sending "1,000 soldiers who specialize in distribution of goods in hostile environments". This is insufficient to get aid to 3.4M Americans.
  - There has been no deployments to secure infrastructure.

- **Begin emergency evacuations** for those who have family/friends on the mainland that they can stay with so that the number of those in need of immediate relief on the Island will be reduced until the Island is stable enough for them to return.
- **Immediately lift all restrictions from the Jones Act** that may inhibit any relief efforts that require relief supplies and aid come from US ships. (The Merchant Marine Act of 1920, also known as the Jones Act: Public law 66–261 enacted in 1920)
  - Initially the president refused stating that there is “the shipping industry that don’t want the Jones Act lifted”. On 9/28 Jones act restrictions were temporarily put on hold. This isn’t enough, it needs to be abolished!
- **Immediately put all debt for the Government and individuals in forbearance** for no less than 5 years so that the Islands can rebuild.
