Line 20: 2015-2016 was Lake Cane Restoration Society's first year as a corporation with nonprofit status (i.e. 501(c)3); however this organization had been a corporation since 2008 and had not previously been required to file a tax return. There was a balance brought forward of \$9,837 that existed prior to our 11/10/2015 designation as a nonprofit.

Line 29: At our Easter "Eat, Pray, Swim" event, the attendees generously made offerings to a local charity. Cash donations totaling \$1,133 were made for the benefit of Matthew's Hope -- a local 501(c)3 that provides outreach to the homeless community. To facilitate the transfer of these directed donations, the cash was deposited in our account and a check was written to Matthew's Hope. This expense is not part of our operating budget, but does align with the fellowship goals of our organization. It is being noted here that our organization made this payment; the same amount (\$1,133) is included our contributions in Line 1.

Line 31: Monthly water quality testing is performed by LCRS volunteers. This involves a monthly time commitment of about 6 man-hours. During the 2015-2016 year, LCRS participated in the LakeWatch program which provides all our supplies and tests the water samples -- at no charge to us -- that we collect. A lake resident allows use of his canoe, so we have had no expenses for our water quality testing this year. Planning is underway for 2016-2017 to use the data to expand our environmental activities by engaging lakefront property owners in pollution-mitigating projects.
