The following is information about our easy-to-use Electronic Funds Transfer (EFT) service. This convenient service allows you to authorize Crossover to deduct your monthly gifts automatically from your checking or savings account. In addition, when we utilize this cost effective service, we can both be better stewards of God's resources by reducing processing and printing/ mailing costs.

### AUTHORIZATION INFORMATION

After filling out the attached form, you will receive a letter confirming that Crossover has enrolled you in this convenient plan. We will let you know the month of your first deduction (usually processed within a few days). Thereafter, a record of your deductions will appear on your bank statement. You will also continue to receive a monthly receipt from Crossover. Should you wish to end or amend your giving plan, or if you have additional questions, simply call 803-451-8604.

This permission to charge my account is the same as if I had personally signed a check made payable to Crossover. This agreement will remain in effect until:

1. I write or call Crossover informing them to end this agreement, and Crossover has had a reasonable period of time to act upon it. OR,
2. Crossover or my bank (if your donation is from a bank transfer) gives me ten days written notice that this agreement will end.

In the event of an error, I will notify Crossover and not my bank. I must inform them in writing within fifteen days of the date on the bank statement or within 45 days after the transfer was made.

I understand and agree that my bank is responsible for the accurate and timely posting of my transferred gift(s). In the event of an amount error or double-posting error, I will handle this problem directly with Crossover.
