Total Abortions include reported and estimated abortions from year of authorization (or first reporting if earlier) through 2015, without rounding the totals. Totals in italics are for former conglomerate countries (i.e., Czechoslovakia, Union of Soviet Socialist Republics, and Yugoslavia) for which most reported abortions are included in the separate individual countries; for U.K. territories; and the second France line includes its overseas departments.

Total for Tabulation includes total abortions for all nations and territories in Report, including the balance not attributed to the constituent republics of former nations; but removing duplication (e.g., only the abortions occurring in Guernsey, Isle of Man, and Jersey are included here; abortions occurring in the U.K. are in the U.K. Total Abortions).

Abortion %: abortion percentage gives annual abortions (in 2014) as a percentage of pregnancies ending either in live birth or abortion.

Abortion Ratio is the number of abortions per 1,000 live births (in 2014).

Population is the population estimate for 2016 from the CIA World Factbook.

Abortions % of Population is the ratio (as a percent) of total abortions to 2016 population.
