On April 27, 2019, from 1:00 – 5:00 p.m. artists will man their booths downtown and sell their original art. Attendees will also be able to purchase the plein air paintings completed at the workshop. Depending on project timeline and completion, we also hope to have live music in the Alley Way. New this year is a Steampunk art contest in Merchants Alley. Don't forget to visit Main Street Wetumpka's Tulotoma Snail Trail installations and the sculptures in Merchants Alley. The highly anticipated event is unique among the city's festivals, with artists displaying in and around participating businesses.

### **Art Trail Admissibility**

- All works must be original and created by the artist. Commercially manufactured items or items produced from commercial kits or molds may not be exhibited.
- A jury selects the participating artists and can refuse submitted works.
- Each artist must be present and show their work throughout the entire event.
- Artist may participate in both the plein air workshop on April 25 & 26 and the Tulotoma Artist Trail on April 27. If artist participates in both, they will be given a \$15.00 discount on the art trail participation fee.
- All artists must be 18 years of age or older.

### **Application Process**

- Complete the attached application.
- Enclose a CD or jump drive containing three .jpg images of work that represent the pieces to be sold during TAT. Be sure to put your name on the CD/jump drive so it can be returned.
- Each file should be named with artist first name\_ last name\_ media\_ title.
- Attach a paragraph in word format about you and your art to use in promotional material for the art trail.
- Enclose a nonrefundable check for \$50.00 made payable to Tulotoma Art Trail.
- Artist packages must be received by March 15, 2019 to be considered. See address below:

### **Time Line**

**March 15, 2019: Application package due.** Include completed application, CD of photos, and paragraph about you and your work, and \$50.00 check for artist space.

### **Acceptance**

Artist will be notified of acceptance no later than March 25, 2019. The number of spaces available is contingent on available space in the downtown area.

### **Awards**

Cash prizes will be given based on the quality of artwork. The first round of judging will review images submitted. The top scoring artists will have their entire body of work evaluated during TAT.

### **Exhibit Spaces**

All spaces are located in downtown Wetumpka.

Limit one artist per space.

Each space must be kept clean and in good shape by the artist using it.

Each artist must bring his/her own displays.

Each artist must supply his/her own tent and display.

***Each artist is responsible for collecting and submitting sales taxes to state and county taxing authority.***
