### **224 PLANNING**

- A. 17/501081/FULL Demolition of existing garage/store and erection of replacement. Elm Tree Cottage, Butlers Hill. The Parish Council recorded no objection to the application but commented that should planning permission be granted the Parish Council would request that the conditions state the replacement building remains ancillary to the main dwelling.
- B. 17/501295/FULL Single storey side extension. Springfield, Church Hill. The Parish Council recorded no objection to the application.

#### 225 MATTERS ARISING

- A. Cllr M. Cooper commented that he had not been able to make any progress on the proposals for fencing at the allotment site since the landowner has been away. The item will be placed on the agenda for discussion at the April meeting.
- B. Mr P. Wilson (attending public) suggested that the Parish seeks volunteers to create a "tidy team" to assist in general maintenance/keeping the village tidy (including dealing with litter at Wey Street, maintaining the benches on the village green and renewing the noticeboards). It was agreed that the Clerk would advertise this and would provide an update on progress at the April meeting. The area around the phone box outside the old shop requires some care and the Clerk was requested to investigate the proper ownership of the phone box.

### 226 COUNCILLORS REPORTS

- A. Cllr J. Geliot reported that there were potholes that needed repairing near the junction of Kemsdale Road/Bull Lane.
- B. Cllr M. Cooper commented that a static caravan has appeared in the horsefield on Kemsdale Road (near the Wey Street bridge). The Clerk advised that Swale Borough Council are aware of the situation and are dealing with the matter..
- C. Cllr P. Couzens requested that the Clerk liaises with the conservation office to see if the visual amenity of the area outside the old shop (where there are currently hay bales) can be improved. Cllr P. Couzens also reported that he attended the recent KALC Planning Conference and found it to be of considerable benefit. Additional documentation from the conference was handed out to Councillors/Clerk who wished to receive it.
