Terms and conditions

Buxton FC Mega Bucks terms and conditions

1. The lottery shall be called the "Buxton FC Mega Bucks" and shall be run for the purposes of conducting a small society lottery in accordance with the Gambling Act 2005.
2. The "Buxton FC Mega Bucks" is established for the purposes of raising funds to support the running of Buxton FC.
3. The promoter is:
Buxton Football Club (Mega Bucks) - The Silverlands, Buxton, Derbyshire SK17 6QH
4. Participation in the "Buxton FC Mega Bucks" will be by the purchase of a chance or chances in the manner specified in rule 5a to 5d.
- 5
 - a. Each applicant for the "Buxton FC Mega Bucks" shall join the "Buxton FC Mega Bucks" by completing an application form for participation in the "Buxton FC Mega Bucks" and authorise their bank to pay £8.68 per calendar month by standing order.
 - b. On receipt of confirmation that the payment has been set up and receipt of a correctly completed application form, the club promoters shall allocate the applicant a number unique to that applicant for the duration of the "Buxton FC Mega Bucks". The promoter will place the players number in the list of numbers to be drawn in the next full calendar week after receipt of the first payment from the applicant and every week that the player is in credit for £2 or more. Upon receipt of that payment, the applicant shall become a player in the "Buxton FC Mega Bucks".
 - c. The member shall continue to participate in each draw and shall cease to participate in the calendar week following receipt of that member's last standing order payment or where the balance of their account is below £2.
 - d. The "Buxton FC Mega Bucks" will be audited at least once per annum by an independent auditor.
6. A draw will be made at the club each week. The winning numbers being randomly selected.
7. The prizes will be a total of £550. First prize £250, 10 x £10, rollover prize of £200 which will accumulate each week if it isn't won up to a maximum of £10,000 when it will become a guaranteed prize. Four weeks per year (once every quarter) the 1st prize will be increased to £1,000
8. Details of the "Buxton FC Mega Bucks" prize amounts and winners names may be published by
 - a) Buxton FC website
 - b) Buxton FC Twitter and Facebook
 - c) Notice board in club house
 - d) Published in Buxton Advertiser
9. Any card issued to a player of the "Buxton FC Mega Bucks" shall state the following details.
 - a) The promoters' names and addresses.
 - b) Prizes may only be paid to "Buxton FC Mega Bucks" players holding drawn winning numbers.
 - c) All prizes will be paid by cheque. Cheque must be cashed within six months. Any cheques not cashed within six months will be treated as a donation to Buxton Football Club.
10. Any cards issued to "Buxton FC Mega Bucks" players by the promoter will be sent by standard post.
11. Upon termination of the "Buxton FC Mega Bucks" either under "Buxton FC" rule 12d, or 12e, the whole of the sums collected by the "Buxton FC Mega Bucks" shall after all expenses become the property of Buxton FC. No monies raised by the "Buxton FC Mega Bucks" shall be paid to "Buxton FC Mega Bucks" players other than in drawn prizes.
12. Playing of the "Buxton FC Mega Bucks" shall cease forthwith upon one of the following events.
 - a) Death of the member or termination of membership in accordance with club rule 5c or 12c.
 - b) Non payment of any standing order payment by a "Buxton FC Mega Bucks" player.
 - c) A "Buxton FC Mega Bucks" player giving one month's written notice to the promoter on or before the 30th day of the month that he wishes to cease to be a participant in the "Buxton FC Mega Bucks". No monies received from the member prior to cancellation of membership will be repaid other than in prizes.
 - d) The promoter giving not less than three months notice of termination of the "Buxton FC Mega Bucks".
 - e) The dissolution of Buxton Football Club.
13. Playing of the "Buxton FC Mega Bucks" is continuous.
14. Any unsold chances, numbers, tickets or shares remain the property of Buxton Football Club.
15. Players must be 16 or older. It is an offence for anyone under the age of 16 to participate in any form of gambling including lotteries. Buxton Football Club may on occasion carry out checks to verify this requirement under the Gambling Act 2005. If any player is subsequently found to be under 16 years of age, any subscriptions already paid will be returned and every effort made to retrieve any winnings.
16. Buxton Football Club reserves the right to refuse any application, or to cancel an existing subscription at our absolute discretion. Any rejection or cancellation may be reconsidered on submission of a written appeal to the Chairman within 7 days. The decision of the Chairman will be final.
17. An instruction to be self excluded, as defined in the Gambling Act 2005, from the "Buxton FC Mega Bucks" may be submitted in writing, emailed or telephoned to the club.
