RULES & REGULATIONS

All contestants MUST follow the laws of the Florida Wildlife Commission.

1. Rules & Regulations

Registration starts September 27th 2019 at Stinky's Bait Shack. Participants will receive their swag bag at this event. Registration forms must be received 24 hours prior to weigh-in. Weigh-in begins at 8am Sept 28 at Stinky's Bait Shack. Anglers may weigh in fish any time thereafter within normal business hours. Registration Fees are non-fundable. Participants are required by law to abide Florida Wildlife Commission (FWC) fishing regulations:

2. Tackle

ALL FISH MUST BE CAUGHT ON HOOK AND LINE WITH LIVE OR ARTIFICIAL BAIT ONLY. NO CAST NETS, ENTANGLEMENT NETS OR TRAPS ALLOWED....with exception for the Gigged Flounder Calcutta only.

3. Participation

Participants are responsible for knowing and abiding by Stinky's tournament rules and the Florida Fish and Wildlife Commission regulations, pertaining to licenses, size and bag limits, and any other regulations that may apply.

Participants agree and consent to the use of any photographs in which they appear by the tournament; to include, ANY Stinky's Fish Camp and Stinky's Bait Shack website, social media outlet, and sponsor websites.

4. Weigh-Ins

Fish are to be weighed-in at Stinky's Bait Shack within normal business hours. **Anglers are allowed to weigh-in ONE fish per species daily and must submit one of each, Red Fish, Speckled Trout, and Flounder to qualify for Grand Slam prize. Heaviest fish in each species category counts as winner and receives Grand Prize for that fish category.** All fish will be weighed as "whole fish weight".

Fish are weighed to the thousandth of a pound. Anglers are permitted to have one fish per species on the leader board daily. Any fish that appears to have been penned, mangled, mauled, mashed or otherwise altered will not be scored. Any questionable fish or rulings will be determined by a three judge panel. All judges' decisions are final. **Fish must be caught "RECREATIONALLY" - NO COMMERCIAL OR CHARTER CATCH ALLOWED!**

5. Distribution of Prizes

Prizes will be issued November 1 2019 at Stinky's Bait Shack during the tournament Awards party. Cash prizes will be awarded by check upon winner's completion of a W-9 including social security number.

6. Release of Claims

Participants do hereby release, forever discharge and agree to hold harmless Word of Mouth Restaurant Group, Inc., Stinky's Fish Camp LLC, Stinky's Bait Shack LLC, and their respective officers, directors, employees, agents, volunteers, partners, members and/or attorney's for any losses, claims, or demands whatsoever arising from and/or through the duration of the Tournament.

7. Disputes

All disputes must be submitted in writing within 24 hours of weigh-in. Resolution of disputes will be determined by a three judge panel. All judges' decisions are final.
