


Minutes of the Annual Meeting of the Connecticut T-Hangar Association

Matters Discussed	<p>We have established an initial operating budget of \$25K per year and we will be collecting condo fees beginning Sept. 1st. The monthly amount per unit is as follows:</p> <p>1. Standard T-Hangar \$58.09 per month/\$174.27 per quarter Midsize Unit (units 230-9, 230-17, 240-9, 240-17) \$66.63 per month/\$133.26 per quarter Large Unit (units 230-1, 230-8, 240-1, 240-8) \$76.64 per month/\$153.28 per quarter</p> <p>These fees are for condo charges only and do not include gas or electric. Please mail a check with you payable to "CT. Hangar Association, Inc." to me for one month's condo fee at your earliest convenience. These fees are per unit, so if you own more than one unit each one must be paid. Include your building and unit number on the check. Beginning October 1st, fees will be collected quarterly, in advance. We need funds as quickly as possible, as there is already an outstanding bill for about \$1800 for the gate repair. Once the account has sufficient funds, we will use them to pay each person back for the legal fees and the installation of individual electric meters.</p> <p>The gate is now repaired.</p> <p>It was brought up that there was no Fire insurance on the structure, I am going to get a quote on insurance from the company that has the insurance on the Oxford T-Hangars.</p> <p>A copy of a letter we are sending out to Blumenthal's office regarding the taxes was circulated.</p> <p>Everyone at the meeting thanked Gus for his help and availability.</p> <p>Collections for legal fees as of today are \$10K.
