Effect of global downturn arrested through policy interventions, with merchandise exports growing in dollar terms by 5.17% and 9.94% in 2016-17 and 2017-18 respectively, and by 7.75% and 5.70% respectively in Rupee terms.

Merchandise exports grew from Rs. 19.05 lakh crore in 2013-14 to Rs. 19.55 lakh crore in 2017-18.




Services exports grew from US\$ 152 billion in 2013-14 to US\$ 192 billion in 2017-18.




India's total exports including services and merchandise, rose from US\$ 466.22 billion in 2013-14 to US\$ 495.42 billion in 2017-18.




Exports witnessed a higher growth rate of 12.9% yoy in 2017-18 (P) (5.4% yoy in 2016-17). Imports also witnessed accelerated growth at 21.0% yoy in 2017-18 (P) (3.1% yoy in 2016-17).


Top exported products during April-March 2018 (P) were petroleum products (US\$ 37.4 billion) followed by pearl, precious, semiprecious stones (US\$ 25.9 billion) and drugs & pharmaceuticals (US\$ 17.27 billion).



Top imported products during Apr-Mar 2018 (P) were petroleum crude (US\$ 87.4 billion) followed by pearl, precious, semi-precious stones (US\$ 34.2 billion) and gold (US\$ 33.7 billion).



USA was India's top export market during Apr-Mar 2018 (P) with exports reaching US\$ 47.9 billion followed by UAE (US\$ 28.1 billion) and Hong Kong (US\$ 14.7 billion).



China was India's largest source country for imports during Apr-Mar 2018 with imports at US\$ 76.3 billion, followed by USA (US\$ 26.0 billion) and Saudi Arabia (US\$ 22.1 billion).



Focus on automating port and customs operations, green channel clearances and benchmarking turnaround time of ships with best global practices

DOC is also funding mega events like Global Exhibition on Services, Textiles India, etc, to create Mega RBSMs

India Brand Equity Foundation (IBEF) under Department of Commerce has undertaken an extensive branding exercise for a number of sectors including engineering, pharmaceuticals, agri-products, plantations, textiles, leather and services

Also over this period, it has ramped up branding efforts through the digital medium for these sectors

MARKET ACCESS INITIATIVE (MAI)

MAI Scheme of DOC provides a platform to trade bodies & export promotion councils for exhibiting their products in global & national forums

Government has approved continuation of the scheme till March, 2020 with an outlay of Rs. 980 crore

In 2017-18, Indian exporters participated in 45 Reverse Buyer Seller Meets (RBSMs) in India and 183 exhibitions/ fairs abroad funded under MAI. During the year, 13,375 Indian exporters and 10,579 foreign buyers participated in RBSMs supported under MAI

Business generation worth Rs. 18,000 crores reported in MAI-funded events in 2017-18



TRADE INFRASTRUCTURE AND LOGISTICS

Trade Infrastructure for Export Sector (TIES)

Department of Commerce was earlier working with states to fill infrastructure gaps through ASIDE.

Central Government funding normally does not exceed the equity that is put in by the implementing agency or 50% of total project equity (80% for Northeastern & Himalayan states including Jammu & Kashmir) As per the recommendations of the 14th Finance Commission, tax devolution to states has increased from 32% to 42%, thus delinking ASIDE from support of the Centre



TIES launched to strengthen export infrastructure in March 2017.

- Power guidelines issued in February, 2016 to streamline generation, transmission and distribution in SEZs





CAPACITY BUILDING





The FDDI Act 2017 came into force on October 16, 2017. This conferred the status of Institute of National Importance on FDDI
