Groundwork Ohio
Jane Marshall, Preble
June 5, 2019**

Good Afternoon, Chairman Dolan, Vice Chairman Burke, Ranking Member Sykes and members of the Senate Finance Committee. I am Jane Marshall and I am an advocate for Preble County. Today I am speaking as the Preble County representative to the United Way of Greater Dayton Public Policy Committee. Thank you for the opportunity to give testimony concerning Substitute House Bill 166, Ohio's budget bill for state fiscal years 2020 and 2021. My testimony is limited to comment and concern on Ohio's quality child care system.

A little about me: I am a farmer, a wife and a mother of five children. I am a former Preble County Commissioner. I am a CASA and I have worked for Children's services in Preble County. In addition to volunteering with United Way, I have served on a number of Social Service Committees. I am not a childcare provider (other than to my two granddaughters when my daughter works on our family dairy farm). In short, I am an advocate for Preble County and the people of Preble County.

I am here today to ask you to put an amendment in the budget bill to ensure that our Preble County day care provider's reimbursement rates are not reduced. Preble County was one of 38 counties whose categories were corrected resulting in increases in reimbursement rates effective in December last year. Now there is a new study and as a result of that, an update to the rate categories is being proposed, which will result in lower reimbursement rates for 13 counties, Preble being one of them. This needs to be corrected, so these 13 counties are held at the rates where they are now.

Preble County is a small county with about 42,000 citizens. We border two urban counties, Montgomery and Butler on the east and south, Darke County on the north and Indiana on the west. Preble County is a training ground for many jobs. Many times employees will move to one of our urban neighbors getting significantly more money. That is an ongoing story in Preble County. Lowering the reimbursement rate will only exacerbate this problem.

The other issue is the star rating system that has been implemented. Child Care centers need to have a 3 star rating by July 1, 2020. According to ODE & JFS data (see attached) we have 22 programs in Preble County with only 6 programs having at least three stars. Exactly half of the Preble programs have no stars. Educational level of the teachers is one of the things that is looked at. It is important to be able to have salaries at a level that will attract people with the needed education. Even with the December correction, the reimbursement rate is higher in the urban counties than it is in Preble (see attached). Lowering our rate is going to be a detriment to the kids of Preble County. These stars are hard enough to get without this happening.

Please understand that the people in Preble County are just as important as the people in the urban counties. Giving Preble an increase for seven months and then taking it away is not how to treat anyone. This will reduce the possibility increasing the number of star ratings in the county as well as it sends a very poor message to the people of Preble County. I don't think you want to do that. Please keep Preble County reimbursement rate whole. I appreciate your attention in this matter. I would be happy to answer any questions.
