### MEASURING and HEIGHT CARD INFORMATION

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Furthermore, this change eliminates the need for a copy of the jump height card to be submitted with an entry form. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the **Judge of Record** PRIOR to running in their class and this measurement will be valid for that weekend of trials only. The exception to this requirement is a dog entered in the 24" height division. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; **ALL** dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog **before** its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

### Simplified Jump Height Card Process

When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog needs to be officially measured. Please check the box so that the Trial Secretary knows whether to include your dog on the *Dogs To Be Measured List*. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in.

## DOGS ELIGIBLE TO ENTER

This trial is open to all dogs over the age of 15 months that are registered with the American Kennel Club or are registerable breeds that have obtained an AKC PAL/ILP number. Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under 4 months of age are strictly prohibited from the trial grounds.

## OBSTACLES AND RING CONDITIONS

Obstacles meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. All classes will take place indoors on dirt. Ring size is 84 feet X 100 feet. Arena is insulated but NOT climate controlled. **Electronic Timers & Rubberized contacts and table will be used.**

No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

**Illegible entries** will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a \$25.00 collection fee to the amount of each returned check.

Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries. No refunds will be issued for overpayment of less than \$12.

**MOVE UPS** will be accepted for the first day of the trial until Monday, October 22, 2018 at 6 PM CST. Please submit in writing (e-mail is fine) to Katherine Emge at [voyagergoldens@yahoo.com](mailto:voyagergoldens@yahoo.com). Day to day move ups will be accepted up to ½ hour after the last class of the day is completed.

**Move Up is not confirmed until exhibitor receives a return confirmation from the trial secretary.**

Entries must be made on Official AKC entry forms or copies and must include the signed Agreement and Rules. Junior Handlers must enter their JH# and complete back of form. Include only AKC titles on entries. All owners of mixed breed dogs must first obtain an AKC Canine Partners listing number before they may enter an AKC Agility event. The dog's breed name should be entered as "All American Dog". The dog's listing number must be entered on the entry form and "AKC No." checked.

### **Online Entries- Accepting online entries through [www.labtestedonline.com](http://www.labtestedonline.com).**

*Please visit their website to register, and for instructions and rules for entering online prior to opening date.* During the first 48 hours after opening, the initial limit of entries designated as either online or paper will be as follows for each trial day: 105 runs online (30%), 245 runs paper (70%). If either form of entry has not filled at the end of the 48-hour time period, the club reserves the right to decrease or increase either one accordingly.

### **"After Closing" Waiting List**

A waiting list (30 runs per trial) will be maintained for these trials once they have closed on Wednesday, October 10, 2018 at 6 PM CST. The waiting list will be active until its deadline - Monday, October 22, 2018 at 6:00 PM CST. Any dogs that are entered in these trials at closing and pulled before the waiting list deadline will be replaced, if possible, by dogs in order on the waiting list, and the exhibitor will be reimbursed in full. **If a dog is pulled but cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent for the trials.** Entry fees for dogs on the waiting list that do not get into the trial by the waiting list closing date will be refunded in full.

## COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

A warm-up area, consisting of a regulation agility jump, will be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

## RIBBONS, AWARDS, AND PRIZES

Ribbons will be awarded in each jump height division in each class as follows:

<i>First Place</i> .....	<i>Blue</i>
<i>Second Place</i> .....	<i>Red</i>
<i>Third Place</i> .....	<i>Yellow</i>
<i>Fourth Place</i> .....	<i>White</i>
<i>Qualifying Score</i> .....	<i>Dark Green</i>

A MACH or PACH rosette and decorated MACH or PACH bar will be awarded to all dog and handler teams that attain either a MACH or PACH title at these trials. A PAX rosette will be awarded to any dog finishing a PAX title at these trials. Please notify Barb Stockard, trial chair at [agilwhippet@yahoo.com](mailto:agilwhippet@yahoo.com) if you think you may be completing a MACH or PACH at our trials. A new title rosette will be awarded to any dog finishing a title at these trials. Dogs qualifying in both Master Standard and Master JWW at the same trial will receive a "Double-Q" ribbon. Dogs Qualifying in Master FAST, Master JWW, and Master Standard will be awarded a "Triple-Q" ribbon.

## NOTICE – SPRINGFIELD CITY ORDINANCE REGARDING Pit Bull Terriers

The City of Springfield, MO has an ordinance pertaining to Pit Bulls. Any owner of a pit bull (American Pit Bull Terrier, American Staffordshire Terrier, Staffordshire Bull Terrier) or any dog exhibiting these distinguishing characteristics will need to abide by this ordinance. When not showing your dog(s) you will need to have your dog(s) crated. When it is off show site it will have to have be transported in a crate in your vehicle and muzzled when in public. Your dog(s) will NOT have to be muzzled when on our private show site.

## NOTICE TO EXHIBITORS

### SAFETY, BEHAVIOR and LIABILITY

**The safety of the dog** is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

**It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. DAAO and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. DAAO reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against DAAO or any official thereof.

**All dogs must be on leash or crated at all times when on trial grounds except when in the designated warm-up area or competing on the course. NO EXCEPTIONS!**

## REFUNDS

**No entry fee** will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

**Bitches in season are not permitted to compete in Agility Trials.** As such, the club will refund all but \$5 per day of the entry fee paid for bitches unable to compete. DAAO will also refund entry fees (minus an administration fee that will also include recording fees and judge's fees for each run) if a dog becomes injured or ill after the closing date of the trial and cannot compete at the trial because of this. To receive all refunds, the trial secretary must receive written notification prior to the start of the trial each day, and the exhibitor must provide a veterinarian certificate to the club within seven days of the trial.

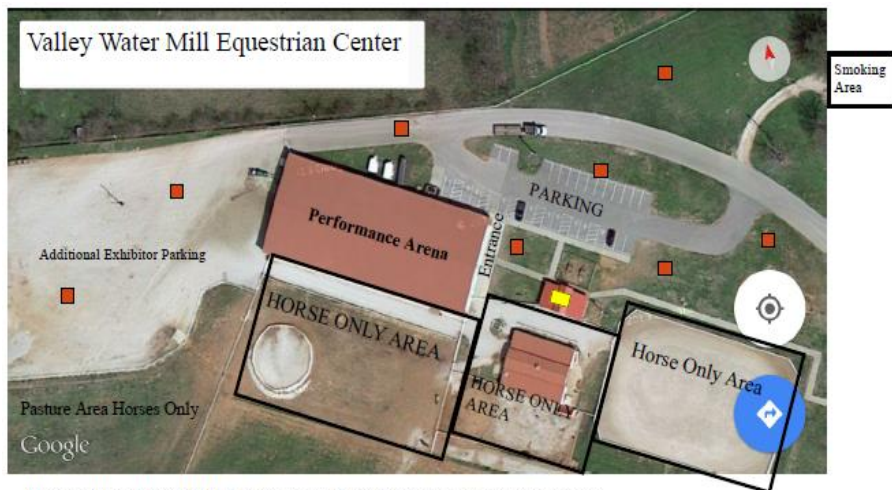
## RINGSIDE

**Dogs may arrive** any time prior to judging, if they have a valid copy of their jump height card. Otherwise, they must be available for measuring prior to the start of their class.

**Judges are not required** to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. ## **SECOND ANNUAL SPECIAL EVENT FUNDRAISER FOR CANINE CANCER**

**DAAO** will be hosting a fund-raising event for canine cancer. The event will begin 30 minutes after the end of the trial on Saturday. Entries are open to any dog eligible to enter an AKC agility trial at any level (dogs must be fifteen months old and AKC registered). Entries taken day of event from 9 AM until event runs. All proceeds to be donated to a canine cancer organization in the Missouri Ozarks area. AKC scoring used, judged by Barb Stockard, Springfield, MO (club member).

**Entry fee \$5**

Dogs can run at any jump height from 4 -24 inches. Course will consist of jumps and tunnels only, with AKC Novice course guidelines used. Two to three wing jumps will be decorated (safely) for Fall/Halloween. Prizes awarded to each jump height winner. Toys will be allowed in the ring (NO FOOD).

**From the Northwest (HWY 13):** Take I-44 East exit towards Rolla. Follow 2.5 miles until exit 80A, Glenstone Avenue, I-44 Business Loop. Turn Left (north) on Glenstone and follow 1 mile to E Valley Water Mill Road. Turn right and continue 0.7 miles to N Farm Road 171. Turn left at the stop sign onto N Farm Road 171. Stay left by the pond dam, and the entrance is on left. If you are using GPS, please be sure to use the zip code with the street address (4007 North Farm Road 171, Springfield, MO 65803) or you may be directed to Fair Grove!

**From the West (I-44 East):** Approach Springfield on Interstate 44 from Joplin and points west. Take exit 80 A, Glenstone Avenue and continue as directed above towards Valley Water Mill Equestrian Center.

**From the Northeast (I-44 West):** Take I-44 West until exit 82B, US 65 North toward Sedalia. Follow US 65 North approximately 0.6 miles to County Rd 102, first exit on the right on US 65. Follow 0.3 miles until E Valley Water Mill Road. Turn left on E Valley Water Mill Rd and continue 1.6 miles until North Farm Road 171. Turn right on N Farm Road 171. Stay left by the pond dam, and the entrance is on left. 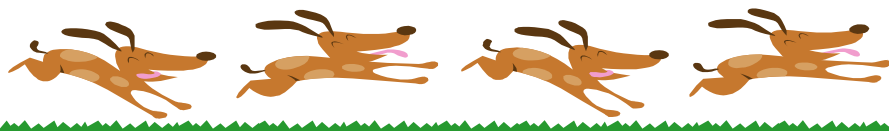

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners<sup>SM</sup>** program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.
