(Washington, DC)—The District Department of Transportation (DDOT) will temporarily close lanes, ramps and shoulders on the following roadways to perform construction activities along and near the I-295 / DC 295 corridor.

The following lane, ramp, and shoulder closures will be in place **daily from 9:30 am to 3:30 pm, Monday, July 8, 2019, through Sunday, July 14, 2019**, weather permitting.

- I-295 northbound single left or right lane between Malcolm X Avenue / JBAB (Exit 2) and I-695 to I-395 Downtown (Exit 5A)
- I-295 southbound single left or right lane between I-695 (Exits 1B-C) and South Capitol Street / Malcolm X Avenue / JBAB (Exit 2)
- South Capitol Street, SE/SW up to two left or right lanes northbound between Firth Sterling Avenue, SE and N Street, SE
- Suitland Parkway, SE eastbound or westbound single left or right lane between Martin Luther King, Jr. Avenue, SE and South Capitol Street, SE
- Firth Sterling Avenue, SE northbound or southbound single left or right lane between South Capitol Street, SE and Howard Road, SE
- Potomac Avenue, SE/SW eastbound or westbound single left or right lane between First Street, SE and Second Street, SW
- P Street, SW eastbound or westbound between South Capitol Street, SW and Half Street, SW
- Howard Road, SE eastbound or westbound single left or right lane and sidewalk between

Firth Sterling Avenue, SE and Suitland Parkway, SE

- Barry Road, SE, near Firth Sterling Avenue SE and Eaton Road, SE
- St. Elizabeths Avenue, SE southbound single right lane between Firth Sterling Avenue, SE and Sweetgum Lane, SE

The following lane, ramp, and shoulder closures will be in place **nightly from 8:00 pm to 5:00 am, Sunday, July 07, 2019, through Sunday, July 14, 2019** weather permitting.

- I-295 northbound two left or right lanes between Malcolm X Avenue / JBAB (Exit 2) and I-695 to I-395 Downtown (Exit 5A)
- I-295 southbound two left or right lanes between I-695 (Exits 1B-C) and South Capitol Street / Malcolm X Avenue / JBAB (Exit 2)
- South Capitol Street, SE/SW up to two left or right lanes between Firth Sterling Avenue, SE and N Street, SE and intermittent intersection closures at P Street, SW.
- Suitland Parkway, SE eastbound or westbound two left or right lanes between Martin Luther King, Jr. Avenue, SE and South Capitol Street, SE
- Firth Sterling Avenue, SE northbound or southbound single left or right lane between South Capitol Street, SE and Howard Road, SE
- Potomac Avenue SE/SW single left or right lane between First Street, SE and Second Street, SW
- P Street, SW between South Capitol Street, SW and Half Street, SW and full closure on P Street, SW intersection South Capitol Street, SW
- Howard Road, SE eastbound or westbound single left or right lane and sidewalk between Firth Sterling Avenue, SE and Suitland Parkway, SE
- St Elizabeths Avenue, SE southbound single right lane between Firth Sterling Avenue, SE and Sweetgum Lane, SE
- Barry Road, SE, near Eaton Road, SE
- I-295 northbound off-ramp closure to westbound Suitland Parkway, SE (Exit 3B). *Signed detour will be in place for closure.*
- I-295 northbound on-ramp closure from northbound Firth Sterling Avenue, SE. *Signed detour will be in place for closure.*
- I-295 southbound off-ramp to Howard Road / Nationals Park (Exit 4B). *Signed detour will be in place for closure.*

- I-295 southbound off-ramp to Suitland Parkway / US Naval Station (Exit 4A). *Signed detour will be in place for closure.*
- I-295 southbound on-ramp closure from eastbound Suitland Parkway, SE. *Signed detour will be in place for closure.*

The following lane and shoulder closures will be in place **daily from 3:30 pm to 9:00 pm, Monday, July 8, 2019, through Friday, July 12, 2019**, weather permitting.

- DC-295 / I-295 northbound one left or right lane between I-695 (Exits 1B-C) and South Capitol Street / Malcolm X Avenue / JBAB (Exit 2)
- St Elizabeths Avenue, SE single right lane

The following lane and shoulder closures will be in place **during the weekend from 9:00 pm, Friday, July 5, 2019 to 9:00 am, Monday, July 8, 2019** weather permitting.

- DC-295 / I-295 southbound up to two left or right lanes between I-695 (Exits 1B-C) and South Capitol Street / Malcolm X Avenue / JBAB (Exit 2)
- DC-295 / I-295 northbound up to two left or right lanes between I-695 (Exits 1B-C) and South Capitol Street / Malcolm X Avenue / JBAB (Exit 2)

Additionally, Firth Sterling Ave., SE, Suitland Parkway, SE, and Howard Road, SE will be closed nightly from July 07, 2019 to July 15, 2019 under I-295 for bridge demolition and other construction activities.

I-295 northbound on-ramp from eastbound Suitland Parkway, SE, off-ramp to Suitland Parkway, Q Street, SW between Half Street, SW and South Capitol Street, SW as well as Half Street, SW between Potomac Avenue, SW and Q Street, SW have been **closed for an extended period**. *Detours are provided for all full closures, and local access maintained where necessary.*

These closures are required for construction activities associated with the following DDOT projects:

South Capitol Street Corridor Project - Frederick Douglass Memorial Bridge

The South Capitol Street Corridor Project calls for replacing the Frederick Douglass Memorial Bridge and transforming related sections of the urban freeway into a beautiful scenic boulevard that increases pedestrian and vehicular safety, improves multimodal transportation options, increases community accessibility and supports economic development on both sides of the Anacostia River.

I-295 / Malcolm X Avenue SE Interchange Improvement Project

The multiple phases of this project include the reconstruction of the I-295 interchange with Malcolm X Avenue SE, including modified ramps and a new access roadway to the St. Elizabeth's West Campus. The planned improvements will be made between Firth Sterling Avenue SE, on the north, and the South Capitol Street/Martin Luther King, Jr. Avenue SE intersection to the south. The project will provide transportation improvements to serve the

proposed Department of Homeland Security headquarters consolidation on the St. Elizabeth's West Campus.

Rehabilitation of Anacostia Freeway Bridges over Nicholson St, SE

The District Department of Transportation project to rehabilitate the Anacostia Freeway bridges over Nicholson St, SE is part of DDOT's ongoing commitment to safety. The rehabilitation project will focus on reconstruction of the bridge deck and adjoining ramps to address deteriorating structural elements, ensuring that each bridge remains a reliable part of our infrastructure.

Motorists are urged to use caution as they travel in these areas, to anticipate moderate delays, and to be mindful of construction personnel.
