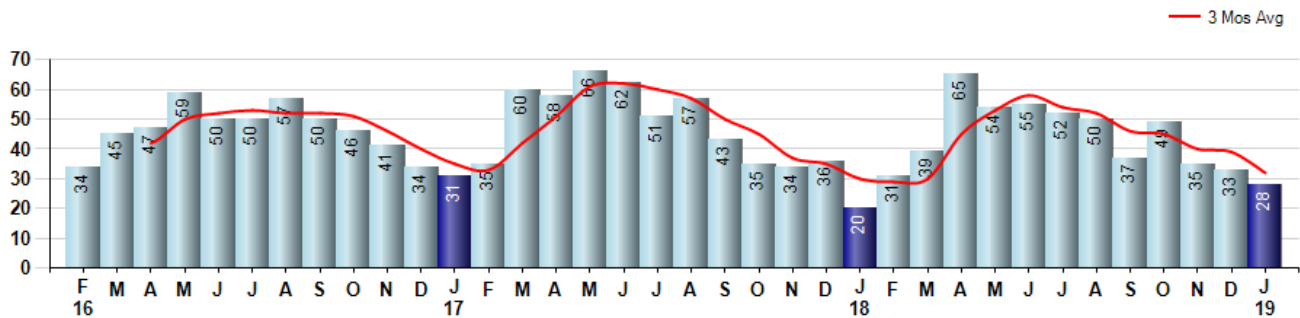

## Property Sales

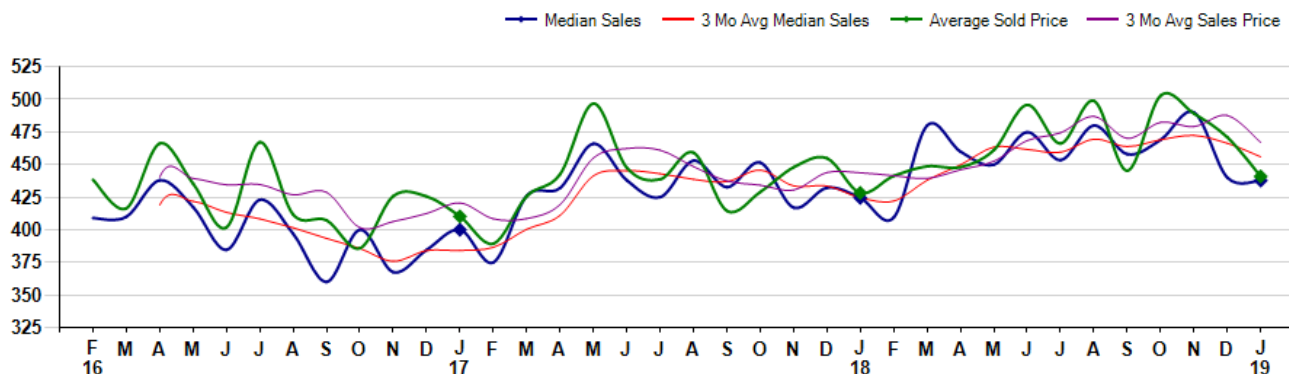
January Property sales were 28, up 40.0% from 20 in January of 2018 and -15.2% lower than the 33 sales last month. January 2019 sales were at a mid level compared to January of 2018 and 2017. January YTD sales of 28 are running 40.0% ahead of last year's year-to-date sales of 20.



## Prices

The Median Sales Price in January was \$437,750, up 3.1% from \$424,500 in January of 2018 and down -0.5% from \$440,000 last month. The Average Sales Price in January was \$440,916, up 3.0% from \$428,249 in January of 2018 and down -6.4% from \$470,960 last month. January 2019 ASP was at highest level compared to January of 2018 and 2017.

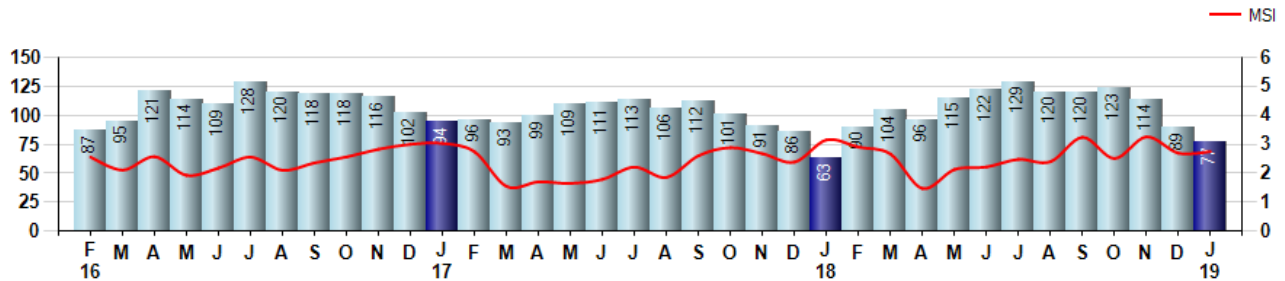

### Inventory & MSI

The Total Inventory of Properties available for sale as of January was 77, down -13.5% from 89 last month and up 22.2% from 63 in January of last year. January 2019 Inventory was at a mid range compared to January of 2018 and 2017.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The January 2019 MSI of 2.8 months was at its lowest level compared with January of 2018 and 2017.

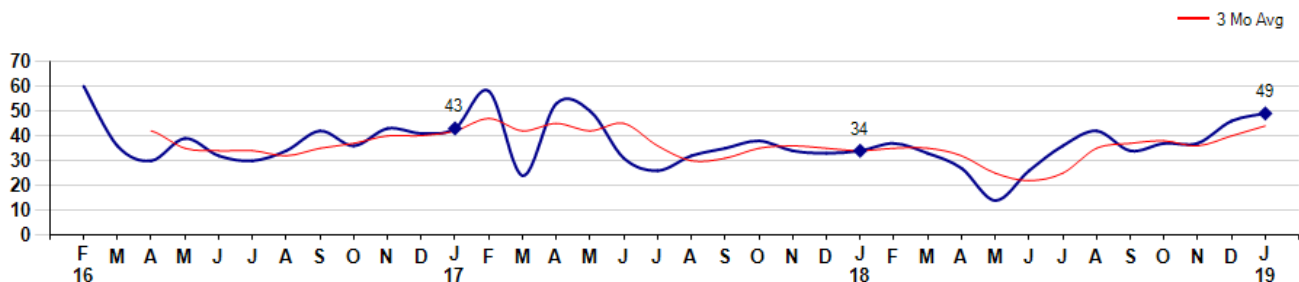
MSI is the # of months needed to sell all of the Inventory at the monthly Sales Pace



### Market Time

The average Days On Market (DOM) shows how many days the average Property is on the Market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for January was 49, up 6.5% from 46 days last month and up 44.1% from 34 days in January of last year. The January 2019 DOM was at its highest level compared with January of 2018 and 2017.

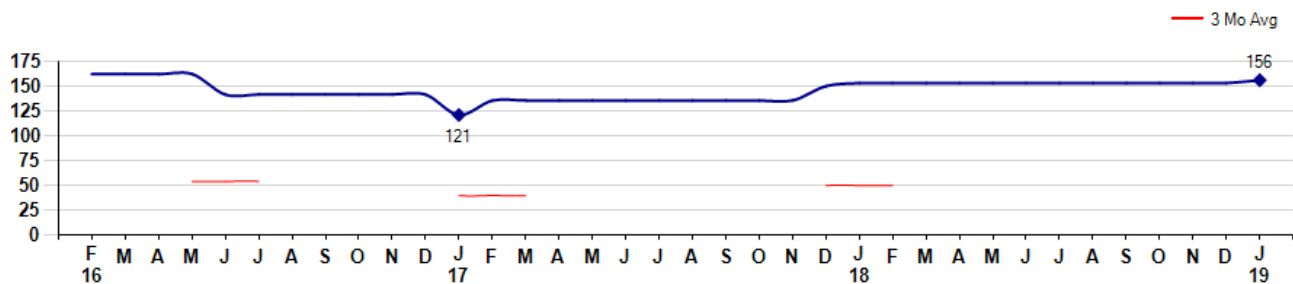
Average Days on Market (Listing to Contract) for properties sold during the month



### Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The January 2019 Selling Price per Square Foot of \$156 was equal to \$0 last month and equal to \$0 in January of last year.

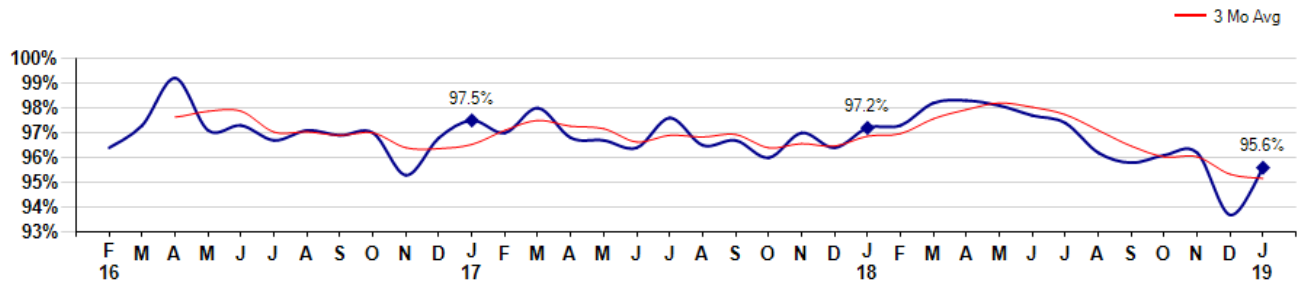

### Selling Price vs Listing Price

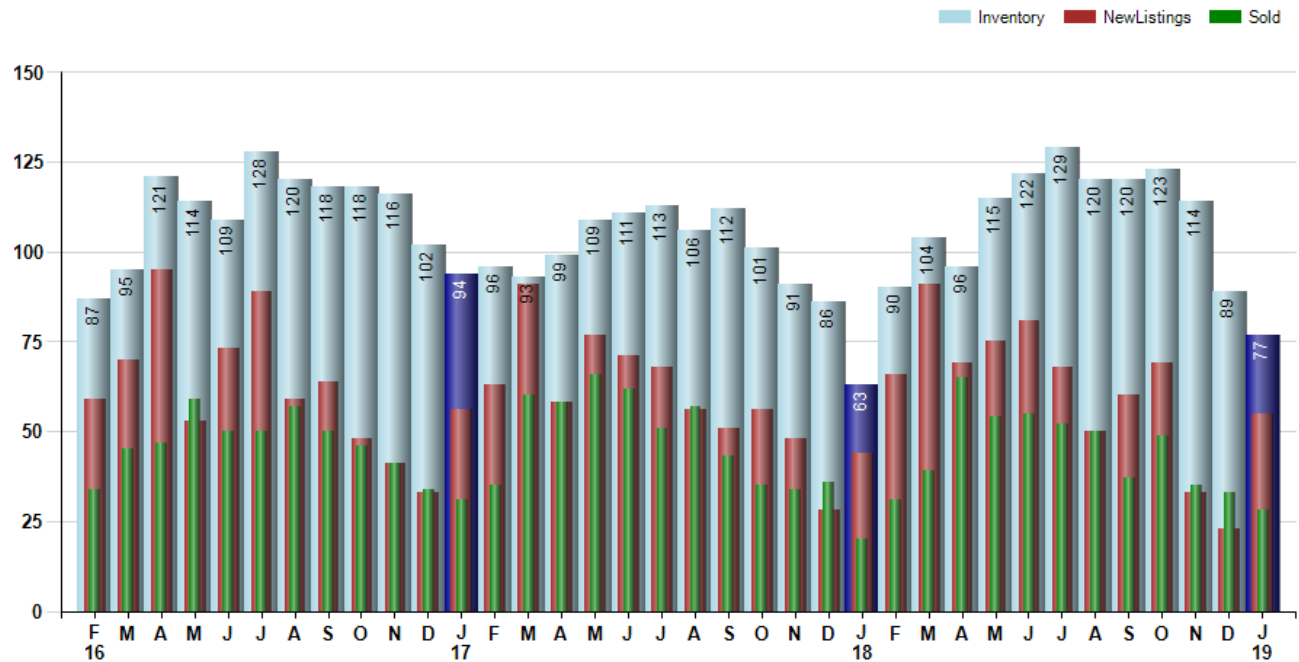
The Selling Price vs Listing Price reveals the average amount that Sellers are agreeing to come down from their list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The January 2019 Selling Price vs List Price of 95.6% was up from 93.7% last month and down from 97.2% in January of last year.

### Inventory / New Listings / Sales

This last view of the market combines monthly inventory of Properties for sale along with New Listings and Sales. The graph shows the basic annual seasonality of the market as well as the relationship between these items. The number of New Listings in January 2019 was 55, up 139.1% from 23 last month and up 25.0% from 44 in January of last year.
