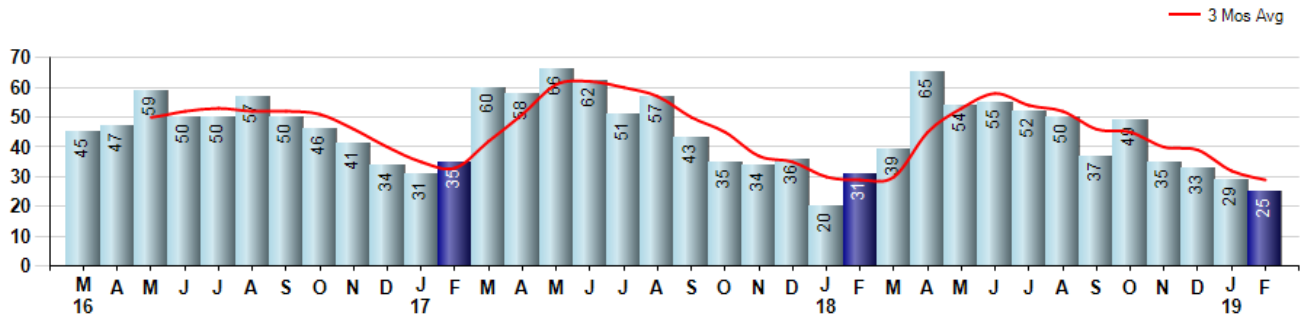

Property Sales

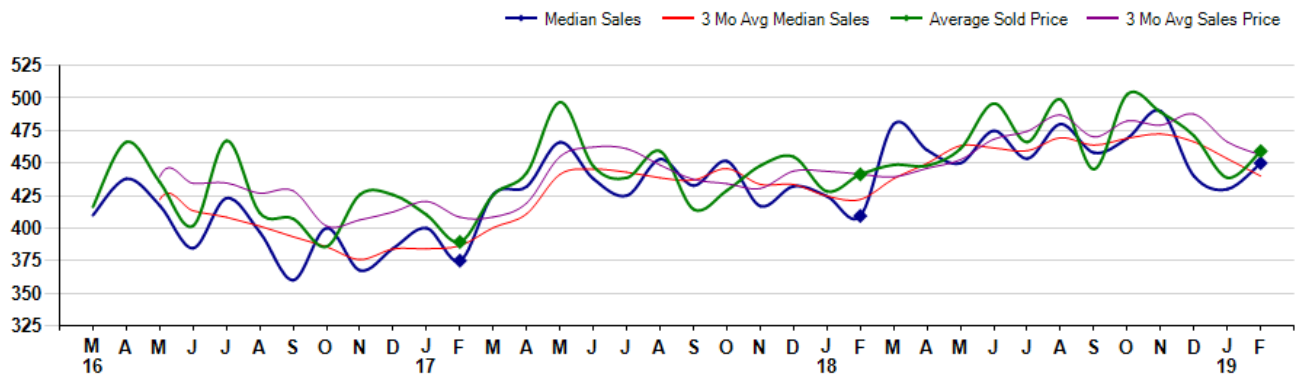
February Property sales were 25, down -19.4% from 31 in February of 2018 and -13.8% lower than the 29 sales last month. February 2019 sales were at their lowest level compared to February of 2018 and 2017. February YTD sales of 54 are running 5.9% ahead of last year's year-to-date sales of 51.



Prices

The Median Sales Price in February was \$450,000, up 9.9% from \$409,400 in February of 2018 and up 4.7% from \$430,000 last month. The Average Sales Price in February was \$459,170, up 4.0% from \$441,303 in February of 2018 and up 4.6% from \$438,798 last month. February 2019 ASP was at highest level compared to February of 2018 and 2017.

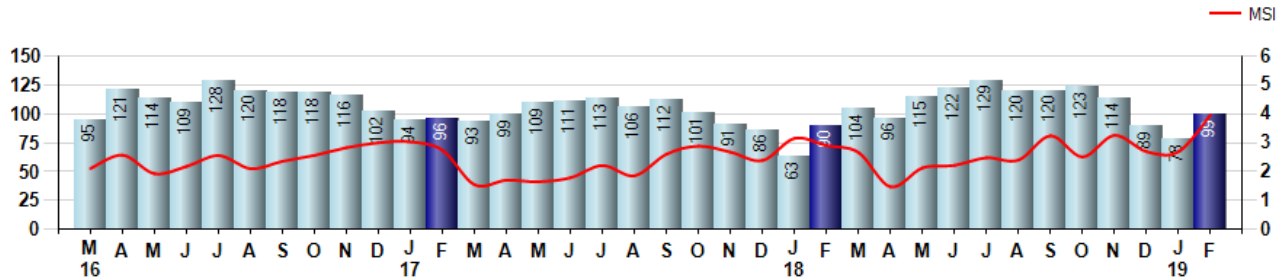

Inventory & MSI

The Total Inventory of Properties available for sale as of February was 99, up 26.9% from 78 last month and up 10.0% from 90 in February of last year. February 2019 Inventory was at highest level compared to February of 2018 and 2017.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The February 2019 MSI of 4.0 months was at its highest level compared with February of 2018 and 2017.

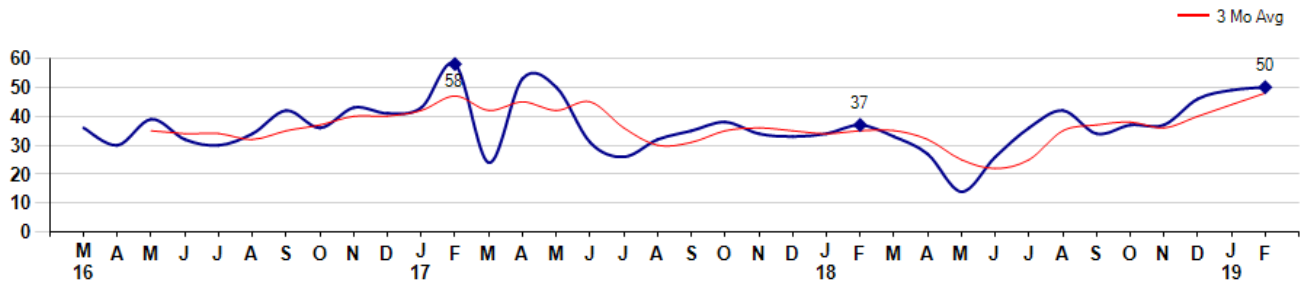
MSI is the # of months needed to sell all of the Inventory at the monthly Sales Pace



Market Time

The average Days On Market(DOM) shows how many days the average Property is on the Market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for February was 50, up 2.0% from 49 days last month and up 35.1% from 37 days in February of last year. The February 2019 DOM was at a mid range compared with February of 2018 and 2017.

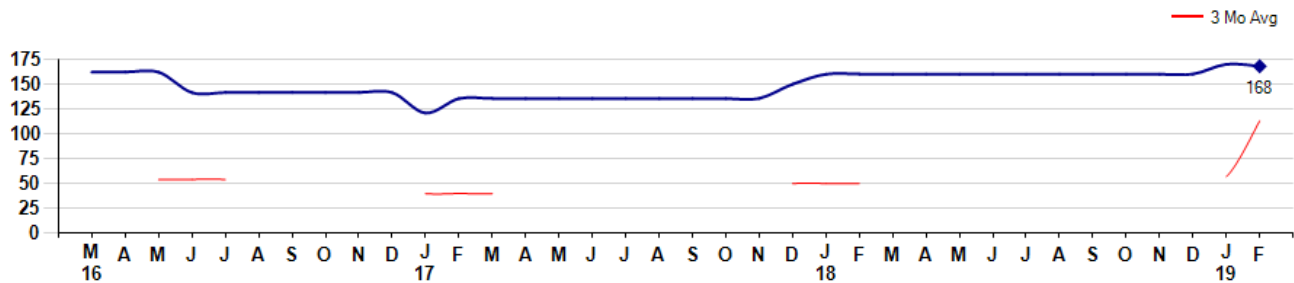
Average Days on Market(Listing to Contract) for properties sold during the month



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The February 2019 Selling Price per Square Foot of \$168 was down -1.2% from \$170 last month and equal to \$0 in February of last year.

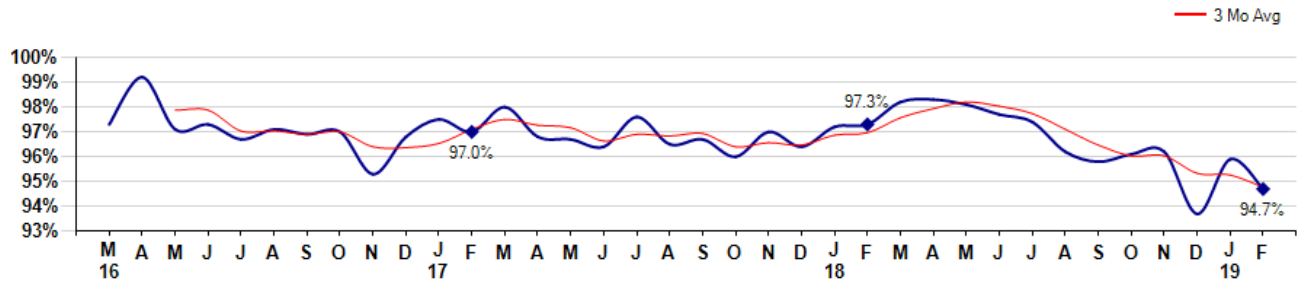

Selling Price vs Listing Price

The Selling Price vs Listing Price reveals the average amount that Sellers are agreeing to come down from their list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The February 2019 Selling Price vs List Price of 94.7% was down from 95.9% last month and down from 97.3% in February of last year.

Inventory / New Listings / Sales

This last view of the market combines monthly inventory of Properties for sale along with New Listings and Sales. The graph shows the basic annual seasonality of the market as well as the relationship between these items. The number of New Listings in February 2019 was 66, up 20.0% from 55 last month and equal to 66 in February of last year.
