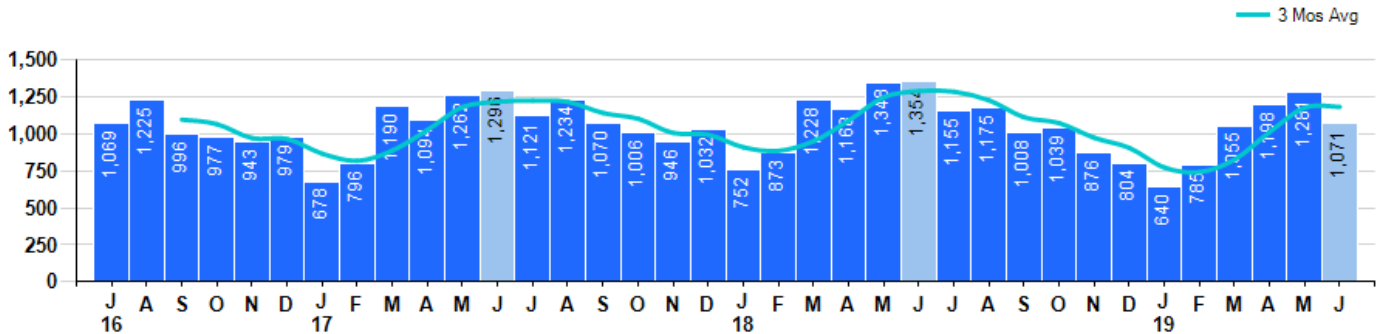

Property Sales

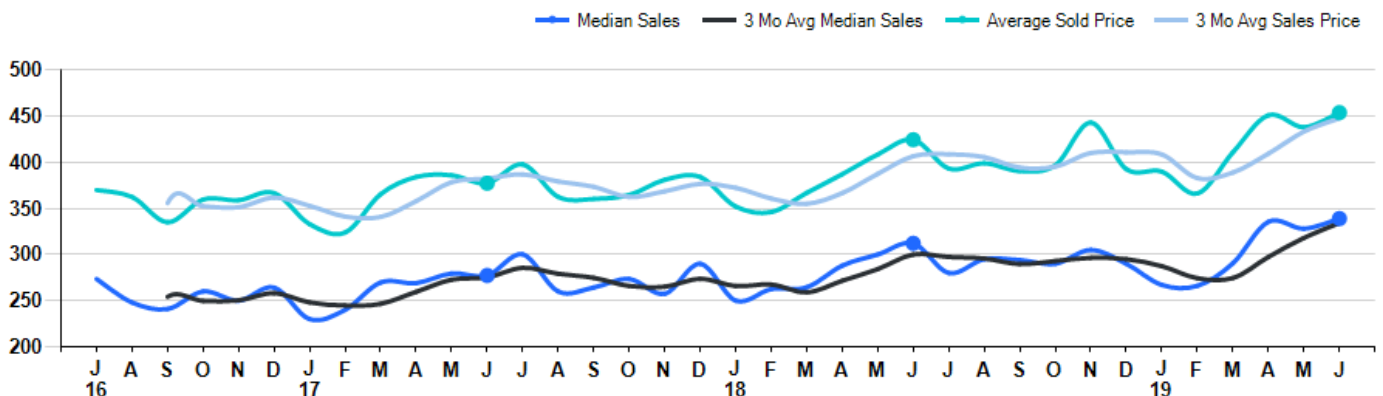
June Property sales were 1,071, down -20.9% from 1,354 in June of 2018 and -16.4% lower than the 1,281 sales last month. June 2019 sales were at their lowest level compared to June of 2018 and 2017. June YTD sales of 6,030 are running -10.3% behind last year's year-to-date sales of 6,723.



Prices

The Median Sales Price in June was \$338,900, up 8.6% from \$312,110 in June of 2018 and up 3.3% from \$328,000 last month. The Average Sales Price in June was \$453,750, up 6.9% from \$424,414 in June of 2018 and up 3.6% from \$437,976 last month. June 2019 ASP was at highest level compared to June of 2018 and 2017.

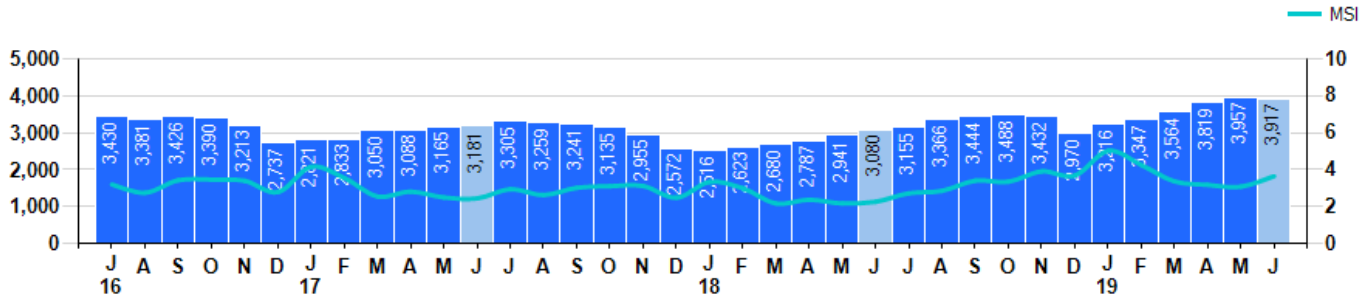

Inventory & MSI

The Total Inventory of Properties available for sale as of June was 3,917, down -1.0% from 3,957 last month and up 27.2% from 3,080 in June of last year. June 2019 Inventory was at highest level compared to June of 2018 and 2017.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The June 2019 MSI of 3.7 months was at its highest level compared with June of 2018 and 2017.

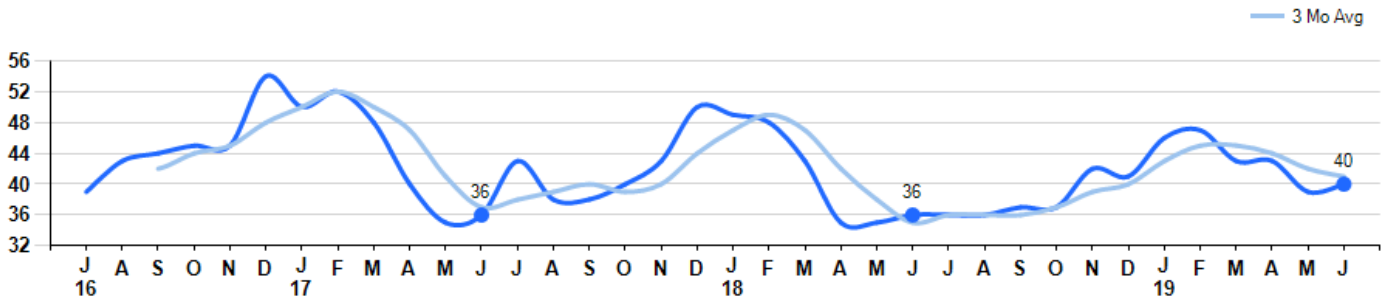
MSI is the # of months needed to sell all of the Inventory at the monthly Sales Pace



Market Time

The average Days On Market(DOM) shows how many days the average Property is on the Market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for June was 40, up 2.6% from 39 days last month and up 11.1% from 36 days in June of last year. The June 2019 DOM was at its highest level compared with June of 2018 and 2017.

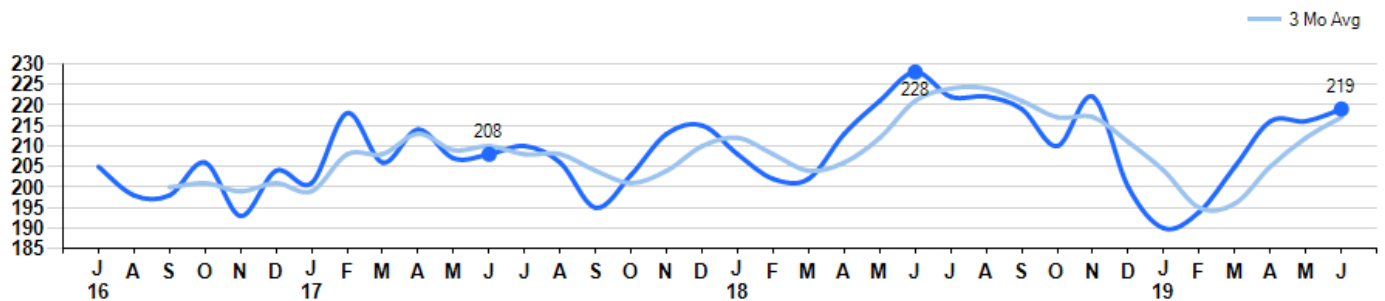
Average Days on Market(Listing to Contract) for properties sold during the month



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The June 2019 Selling Price per Square Foot of \$219 was up 1.4% from \$216 last month and down -3.9% from \$228 in June of last year.

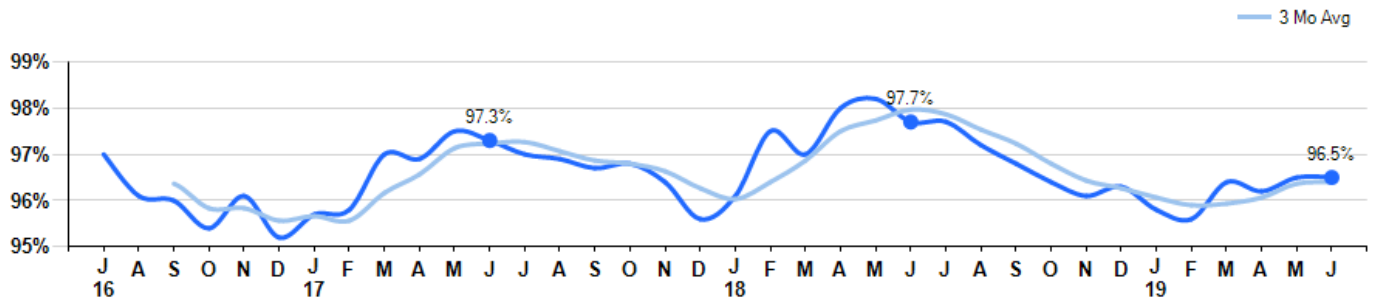

Selling Price vs Listing Price

The Selling Price vs Listing Price reveals the average amount that Sellers are agreeing to come down from their list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The June 2019 Selling Price vs List Price of 96.5% was equal to 96.5% last month and down from 97.7% in June of last year.

Inventory / New Listings / Sales

This last view of the market combines monthly inventory of Properties for sale along with New Listings and Sales. The graph shows the basic annual seasonality of the market as well as the relationship between these items. The number of New Listings in June 2019 was 1852, down -11.2% from 2,085 last month and up 9.2% from 1,696 in June of last year.
