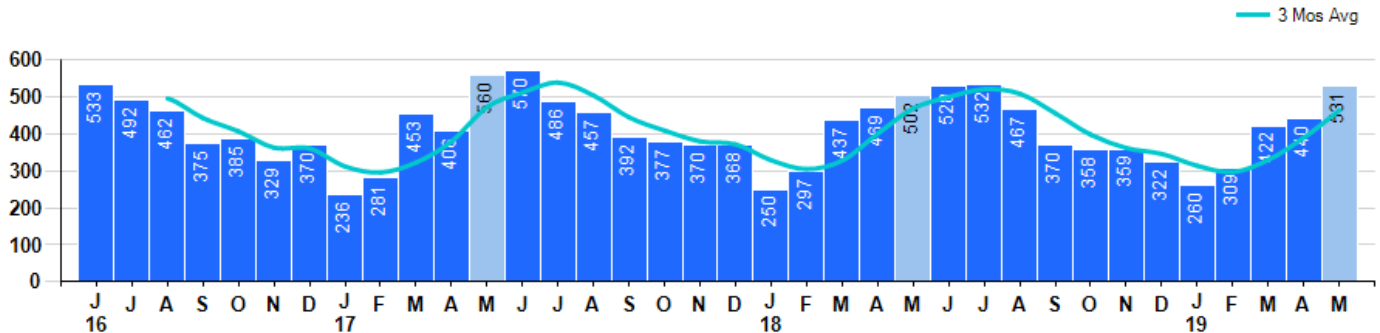

Property Sales

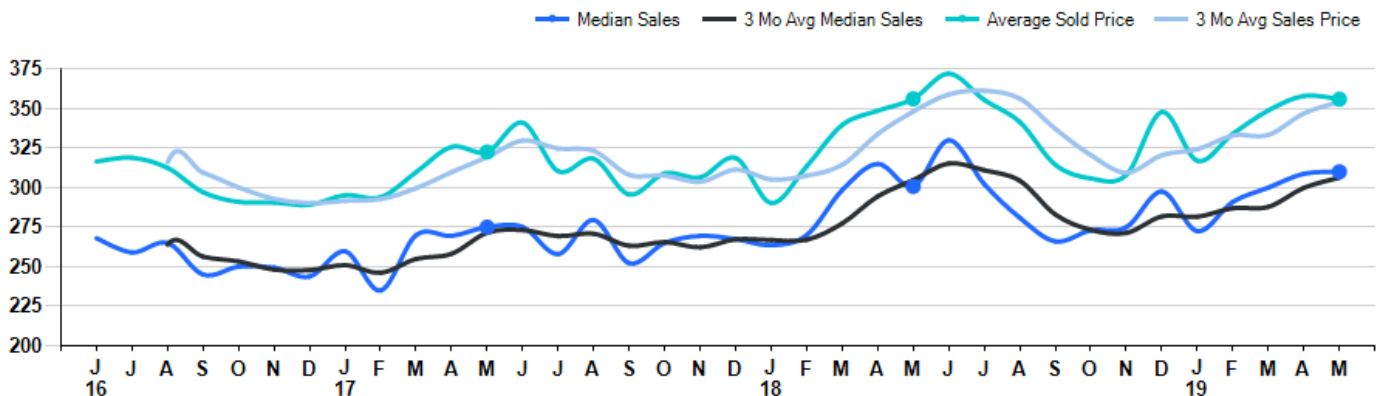
May Property sales were 531, up 5.8% from 502 in May of 2018 and 20.7% higher than the 440 sales last month. May 2019 sales were at a mid level compared to May of 2018 and 2017. May YTD sales of 1,962 are running 0.4% ahead of last year's year-to-date sales of 1,955.



Prices

The Median Sales Price in May was \$310,000, up 3.1% from \$300,700 in May of 2018 and up 0.4% from \$308,750 last month. The Average Sales Price in May was \$355,879, down -0.1% from \$356,137 in May of 2018 and down -0.6% from \$357,973 last month. May 2019 ASP was at a mid range compared to May of 2018 and 2017.

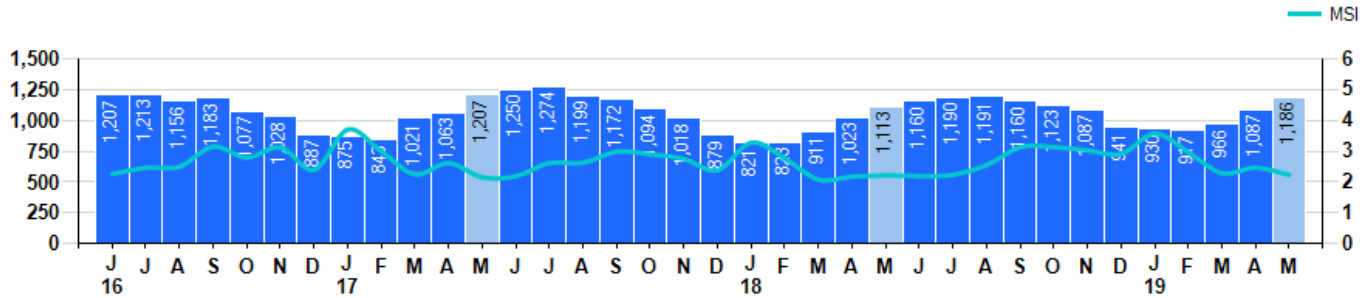

Inventory & MSI

The Total Inventory of Properties available for sale as of May was 1,186, up 9.1% from 1,087 last month and up 6.6% from 1,113 in May of last year. May 2019 Inventory was at a mid range compared to May of 2018 and 2017.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The May 2019 MSI of 2.2 months was at its highest level compared with May of 2018 and 2017.

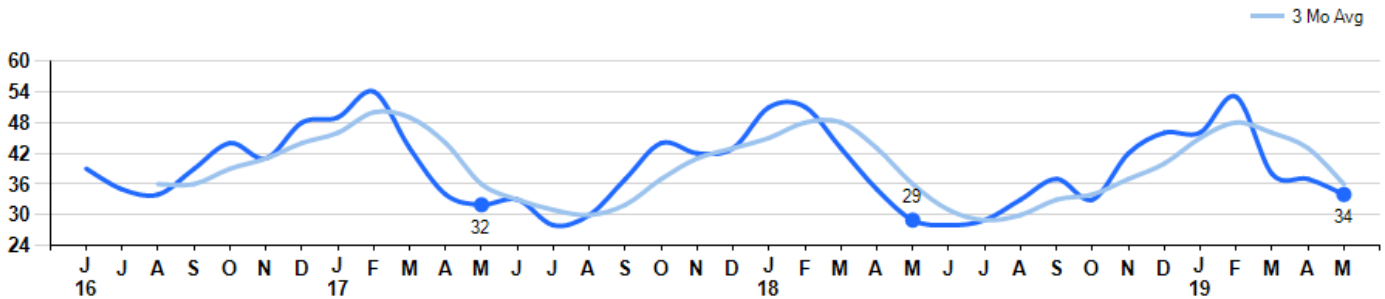
MSI is the # of months needed to sell all of the Inventory at the monthly Sales Pace



Market Time

The average Days On Market(DOM) shows how many days the average Property is on the Market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for May was 34, down -8.1% from 37 days last month and up 17.2% from 29 days in May of last year. The May 2019 DOM was at its highest level compared with May of 2018 and 2017.

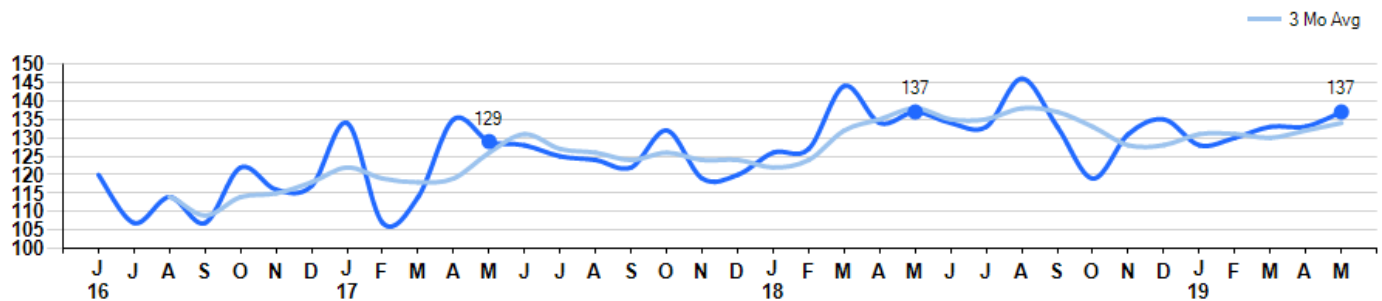
Average Days on Market(Listing to Contract) for properties sold during the month



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The May 2019 Selling Price per Square Foot of \$137 was up 3.0% from \$133 last month and equal to \$137 in May of last year.

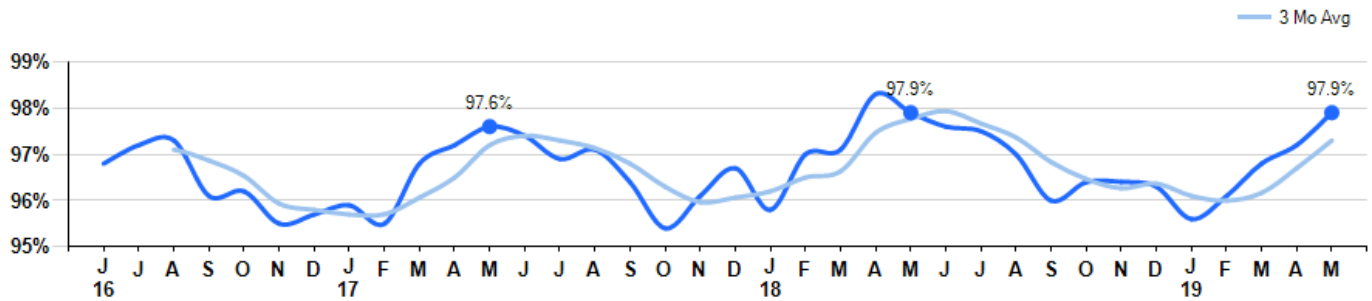

Selling Price vs Listing Price

The Selling Price vs Listing Price reveals the average amount that Sellers are agreeing to come down from their list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The May 2019 Selling Price vs List Price of 97.9% was up from 97.2% last month and equal to 97.9% in May of last year.

Inventory / New Listings / Sales

This last view of the market combines monthly inventory of Properties for sale along with New Listings and Sales. The graph shows the basic annual seasonality of the market as well as the relationship between these items. The number of New Listings in May 2019 was 837, up 12.3% from 745 last month and up 13.1% from 740 in May of last year.
