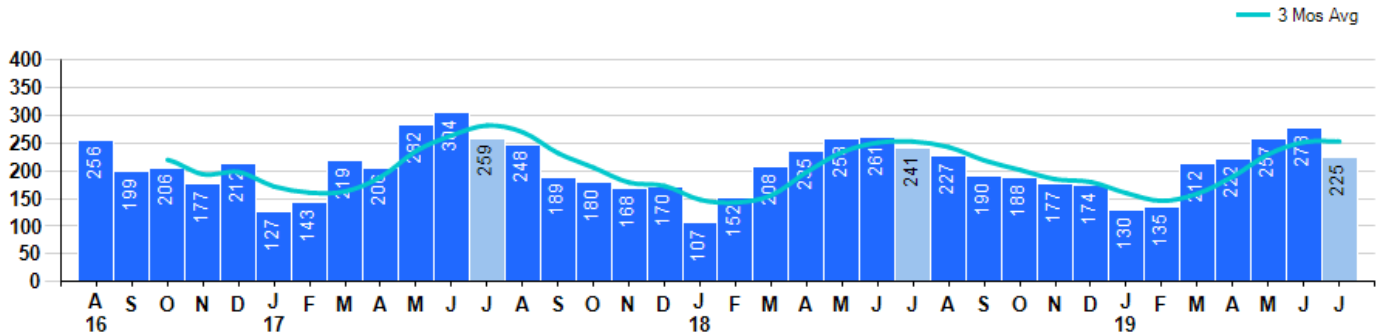

## Property Sales

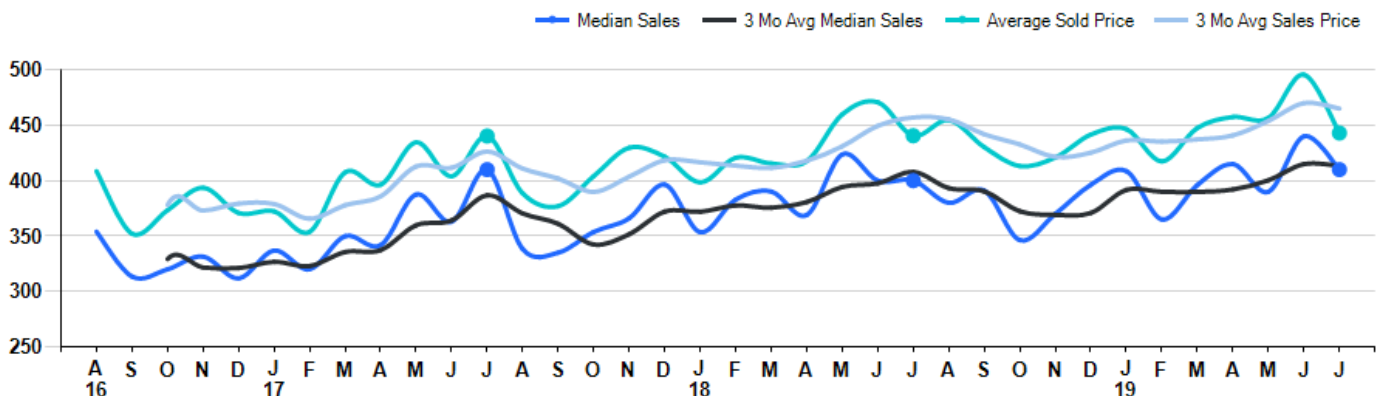
July Property sales were 225, down -6.6% from 241 in July of 2018 and -19.1% lower than the 278 sales last month. July 2019 sales were at their lowest level compared to July of 2018 and 2017. July YTD sales of 1,459 are running -0.2% behind last year's year-to-date sales of 1,462.



## Prices

The Median Sales Price in July was \$410,000, up 2.5% from \$400,000 in July of 2018 and down -6.8% from \$439,998 last month. The Average Sales Price in July was \$443,059, up 0.6% from \$440,586 in July of 2018 and down -10.6% from \$495,768 last month. July 2019 ASP was at highest level compared to July of 2018 and 2017.

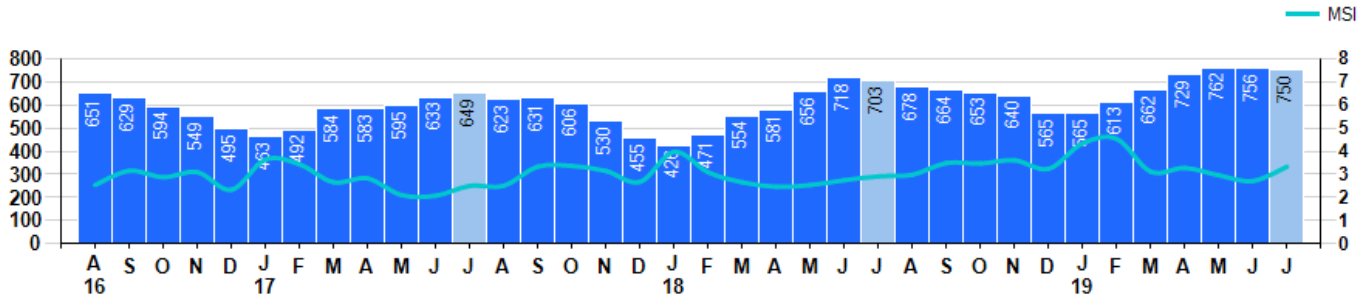

## Inventory & MSI

The Total Inventory of Properties available for sale as of July was 750, down -0.8% from 756 last month and up 6.7% from 703 in July of last year. July 2019 Inventory was at highest level compared to July of 2018 and 2017.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The July 2019 MSI of 3.3 months was at its highest level compared with July of 2018 and 2017.

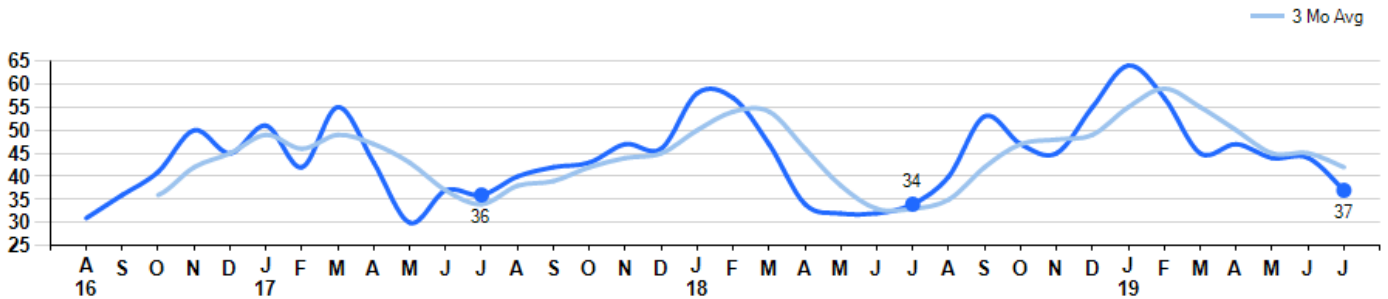
MSI is the # of months needed to sell all of the Inventory at the monthly Sales Pace



## Market Time

The average Days On Market (DOM) shows how many days the average Property is on the Market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for July was 37, down -15.9% from 44 days last month and up 8.8% from 34 days in July of last year. The July 2019 DOM was at its highest level compared with July of 2018 and 2017.

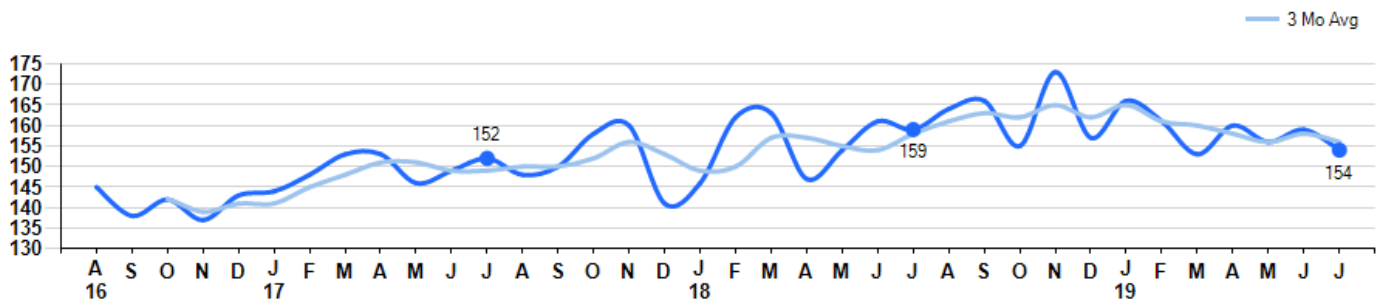
Average Days on Market (Listing to Contract) for properties sold during the month



## Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The July 2019 Selling Price per Square Foot of \$154 was down -3.1% from \$159 last month and down -3.1% from \$159 in July of last year.

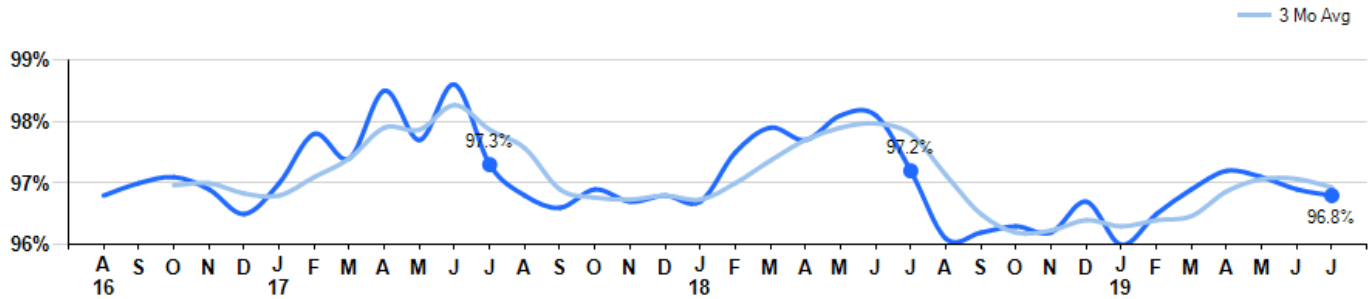

## Selling Price vs Listing Price

The Selling Price vs Listing Price reveals the average amount that Sellers are agreeing to come down from their list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The July 2019 Selling Price vs List Price of 96.8% was down from 96.9% last month and down from 97.2% in July of last year.

## Inventory / New Listings / Sales

This last view of the market combines monthly inventory of Properties for sale along with New Listings and Sales. The graph shows the basic annual seasonality of the market as well as the relationship between these items. The number of New Listings in July 2019 was 337, up 4.0% from 324 last month and up 8.4% from 311 in July of last year.
