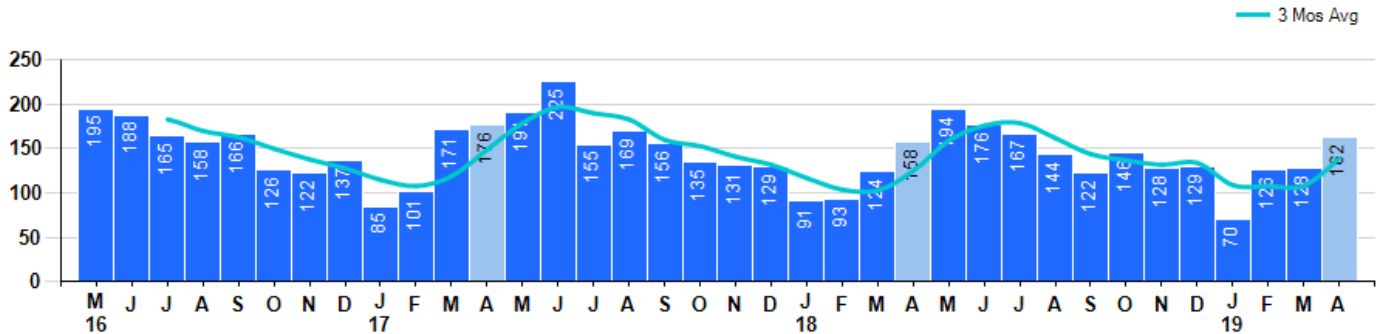

Property Sales

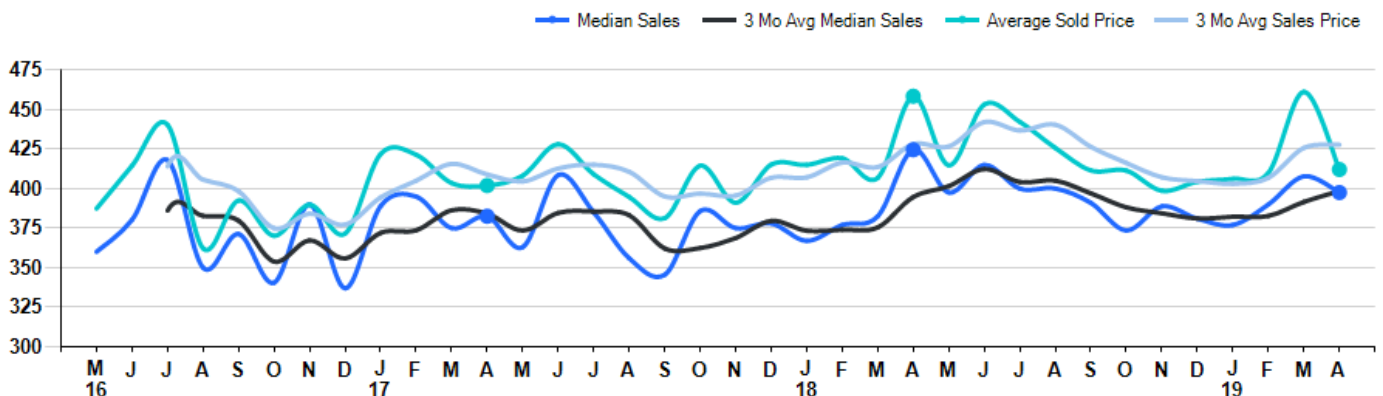
April Property sales were 162, up 2.5% from 158 in April of 2018 and 26.6% higher than the 128 sales last month. April 2019 sales were at a mid level compared to April of 2018 and 2017. April YTD sales of 486 are running 4.3% ahead of last year's year-to-date sales of 466.



Prices

The Median Sales Price in April was \$397,500, down -6.4% from \$424,563 in April of 2018 and down -2.5% from \$407,750 last month. The Average Sales Price in April was \$412,075, down -10.1% from \$458,355 in April of 2018 and down -10.7% from \$461,199 last month. April 2019 ASP was at a mid range compared to April of 2018 and 2017.

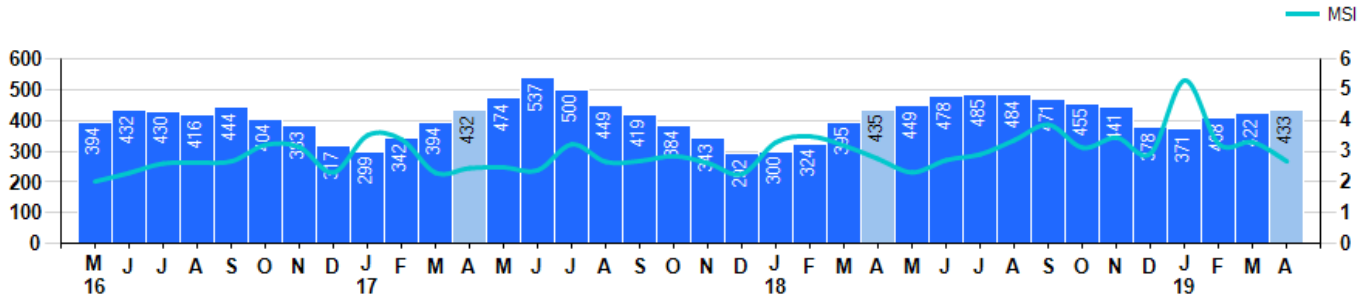

Inventory & MSI

The Total Inventory of Properties available for sale as of April was 433, up 2.6% from 422 last month and down -0.5% from 435 in April of last year. April 2019 Inventory was at a mid range compared to April of 2018 and 2017.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The April 2019 MSI of 2.7 months was at a mid range compared with April of 2018 and 2017.

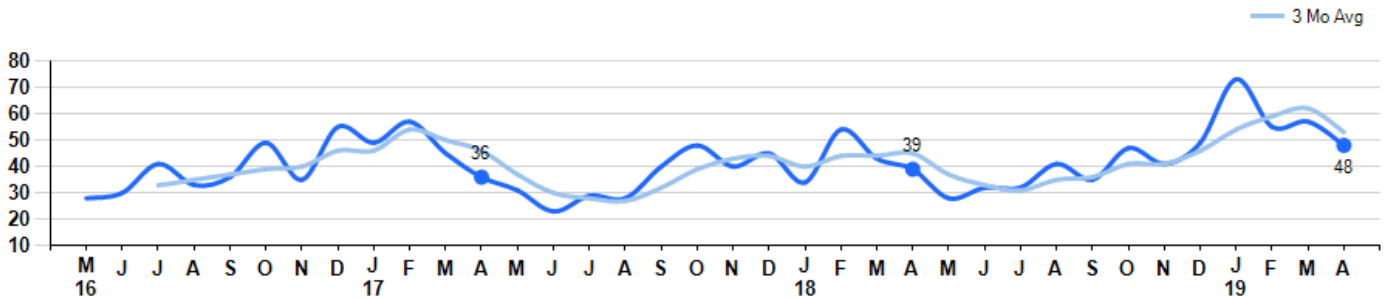
MSI is the # of months needed to sell all of the Inventory at the monthly Sales Pace



Market Time

The average Days On Market(DOM) shows how many days the average Property is on the Market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for April was 48, down -15.8% from 57 days last month and up 23.1% from 39 days in April of last year. The April 2019 DOM was at its highest level compared with April of 2018 and 2017.

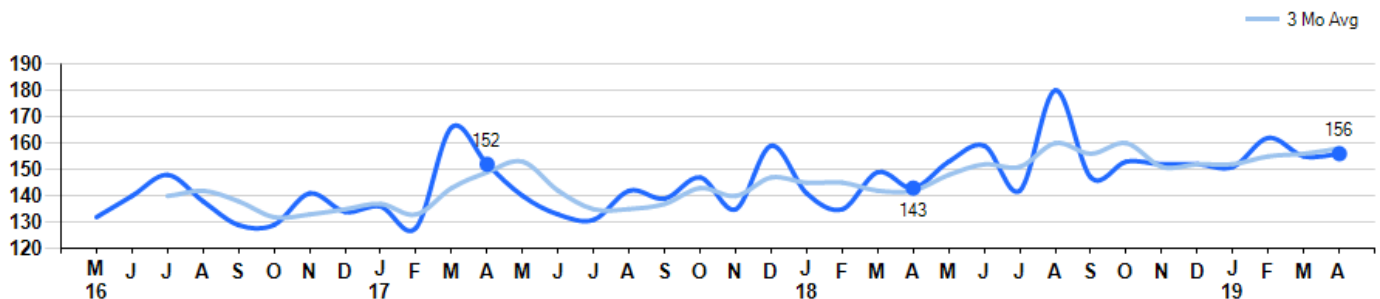
Average Days on Market(Listing to Contract) for properties sold during the month



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The April 2019 Selling Price per Square Foot of \$156 was up 0.6% from \$155 last month and up 9.1% from \$143 in April of last year.

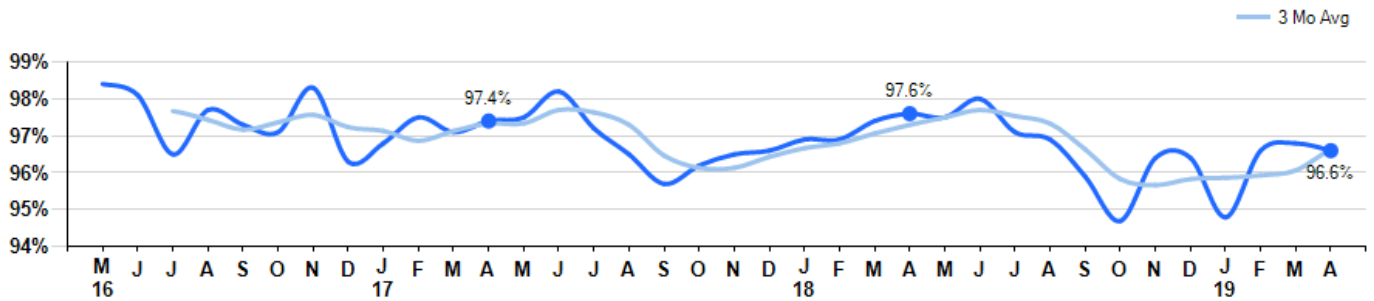

Selling Price vs Listing Price

The Selling Price vs Listing Price reveals the average amount that Sellers are agreeing to come down from their list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The April 2019 Selling Price vs List Price of 96.6% was down from 96.8% last month and down from 97.6% in April of last year.

Inventory / New Listings / Sales

This last view of the market combines monthly inventory of Properties for sale along with New Listings and Sales. The graph shows the basic annual seasonality of the market as well as the relationship between these items. The number of New Listings in April 2019 was 293, up 6.9% from 274 last month and up 2.8% from 285 in April of last year.
