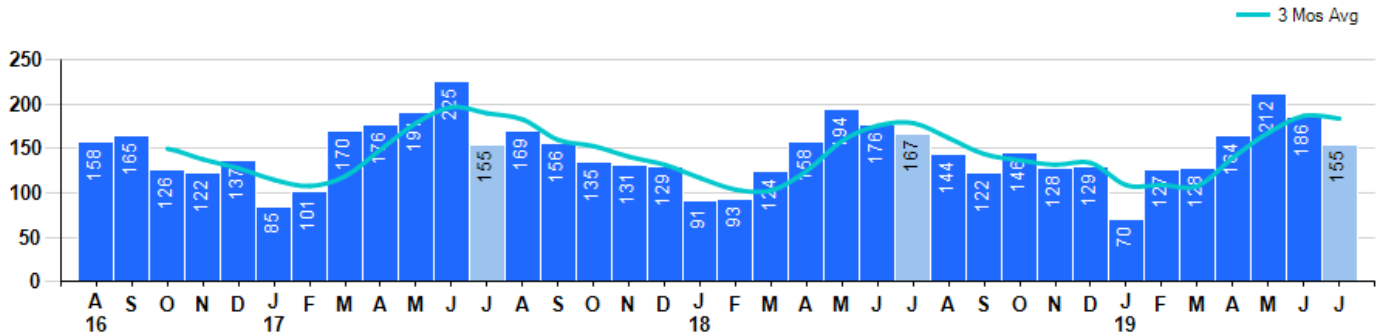

Property Sales

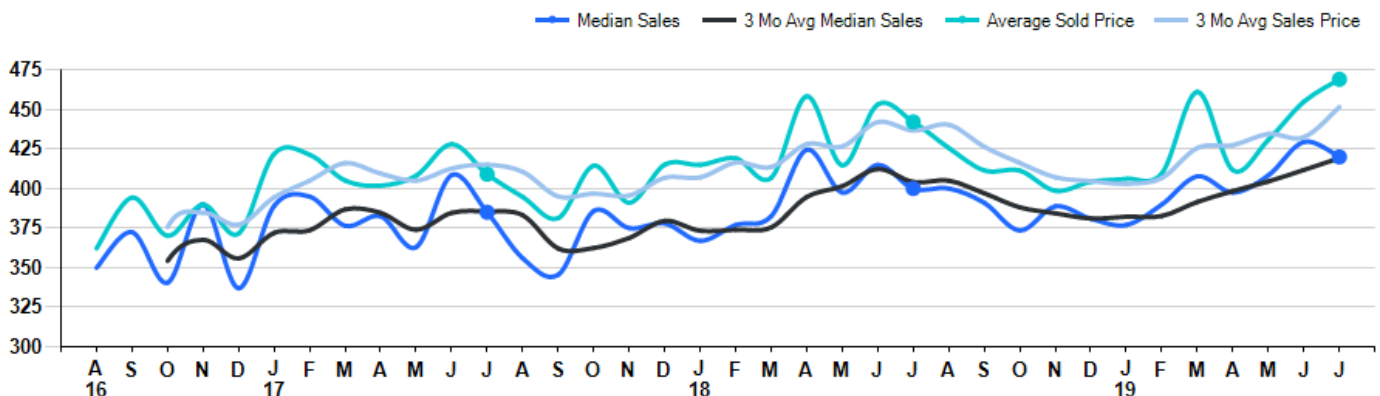
July Property sales were 155, down -7.2% from 167 in July of 2018 and -16.7% lower than the 186 sales last month. July 2019 sales were at their lowest level compared to July of 2018 and 2017. July YTD sales of 1,042 are running 3.9% ahead of last year's year-to-date sales of 1,003.



Prices

The Median Sales Price in July was \$420,000, up 5.0% from \$400,000 in July of 2018 and down -2.2% from \$429,500 last month. The Average Sales Price in July was \$469,053, up 6.1% from \$442,187 in July of 2018 and up 3.1% from \$454,971 last month. July 2019 ASP was at highest level compared to July of 2018 and 2017.

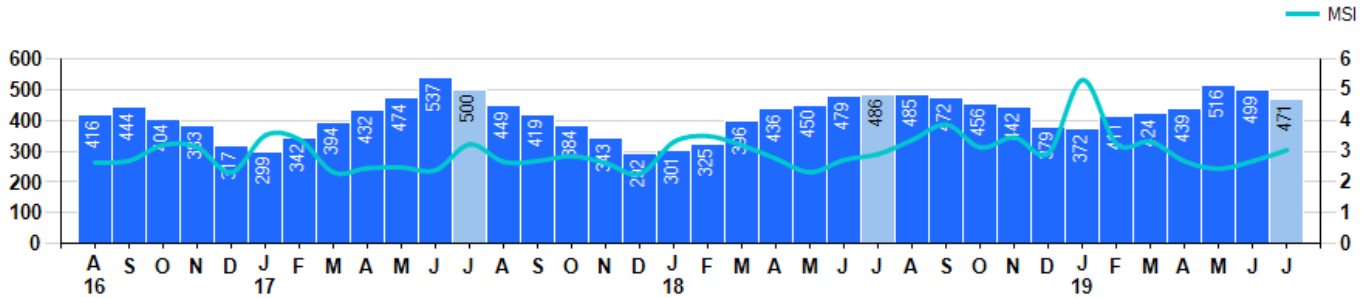

Inventory & MSI

The Total Inventory of Properties available for sale as of July was 471, down -5.6% from 499 last month and down -3.1% from 486 in July of last year. July 2019 Inventory was at the lowest level compared to July of 2018 and 2017.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The July 2019 MSI of 3.0 months was at a mid range compared with July of 2018 and 2017.

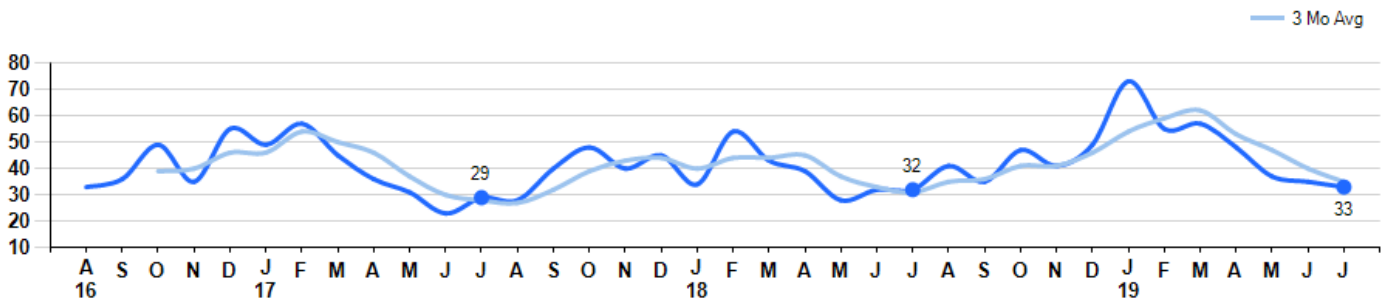
MSI is the # of months needed to sell all of the Inventory at the monthly Sales Pace



Market Time

The average Days On Market(DOM) shows how many days the average Property is on the Market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for July was 33, down -5.7% from 35 days last month and up 3.1% from 32 days in July of last year. The July 2019 DOM was at its highest level compared with July of 2018 and 2017.

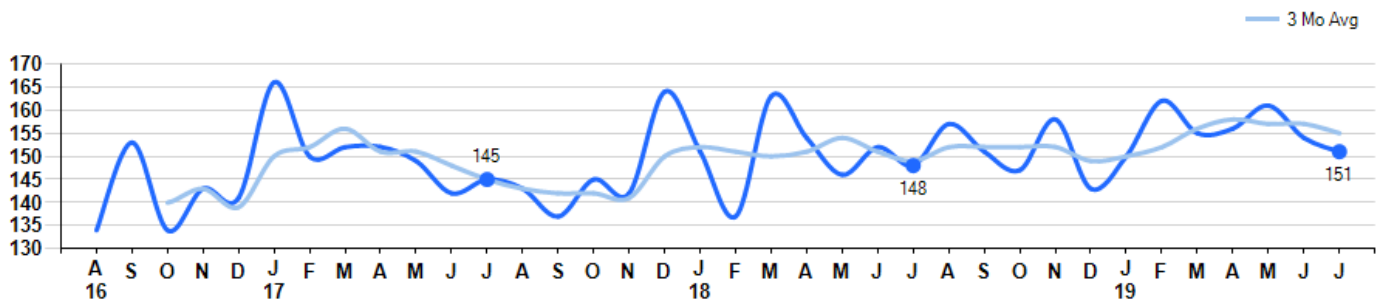
Average Days on Market(Listing to Contract) for properties sold during the month



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The July 2019 Selling Price per Square Foot of \$151 was down -1.9% from \$154 last month and up 2.0% from \$148 in July of last year.

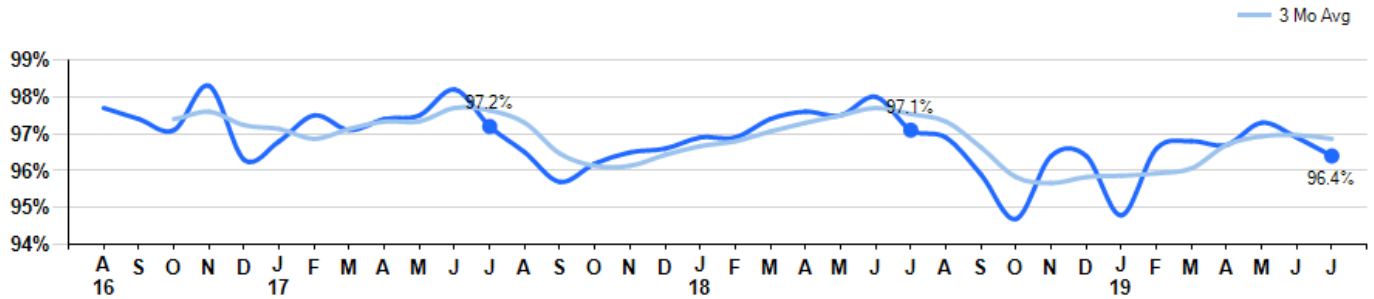

Selling Price vs Listing Price

The Selling Price vs Listing Price reveals the average amount that Sellers are agreeing to come down from their list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The July 2019 Selling Price vs List Price of 96.4% was down from 96.9% last month and down from 97.1% in July of last year.

Inventory / New Listings / Sales

This last view of the market combines monthly inventory of Properties for sale along with New Listings and Sales. The graph shows the basic annual seasonality of the market as well as the relationship between these items. The number of New Listings in July 2019 was 215, down -17.9% from 262 last month and down -8.1% from 234 in July of last year.
