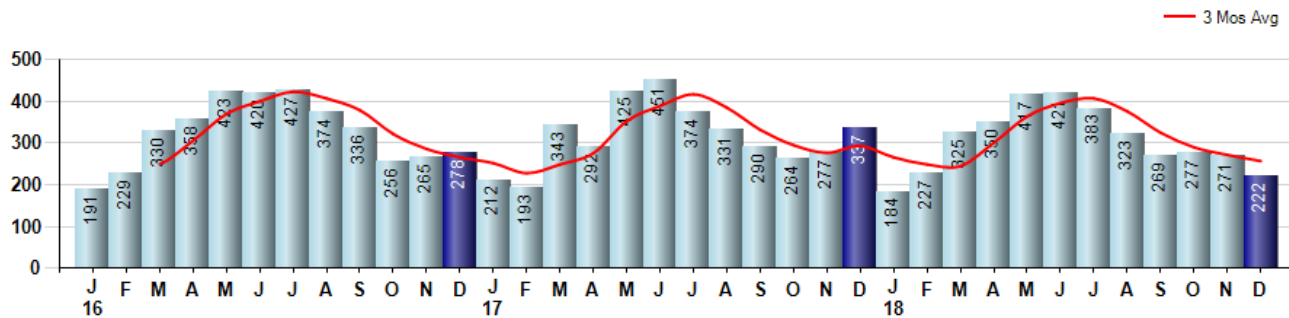

Property Sales

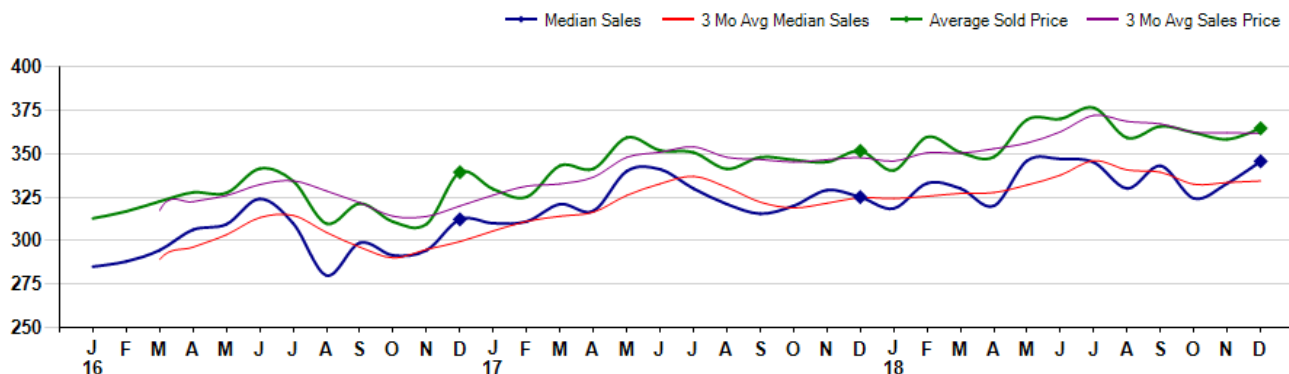
December Property sales were 222, down -34.1% from 337 in December of 2017 and -18.1% lower than the 271 sales last month. December 2018 sales were at their lowest level compared to December of 2017 and 2016. December YTD sales of 3,669 are running -3.2% behind last year's year-to-date sales of 3,789.



Prices

The Median Sales Price in December was \$345,611, up 6.3% from \$325,000 in December of 2017 and up 3.8% from \$333,000 last month. The Average Sales Price in December was \$364,601, up 3.7% from \$351,599 in December of 2017 and up 1.8% from \$358,326 last month. December 2018 ASP was at highest level compared to December of 2017 and 2016.

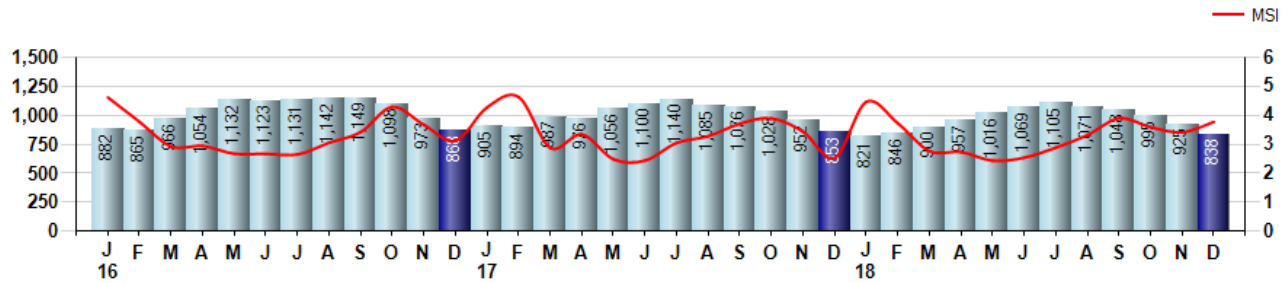

Inventory & MSI

The Total Inventory of Properties available for sale as of December was 838, down -9.4% from 925 last month and down -1.8% from 853 in December of last year. December 2018 Inventory was at the lowest level compared to December of 2017 and 2016.

A comparatively lower MSI is more beneficial for sellers while a higher MSI is better for buyers. The December 2018 MSI of 3.8 months was at its highest level compared with December of 2017 and 2016.

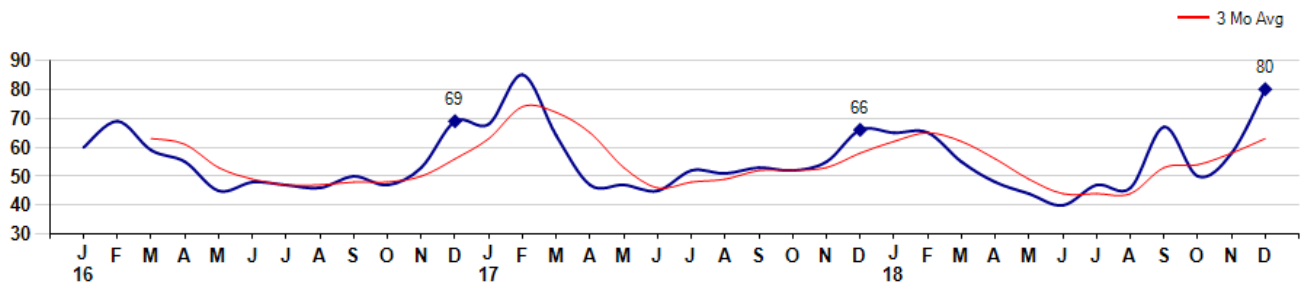
MSI is the # of months needed to sell all of the Inventory at the monthly Sales Pace



Market Time

The average Days On Market (DOM) shows how many days the average Property is on the Market before it sells. An upward trend in DOM tends to indicate a move towards more of a Buyer's market, a downward trend a move towards more of a Seller's market. The DOM for December was 80, up 37.9% from 58 days last month and up 21.2% from 66 days in December of last year. The December 2018 DOM was at its highest level compared with December of 2017 and 2016.

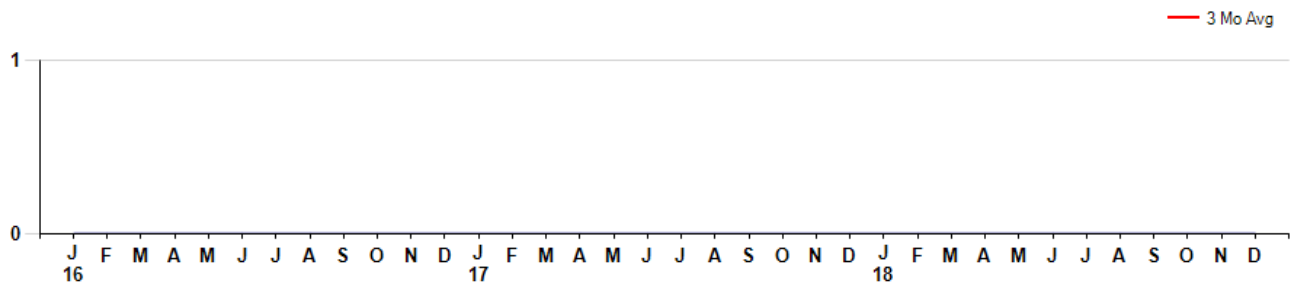
Average Days on Market (Listing to Contract) for properties sold during the month



Selling Price per Square Foot

The Selling Price per Square Foot is a great indicator for the direction of Property values. Since Median Sales Price and Average Sales price can be impacted by the 'mix' of high or low end Properties in the market, the selling price per square foot is a more normalized indicator on the direction of Property values. The December 2018 Selling Price per Square Foot of \$0 was equal to \$0 last month and equal to \$0 in December of last year.

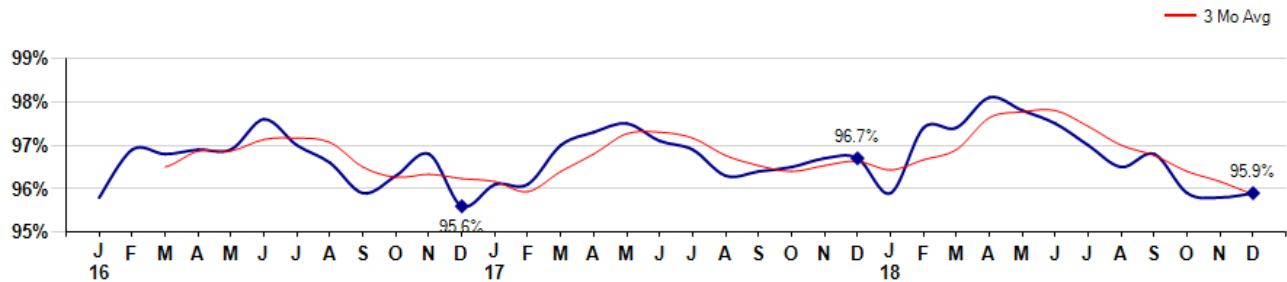

Selling Price vs Listing Price

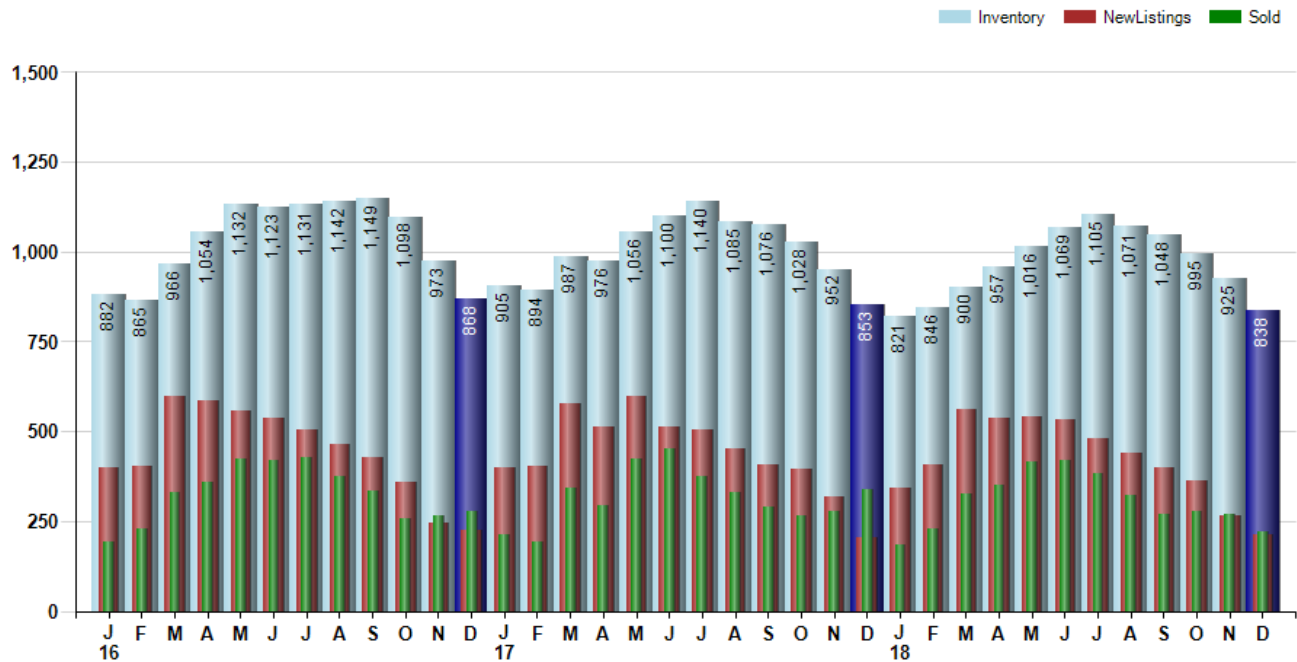
The Selling Price vs Listing Price reveals the average amount that Sellers are agreeing to come down from their list price. The lower the ratio is below 100% the more of a Buyer's market exists, a ratio at or above 100% indicates more of a Seller's market. The December 2018 Selling Price vs List Price of 95.9% was up from 95.8% last month and down from 96.7% in December of last year.

Inventory / New Listings / Sales

This last view of the market combines monthly inventory of Properties for sale along with New Listings and Sales. The graph shows the basic annual seasonality of the market as well as the relationship between these items. The number of New Listings in December 2018 was 212, down -20.0% from 265 last month and up 4.4% from 203 in December of last year.
