28th Amendment:

34th Amendment:

There shall be no federal criminal statutes or federal prisons except for those that apply to members of the federal and state militaries and to elected and appointed officials and employees of the federal, state and local governments.

All Criminal Statutes And Prisons Will Be Handled By The States

35th Amendment:

Congress may pass Bills of Attainder against members of insurgencies.

36th Amendment:

**Congress may declare individual street gangs,
drug cartels and criminal enterprises to be insurgencies.**

37th Amendment:

The Army shall capture and execute insurgents within the shores of the United States.

36th Amendment:

The total size of the Army shall not exceed the total

cumulative size of the National Guard's of the states.

37th Amendment:

The Navy, Marines and Air Force may not operate within the shores of the United States except for physical defense against foreign enemies and training.

37th Amendment:

Muslims and practitioners of islam, voodoo or satanism of any form may not hold elected office, serve within the military of the United States or the National Guard's of the states, be employed by the federal, state or local governments, vote, or hold citizenship.

38th Amendment:

The foreign service of the United States shall negotiate the purchase from Mexico of all land north of 25th Parallel and the Baja Peninsula and the US Department of Energy shall blast a 2 mile deep and 100 mile wide canal measured south to north from the 26th Parallel through that territory, successfully connecting the Gulf of California to the Gulf of Mexico and creating a natural 100 mile wall of water that secures the southern border of the United States. Inhabitants and descendants of inhabitants of the territory north of the 25th Parallel and south of the current border of the United States may not petition for US citizenship until after the year 2300 and may not attain voting rights in federal elections until after the year 2400.

39th Amendment:

An Honorable Discharge form the military of the United States will be considered the American Patent of Nobility entitling all honorably discharged veterans to an immediate pension that is prorated to the number of days served in the military.

39th Amendment:

Veterans preference for employment with the federal, state and local governments and for all available services therefrom is absolute.

40th Amendment:

The Foreign Service shall negotiate with the nation of Liberia their willful acceptance and granting of full citizenship to black Americans who chose to repatriate to Africa.

40th Amendment:

All black Americans who are incarcerated within the shores of the United States for any reason have the right to permanently renounce citizenship in the United States and to be immediately repatriated to the nation of Liberia, given a cash sum of 25,000 US Dollars and freed in exchange for their agreement that their reentering any territory that is owned or controlled by the United States is a capital offence for which they will have no constitutional right to a defense.
