- Despite these and other risks, and fully understanding such risks, I wish to play the "Game" and hereby assume the risks of playing the "Game". I also hereby hold harmless the "Sponsors" and indemnify them against any or all claims, actions, suits, procedures, costs, expenses (including attorney's fee and expenses), damages and liabilities arising out of, connected with, or resulting from my playing the "Game", including without limitation, those resulting from the manufacture, selection, delivery, possession, use or operation of such equipment. I hereby release the "Sponsors" from any and all such liability, and I understand that this release shall be binding upon my estate, my heirs, my representatives and assigns. I hereby certify to the "Sponsors" that I'm in good health and do not suffer from a heart condition or other ailment which could be exacerbated by the exertion involved in playing the "Game".

**RELEASE OF LIABILITY, WAVIER OF CLAIMS AND IDEMNITY AGGREEMENT**
