Ask Anne: Is REAL ID Really Necessary?

Anne: Over the last several years, our agency has been working with residents to become REAL ID compliant. Roughly 10% of Palm Beach County residents still do not have a REAL ID driver license or ID card. Are you one of them? If your driver license or state ID card is missing a star in the upper right corner, you do not have a REAL ID.

Oct. 1, 2020 is the REAL ID deadline when every U.S. resident must present a REAL ID driver license or ID card to a board commercial flight or enter a federal building. Residents who do not provide a REAL ID must present an alternate

acceptable form of identification, such as a valid passport.

Don't get caught in the last minute rush! Palm Beach County residents can make an appointment at www.pbctax.com to renew their driver license or ID card up to 18 months in advance of the expiration date.
