Arizona

HB 2513, SB 1134, Prevent an Automatic Freeze on KidsCare Sponsors: Representative Cobb and Senator Carter

KidsCare now provides affordable health care coverage to nearly 35,000 children in working families, connecting them with the check-ups, immunizations, treatment and prescriptions they need to grow up healthy.

Current state law has a trigger that immediately freezes enrollment in KidsCare when federal funding dips to a 91% match in October.

These identical bills remove the automatic freeze and match Governor Ducey's budget with a \$1.6 million appropriation of state funds to keep KidsCare open during the whole fiscal year.

Major Juvenile Justice Reformed Signed into Law



- March 8th was the bill signing ceremony for SB152 (now Act 189), landmark legislation that will begin the process of reforming the Arkansas juvenile justice system
- The new legislation, which will take effect on July 1, 2020



Major goals of the reform legislation, which was years in the making, included:



Reducing the number of youth and length of stay in juvenile lockups



Redirecting funding from secure confinement to more effective (and cheaper), evidence-based community services



Improving equity in the allocation of services in and across judicial districts; and enhancing the treatment of youth committed to the Division of Youth Services (DYS).



- Provide funding for prevention activities.
- Implement plans to prevent child abuse and neglect fatalities.
- Better access to family reunification services with federal reimbursement.
- Increase efficiency and timeliness to stable placements across state lines.
- Provide supports for Kinship Navigator Programs.
- Improve licensing standards for foster care placements.
- Take steps to ensure that placements outside of foster family homes are a necessity.
- Ensure placements in residential programs are necessary.
- Provide continuous support for recruiting and retaining foster families, extending child and family services programs, and improving independent living programs.

New Jersey FY2020 Budget Highlights that Impact Children and Families

Highlights of some of the proposed investments outlined in the Governor's speech:

- •A \$68 million increase to maintain and expand access to preschool. These additional dollars will allow more 3- and 4-year-olds from low-income families to benefit from our state's nationally recognized model of high quality preschool.
- •A \$206 million increase in K-12 school funding to put New Jersey on a path to full school funding;
- •A \$15 million increase in child care funding that will improve the child care subsidy system program payment rates, create new incentives to expand infant care and prioritize quality care and services;
- •\$2 million toward the State's outreach strategy for the 2020 Census;
- •\$30 million to increase the Earned Income Tax Credit (EITC) as well as the continuation of the Child and Dependent Care Tax Credit to help low-income working families.

The budget process is just beginning and details regarding the proposed budget increases are still unknown. ACNJ will continue to provide updates as additional information becomes available. These proposals represent a big step forward for New Jersey's children and families.
