## Aurora Deck Lighting - Remote Control Dimmer

RF dimmer is a controller that can adjust light to the appropriate lighting brightness incrementally.

#### **Supplemental Instructions**

This 12V DC Low Voltage Remote Control Dimmer is to be used only with Aurora Deck Lighting DC Transformers and Lighting Products. Failure to follow installation instructions and/or use with other brand products will void the manufacturer warranty.

## **REQUIREMENTS:**

Before you begin, make sure you have an external, weatherproof, protected 110 volt outlet that meets GFCI (ground fault circuit interrupter) standards. Mount the LED Driver Box and Remote Control Driver Box 18 inches above the ground. Best results can be achieved when you have access to the underside of your deck or installation surface.

CAUTION: Use eye protection when using power tools. Do not install more than the recommended deck lights on one driver box. Do not install within 10 feet of a pool, fountain or spa.

#### **Installation Instructions**

Once all of the LED Deck lights have been connected to the wire, connect the male end of the twisted wire pigtail to the Remote Driver Box. Connect the Remote Control Driver wires to the end of the twisted wire using two connectors. The black wire must be connected to the positive wire lead as noted on the transformer, and the white wire must be connected to the negative wire. See Figure #1.



## **Operating Instructions**

There are 4 buttons on your remote control:

**M** = Mode button – allows for quick click adjustment

 $\Lambda$  = Micro adjust UP – Press and hold

V = Micro adjust DOWN - press and hold

**U**= On/Off button



RF dimmer is a controller that can adjust light to the appropriate lighting brightness incrementally. Using the MODE button, click button to adjust from 100% - 70% - 35% - 5%. Pressing and holding the

up/down arrow keys allows for micro adjustment between these increments. Pressing the MODE button again will bring the light back to previous increment. Press the  $\ensuremath{\mathbf{U}}$  button to turn lights on/off.

## **Trouble shooting**

- 1. If your lights do not come on at all, check power to outlet, and inspect wiring system for damage, such as staple, nail, or screw piercing the wire.
- 2. Test the lights using the buttons on the Remote Control Driver Box.
- 3. Next, disconnect the Remote Control Driver Box from the Transformer, and connect the lights directly to the transformer.
- 4. Replace the battery in the handheld remote control with type MN27/A27 battery, 27A 12V.

## **Replacement Remote Controllers**

Your Remote Control handheld device is programmed to the frequency of the Remote Control Driver Box. In the event that you need to replace the handheld, follow the instructions below to reprogram the handheld device:

- 1. Check all connections on the transformer, Remote Control Driver Box, and lights. Confirm that power in on.
- 2. Press and hold both UP and DOWN buttons simultaneously for 15 seconds.
- 3. When the signal light on the hand held flashes, the handheld is programmed to the Remote Control Driver Box.

## **Warranty Information**

The Aurora Deck Lighting Remote Control Dimmer is covered by a one year limited warranty. This product is warranted against defects in materials or workmanship as follows:
