Lookeba-Sickles Board of Education January 22, 2018, 7:00 p.m. Superintendent's Office

The Lookeba-Sickles Board of Education met in regular session to conduct business for the month of January.

The meeting was called to order at 7:00 p.m. by Mr. House. Members present were Casey Horn, Frank Klassen, Chad Cooper, and Tommy House. Also in attendance was Mike Davis and Shirley Gathers. At this time Mr. Davis gave the invocation. Jami Radacy was absent.

Mr. Horn made a motion to approve the Consent Agenda, which included 2017-2018 General Fund encumbrances #131 thru #135. 2017-2018 General Fund warrants #530 thru #619. 2017-2018 Building Fund encumbrances #22 thru #24. 2017-2018 Building Fund warrants #45 thru #54. 2017-2018 Child Nutrition Fund warrants #45 thru #51, that were reviewed and discussed. Mr. Cooper seconded the motion. Voting yes, Mr. Horn, Mr. House, Mr. Cooper, and Mr. Klassen. Motion Passed

Mr. Davis and Mrs. Gathers gave their principals reports at this time. Mr. Davis informed the board that they would now be using Star Reading to replace Dibels and Moby Macs Math at the elementary.

There was no new business to be discussed.


February 19, 2018, at 7:00 p.m., was confirmed as the next regular school board meeting.
