The Lookeba-Sickles Board of Education met in regular session to conduct business for the month of February.

The meeting was called to order at 7:00 p.m. by Mr. House. Members present were Tommy House, Justin Harvey, Jami Radacy, Chad Cooper, and Frank Klassen. Also in attendance were Mike Davis, Shirley Gathers, and Shana Lierle. At this time Mr. Davis gave the invocation.

Mr. Klassen made a motion to approve the Consent Agenda, which included 2018-19 General Fund encumbrances #111 thru #114 and #50042. 2018-2019 General Fund warrants #612 thru #705. 2018-2019 Building Fund warrants #47 thru #51. 2018-2019 Child Nutrition Fund warrants #54 thru #62. 2018-2019 Transportation Bond of 2017 encumbrance #1. 2018-2019 Transportation Bond of 2017 warrant #1, that were reviewed and discussed. Mr. Cooper seconded this motion. Voting yes, Ms. Radacy, Mr. Harvey, Mr. Cooper, Mr. House, and Mr. Klassen. Motion Passed

The re-organization of the school board was discussed at this time. The board voted to remain the same on a motion by Ms. Radacy, seconded by Mr. Klassen, (1) President – Tommy House, (2) Vice-President – Jami Radacy, (3) Clerk – Frank Klassen, (4) Deputy Clerk – Chad Cooper, and (5) Legislative Network Member – Justin Harvey. Voting yes, Mr. House, Ms. Radacy, Mr. Harvey, Mr. Cooper, and Mr. Klassen. Motion Approved

At this time, Mrs. Gathers and Mr. Davis presented their principal's reports.

Superintendent's Report:

Mr. Davis informed the board of upcoming school events and reminded the board of the upcoming Region 10 meeting that will be held at Redlands Community College on February 26th.

There were no vacancies known at this time for the 2019-2020 school year.


March 13, 2019, 7:00 p.m., was confirmed as the next regular school board meeting.


