Lisboa hosts from **8 to 10 February 2016** the **Third International Symposium on Enhanced Landfill Mining (ELFM III)**. Building upon the first two editions which were held in the vicinity of the Remo landfill site in Houthalen-Helchteren (Belgium), this Symposium is expected to attract once more 150 to 200 leading ELFM academics, industry and public body representatives, as well as civil society actors. The participants will exchange and debate their experiences and research results in the field of ELFM, being "the integrated valorisation of landfilled waste streams as materials and energy, using innovative transformation and upcycling technologies while respecting the most stringent social and ecological criteria".

ELFM Seminar organised by the European Parliament

On **20 October 2015** Members of the European Parliament are organising, in interaction with EURELCO, the first ever event which will discuss the merits and pitfalls of ELFM in Europe. The Seminar will have attention for both Municipal Solid Waste landfills and mono-landfills containing industrial residues. The technological, economic and legal aspects of ELFM will also be discussed. At the end of the Seminar a debate will be organised on the future of ELFM in Europe.

Speakers will come from the European Parliament and/or Commission, from EURELCO Members and from other companies, Public Bodies and non-profit organisations.
