Withdraw Proposed H.Res.327

We ask you to withdraw your name and withdraw H.Res.327. Oppose H.Res.327. Whereas,

1. Congress¹, the Supreme Court², Pharmaceutical Manufacturer Inserts³, the CDC, FDA, IOM, and published peer-reviewed research by scientists worldwide all recognize that vaccine-related injuries are legitimate, and that adverse side effects from vaccines are unavoidable, cause serious injuries and death, and that some vaccines have defective designs. Justices of the US Supreme Court opined that families should have additional recourse available to them, when children are injured by vaccines.
2. For 25+ years, the FDA, CDC, NIH, and HHS have been and continue to be in violation of Federal Law SEC. 313. STUDY OF OTHER VACCINE RISKS (a) STUDY.—42 USC 300 aa-1 note⁴ for not complying with vaccine safety study requirements. The Institute of Medicine has repeatedly called for more safety studies and for the identification of injury-susceptible population groups.⁵
3. The National Vaccine Injury Compensation Program (NVICP) has paid out over \$3.76 billion for vaccine injuries and deaths, \$282 million so far in fiscal year 2017 alone.⁶ (Chart 1).
4. A 2017 NVICP Special Master ruled¹⁰ that the preponderance of evidence showed the vaccines actually caused or substantially contributed to death by Sudden Infant Death Syndrome, stating, “The role of inflammatory cytokines as neuro-modulators in the infant medulla has been well described and is likely the reason for a significant number of SIDS deaths occurring in conjunction with mild infection.”
5. It is by improving living conditions that we reduce morbidity and mortality for ALL disease. “Nearly 90% of the decline in infectious disease mortality among US children occurred before 1940, when few antibiotics or vaccines were available.”⁷ (See Chart 2). The United States boasts the top per capita vaccination and health care spending⁸ yet maintains astronomical 5-12 infant deaths per 1000⁹.
6. Department of Health and Human services report states <1% of vaccine adverse events are reported in their Vaccine Adverse Event Reporting System(VAERS), P.6.¹¹ (See Chart 4). In 2016 alone, as many as 6 million short term, long term and lifelong side effects and deaths went unreported.
7. Products vary widely in effectiveness, safety and necessity. Additional adverse events not listed but referred to in Section 13.1 of all vaccine manufacturer package inserts states they have not been tested for carcinogenicity, infertility or DNA mutagenicity.

Whereas drug companies, including the CDC Agency, have financial control over the non-profit organizations who spread biased vaccine information¹², and they use bullying tactics at all levels of government to pass legislation favoring drug company and Agency profits over citizens' health; whereas such legislation increasingly strips citizens of their human right to fully informed medical consent as described in the Nuremberg Code; whereas human beings are not “vaccine-deficient” and do not require pre-cradle-to-grave vaccination for optimal health and wellness; and for all the reasons stated above, we the presenters and undersigned hereby declare proposed House Resolution 327 inaccurate, unethical, and unconstitutional. We will never support elected officials who deny the existence of drug side effects, including vaccine induced short term, long term and lifelong injury and death.

We ask you to withdraw your name as an author and co-sponsor, and withdraw H.Res.327.




