

Experience Perth Hills Valentine's Day Competition Terms & Conditions

1. The Promoter:

The promoter of this Competition is the Shire of Kalamunda (the "**Promoter**") (ABN 60 741 095 678), 2 Railway Road, Kalamunda, WA 6076, Australia.

2. Who May Enter:

- a) An entrant must be an individual and not a company or organisation.
