# Day 1 - NCLCA 2018 Breastfeeding Summit

#### Mission

The mission of this summit is to support, connect, and grow the community of Lactation professionals in NC. Each year the NCLCA Summit brings together lactation consultants from across the state as speakers and participants. Our goal is to provide an opportunity for NC lactation consultants to collaborate, share ideas, mentor each other, and become a cohesive community of health care providers and breastfeeding advocates. This year, we will focus on creating conversations that further our skills, ethics and regional identity.

Description

The 2018 NCLCA Breastfeeding Summit is exactly that, a summit. It is designed to bring North Carolina lactation consultants together, in one place, once a year. The NC Division of Public Health will give an update on state initiatives, and all summit participants will spend facilitated time making decisions about breastfeeding advocacy in their regions. Using case studies and interactive forums such as the Lactation Science Fair, the goal of the summit is to provide practical strategies for lactation consultants to facilitate breastfeeding across the state.

#### **Objectives**

- · Identify how the North Carolina WIC program supports breastfeeding at a federal, state, and local level
- Describe how the North Carolina WIC Program collects and uses breastfeeding data
- Compare North Carolina WIC Program breastfeeding rates to the state and national breastfeeding rates
- Review North Carolina Division of Public Health's breastfeeding training programs, resources and initiatives
- Outline current breastfeeding research and successes in individual perinatal regions in North Carolina
- Identify at least 3 strategies for breastfeeding success in challenging situations
- Explore the use of therapeutic breast massage of the treatment of mastitis
- Identify practical approaches to construct a path to Baby Friendly Designation

# Day 2 - Breastfeeding Symposium 2018

#### Description

The 2018 Breastfeeding Symposium will provide current information and evidence-based practice recommendations related to optimal breastfeeding care and support. This symposium will present topics including opioids, babies and breastfeeding; making the case for breastfeeding; and supporting, promoting and protecting breastfeeding in the Latino population. The program will also include afternoon breakout sessions for Peer Counselors and others working with breastfeeding mothers. Topics for these sessions will include: community support for breastfeeding; jaundice and breastfeeding; breastfeeding counseling and education and a panel discussion on weaning.

### **Objectives**

- Discuss challenges and tools to help families dealing with infants with Neonatal Abstinence Syndrome reach their breastfeeding goals
- Discuss how breastfeeding advocates, lactation consultants and peer counselors deal with these parents in a way that can support, promote and protect breastfeeding; Review the data and best practices for this vulnerable population
- Explore the evidence for exclusive breastfeeding and the Baby Friendly Hospital Initiative in light of recent claims in the media
- Discuss how anyone in healthcare can support breastfeeding; Discuss how Queen City Cocoa B.E.A.N.S. is striving to make a difference; Review the incidence of infant and maternal mortality
- List 3 strategies for enhancing communication with clients/patients by employing a strength-based approach to counseling and education
- Identify strategies to help empower, support and reclaim breastfeeding in Latinx families
- Identify differences between physiologic and pathologic jaundice in the newborn
- Describe the relationship between breastfeeding and jaundice at 1-3 days of life compared to 1-3 weeks of life
- Describe 2 risk factors for physiologic and pathologic jaundice in the newborn
