## **COVERING LETTER TO POLITICIANS**

**Subject: RBT Violates Right to Privacy**

## **NINE'S AFTERNOON NATIONAL NEWS - 4:30pm August 8, 2016**

“Random Breath Testing and Cannabis Swabbing - South Australian Police blitz primary schools as Moms drop off their children. Three mothers arrested and dragged off to lockup as Police strike fear into toddlers”.

**O.K. - SO WHAT HAPPENS NOW?** (Lets look at just one scenario):

The law abiding mother is charged, fingerprinted, criminalised and fined for having a minuscule trace of cannabis or .050 of alcohol in her blood. A residue from a dinner party the night before. She, loses her licence, can't drive her car or run her child to and from school and can't get to her part time day job. The mother and child are stigmatised by neighbours and at school.

The fine and loss of her job eats into their tight budget and bills don't get paid. The husband who works 60 hours a week has to look after the child's transportation needs, do the shopping and all the running around. This puts immense pressure on the entire family and arguments break out.

The depressed mother can't cope so starts on prescription drugs and drives her car again. She gets caught for driving without a licence and is heavily fined once more and loses her licence for much, much longer. The child thinks it's his fault and withdraws. “If I hadn't asked Mom to drive me to school none of this would ever have happened. Now they bully me at school and I don't know what to do”.

The husband can no longer cope with the pressure of work and family and loses his job and then the house goes. The family falls apart and that beautiful, loving, intelligent woman and mother feels helpless and useless but takes control one last time... She O.D's on pharmaceuticals.

The talented child who would have become a hard working tax paying citizen has a huge chip on his shoulder, hates the police with a venom, turns to drugs and crime and ends up in juvenile detention where he plots his revenge against the system that abuses him every day, killed his mother and destroyed his life.

The father develops a “I don't care” attitude, takes alcohol and gambles as a diversion - He feel now that he's been screwed over by society and figures that “You can all go and get stuffed”. No more work and no more tax to the Government that crippled him. He throws in the towel and searches for any means of escape. He takes up residence at the end of a bar and fades quietly into the night.

That's the butterfly effect... Form an innocent fun loving dinner party to oblivion via a RBT. Mother dead, father and child destroyed beyond repair... The Police need to ask themselves what the consequences of their actions are going to be?

Family is the foundation stone of society and is entitled to protection by the State. That's right, that is the State that just destroyed a perfectly good nuclear family and they have destroyed thousands more just like it.

3.4 MILLION random breath tests were conducted by Police last year in NSW alone. At any one time around 125,000 Australians have lost their licence to a RBT. An action that violates basic human rights and has a devastating and lasting impact on our struggling economy. All this to make the police feel big and strong and all powerful for beating up mothers who are taking their small children to school.

## **HUMAN RIGHTS VIOLATIONS (In relation to the above news storey)**

**Random Breath Testing:** In UK and US law police need a reason to suspect that a driver is intoxicated, before requesting a breath and/or sobriety test. i.e. (Due cause).

Not so in Australia where the human right to privacy and bodily integrity are violated.

**Drug Driving Laws:** It is held that random cannabis swabbing violates human rights in terms of right to privacy and bodily integrity. Also, zero tolerance means you will be criminalised, may lose your licence and be heavily fined even though you are not physically or mentally impaired. Again, this is happening without due cause.

*Violation of UDHR Article 12 - No one shall be subjected to arbitrary interference with their privacy. Everyone has the right to the protection of the law against such interference.*

*Violation of UDHR Article 3 - Everyone has the right to security of person.*

*Violation of UDHR Article 5 - No one shall be subjected to inhuman or degrading treatment.*

**NOTE:** Like those adopted in the USA and UK, there are other effective deterrents to drink driving and drug driving that don't violate human rights. e.g. If someone is in an accident, driving erratically or breaks a road rule, by all means breath test them. Also, concurrently as a deterrent, increase DUI penalties. If need be crush cars. Otherwise, respect a persons right to privacy and leave them alone!

## **HUMAN RIGHTS IN AUSTRALIAN**

### **UNIVERSAL DECLARATION OF HUMAN RIGHTS 1948 (UDHR)**

The Universal Declaration of Human Rights is an international document that states basic rights and fundamental freedoms to which all human beings are entitled. No nation may rightfully deprive a person of a human right. Human rights are fundamental rights universal to all human beings and are considered to be the necessities of human existence. They are internationally recognised personal guarantees and freedoms that the Government cannot abridge, either by law or by judicial interpretation. The *UDHR* is generally agreed to be the foundation of international human rights law and yet, Australian Public Servants blatantly ignore them.

Since there is no mechanism for civil rights protection in Australia and since the Universal Declaration of Human Rights is written into international law then, this is where we must turn for protection of our rights. Australia was a key player and one of 8 nations involved in the drafting of the Universal Declaration of Human Rights adopted by the United Nations General Assembly on 10 December 1948.

We would be seen as hypocritical not to fully embracing something we helped create.

### **UNITED NATIONS GENERAL ASSEMBLY PROCLAMATION**

The United Nations General Assembly proclaims the Universal Declaration of Human Rights 1948 (*UDHR*) as a common standard of achievement for all peoples and all nations, to the end that every individual and every organ of society, keeping this Declaration constantly in mind, shall strive by teaching and education to promote respect for these rights and freedoms and by progressive measures, national and international, to secure their universal and effective recognition and observance, both among the peoples of Member States themselves and among the peoples of territories under their jurisdiction. As a member state, this includes Australia.

## WHERE WE STAND IN 2016

Politics of Australia incorporate elements from the UK Westminster system (State) and United States Congress (Federal). Yet, international human rights embraced by both the UK and USA are ignored in Australia? Are we a free and democratic society, who respect international law or not! ***Our Governments are elected to administer, not to control.*** As a free nation we cannot tolerate being abused and oppressed by our own public servants.

Any excuses put forward by those same public servants, for their oppressive actions, are pathetically disproportionate, and pale into insignificance, compared to the internationally recognised freedoms and human rights of an entire nation. What's lacking in the Australian Constitutions is also no excuse and is, in fact, more reason to embrace the UN Universal Declaration of Human Rights.

We can't let any person or group or any government department be a law unto themselves? These are the people who feed off us. The bullies, the oppressors and controllers who undermine and drag down all of society to justify their own existence. The alarmists with police state and totalitarian mentalities intent on a dark future.

Prime Minister Malcolm Turnbull is correct in saying that for Australia to flourish we need to be seen as the innovation nation and this suggests being ahead of the times. To hold our heads up high, on the international stage, first we need to step out of the dark ages and loose the penal colony mentality.

Going on a witch hunt for those responsible, for lost human rights, is a negative response. The positive response would be to follow the lead of the UK and the USA and change the mind set from control and oppression to freedom and liberation. If they can do it with populations of 65 million and 326 million respectively, we can do the same thing for 24 million Australians. The UDHR mechanism is already in place.

A starting point, for change, would be to amend oppressive legislation and reinstate the lost human rights referred to. And again, this is where we need to engage our politicians. Those who speak for us and those who will stand up for the rights of all Australians.

*UDHR Article 21 - 1. Everyone has the right to take part in the government of their country, directly or through freely chosen representatives.*

Also, it follows that there needs to be an amnesty for any Australian imprisoned, directly or indirectly, as a result of abuse of their human rights. As an example that would be a person imprisoned as a result of a RBT violating their right to privacy without reason to suspect that the driver was intoxicated. i.e. Without due cause.

*Violation of UDHR Article 12 - No one shall be subjected to arbitrary interference with their privacy. Everyone has the right to the protection of the law against such interference.*

## SUMMATION

I should point out that, with RBT, the police have an unlimited supply of law abiding, tax paying citizens to feed off and the fact that there have been 3.4 million RBT's in NSW in the past year is testament to that. Again, one needs to ask. "How many of these people have the police pulled out of the crowd, at random, and taken away their drivers licence. Nationally, the answer is around 125,000 at any given time and the impact on them, their families and a struggling economy is devastating".

**SUMMATION** cont'd

This is a barbaric and outrageous violation of our rights and, cannot be justified. I can only conclude that it's easier for the police to create criminals out of average Moms and Dads, rather than get out there and catch the real criminals who rape, pillage and plunder our cities. The Police need to re-deploy their abundant and talented work force to protecting society rather than destroying families. By undermining society the police are just as bad as the criminals!

***Breathalyser legislation needs to change to incorporate our right to privacy and due cause. Lets drop the penal colony mentality and move forward.***

The Universal Declaration of Human Rights is a declaration of freedom and, in the words of Senator Malcolm Roberts "You can only have human progress if you have freedom". Using RBT violates our right to privacy and removes that freedom!

We should not have to battle through the High Court of Australia for fundamental human rights or the civil liberties embraced by our contemporaries, they should be automatic. To stop the abuse our rights need to be 1st. acknowledged by Government and then 2nd. written into Australian law either through amendments to the Australian Constitution or an Australian Bill of Rights. As a Nation, maybe then, we can rejoice.

Keep in mind that our forbearers fought and died for our freedom. One of those freedoms is the right to privacy ***recently taken away from us*** by an over zealous and controlling Public Service and the State Political Party that endorsed those oppressive legislation.

62,000 young Australian men and women went to war and gave their lives. We have an obligation to respect and protect the freedom they fought for and our Public Servants and Politicians need to stay squarely focus on that.

We should be seen as the country who leads the world in human rights issues and yet here we are... Until we change Australia will continue to be looked upon as the Country that abuses its children, has no regard for human rights and has a disregard for international law. Besides being oppressive, it's shameful. We need to step up.

## ADJUNCT - DRINK DRIVING STATISTICS

Since 1997, Victorian Police have breath tested more than 20 million drivers and bike riders from RBT operations, catching close to 70,000 with a blood alcohol concentration (BAC) greater than 0.05g/100ml.

The majority (99.7%) of drivers and riders tested do not exceed prescribed blood alcohol levels. They have just been seriously inconvenienced and paid dearly for the privilege . Evert time you are breath tested it costs you roughly \$100 in tax.

The proportion of drivers and motorcycle riders killed with a BAC greater than 0.05g/100ml has increased from 27% in 1992 to 28% in 2013-15. The average throughout this 20 year period remains the same at about 45 drivers and riders killed each year. As verified by the TAC graph below.

From these statistics it appears that the RBT is having no discernable impact other than the outrageous cost to taxpayers and, the devastating and destructive effect it is having on our struggling State economies.

There are more effective deterrents to DUI that don't deny us our fundamental right to freedom. That freedom being our right to privacy. In the U.S.A. and U.K. the DUI management plan does not include RBT's for reasons previously outlined.

This is telling me that 20 million people have had their freedom and right to privacy violated and 70,000 taxpaying mothers and fathers, also in violation of their rights, have been criminalised and lost their licence with a devastating impact to them, their jobs, their families and their children.


If you are serious about saving those 45 lives, a year, you are NOT going to do it with RBT's. Now ask yourself: "Without Random Breath Testing (RBT) what penalties would stop you from Driving Under the Influence?" Perhaps a \$20,000 fine and community shaming concurrently with the public crushing of your car... Make a day of it.

## CONCLUSION

Do the sums:- Hardware & labour for each breath test = \$100 x 20 million = \$2 Billion  
Fines Revenue @ \$1,000 x 70,000 = \$70 Million. Cost to taxpayers = \$1.93 Billion  
That's \$1,930,000,000 of taxpayers money wasted in the Victorian model alone?

With all the evidence pointing away from any good reasons to persist with RBT's why then are we still burdened with it? Other than Breathalyser Sales & Service Pty Ltd. supplying RBT units to the Police Force and also donating to the Police Force.

***You can't put what the Police want or what a (2 share) Company wants ahead of the freedom of an entire Nation... Not this Nation - Not Australia!***



As the name implies, public servants serve the public and, they are accountable.


***In view of the above, one needs to ask the big question: "Is the Australian population literarily being held to ransom?" I don't know about you but, I would like some answers!***

If you are still arguing in favour of RBT's you have missed the point on a number of levels:


- (1) RBT's are in breach of the UDHR - Article 12 and **violate our right to privacy**.
