my apologies for the delay. The information you have below from Transparent California is correct as reported. The two comments made at the Board meeting was that Ms. Schultz makes \$133,000 and that she gets paid \$134,000. That is not accurate. The total compensation amount listed of \$134,590.63 is the total cost of the position for the calendar year from January through December. That figure includes the required statutory benefits, such as worker's compensation and other required payroll taxes. Salary for that position is paid based on the salary schedule link that I sent to you in an earlier email. In this case, the amount reported for salary includes a retroactive increase that was brought forward to the Board in the 15/16 fiscal year.

Please let me know if I can clarify anything further for you.
