Notice of Vacancy on Tuolumne County Transportation Council (TCTC)

The Tuolumne County Transportation Council (TCTC) and Tuolumne County Transportation Agency (TCTA) is actively recruiting potential candidates for one At-Large member from the general population of the County.

The TCTC is the Regional Transportation Planning Agency for the Tuolumne County Region. Staff at Pacific North-South Connector, Pacific Regional Transportation Plan, Statewide Connector, Statewide Range Transit Plan and Active Transportation Program. The TCTC does not directly do the planning work, but directs staff and private consultants through the process.

The TCTA oversees transit services in Tuolumne County, including Tuolumne Transit, Yosemite Area Regional Transit System and other Regional Services Transportation Providers.

Duties consist of:

- Attending 12 evening meetings per year at the Tuolumne County Board of Supervisors Chambers, 2 South Green Street, Sonora, California.
- Working with and overseeing staff development of general budget.
- Supervise the efforts of the Regional Public Transportation System.
- Administer transportation planning projects.
- Review and comment on completed transportation studies.
- Establishing Transportation Funding Priorities.

While any person residing within Tuolumne County may apply and be appointed, desirable qualifications include a background or interest in transportation and/or transit services. TCTC and TCTA are responsible for future transportation planning and the future of the County should be concerned and motivated to look and further well into the 21st Century. The transportation field is a complex and the selected individual will need to review and conduct a substantial amount of technical reading.
