

**Resolution of the
Tuolumne County Transportation Council**

Allocating Local Transportation Funds from the Bicycle/Pedestrian Projects Reserves to
the City of Sonora for the Crosswalk Improvements at Restano/Stewart/Mono Way
Intersection

Whereas, as the Regional Transportation Planning Agency for Tuolumne County, the Tuolumne County Transportation Council is responsible to administer the Transportation Development Act (TDA) Program for the Region; and

Whereas, administration of this Program includes, but is not limited to, considering claims against and making allocations from the Local Transportation Fund; and

Whereas, the Tuolumne County Transportation Council maintains a reserve of Local Transportation Funds for Bicycle/Pedestrian projects, historically setting aside 2% of the total each year for this purpose; and

Whereas, the County of Tuolumne submitted request for \$25,000 in Bicycle/Pedestrian Local Transportation Funds Reserves to contribute to the cost of the Washington Street Overlay Project; and

Whereas, the TCTC has a current unobligated fund balance of \$84,999 in the Bicycle/Pedestrian Local Transportation Funds Reserve; and

Whereas, the Tuolumne County Transportation Council has found that the request and allocation of funds is consistent with the purpose and regulations pertaining to Local Transportation Funds, including Article 8, Section 99400(a), of the Transportation Development Act.

Now, Therefore, Be It Resolved that the Tuolumne County Transportation Council allocates \$25,000 in Local Transportation Funds from the Bicycle/Pedestrian Projects Reserves Fund to the County of Tuolumne to complete the Restano/Stewart Street/Mono Way intersection crosswalk project.

Be it further resolved that the Tuolumne County Transportation Council makes this allocation on the condition that the City complies with the requirements for the use of Local Transportation Funds from the Bicycle/Pedestrian Reserve.

Be it further resolved that this funding allocation incorporates the terms and conditions included in Master Funding Agreement between the City of Sonora and TCTC.



Darin:

As we discussed, in conjunction with the Washington Street Overlay Project, which also includes work at Restano, Stewart Street and Mono Way, the City would like to install a cross walk at the north side of the Restano and Stewart Street intersection. The work would require the reconstruction of the handicap ramp at the north west corner; cross walk striping; construction of a pedestrian ramp on the east side of Stewart Street; and, installing pedestrian signals, buttons and signs.

As I understand, there may be funds available in the TCTC LTF Bicycle/Pedestrian reserve account. The cost of this project has been preliminarily estimated at \$25,000 (assuming the project does not necessitate any traffic signal pole relocation). The City would submit request(s) for reimbursement and cover any costs in excess of the estimated amount.
