## Resolution of the Tuolumne County Transportation Council Unmet Transit Needs Findings for Fiscal Year 2017/18

Whereas, pursuant to the Transportation Development Act (TDA), the Tuolumne County

Transportation Council is mandated to consider and make findings regarding the adequacy of all transportation services throughout the County on an annual basis; and,

Whereas, pursuant to Section 99401.5, of the Transportation Development Act, as the basis of this process, the Tuolumne County Transportation Council has defined "Unmet Transit Needs" and "Reasonable to Meet" criteria in Resolution 515-15; and,

Whereas, pursuant to Sections 99238, 99238.5 and 99401.5(a), of the Transportation Development Act, the Tuolumne County Transportation Council has established and received input from the Social Services Transportation Advisory Council; and,

Whereas, pursuant to Article 8, Section 99401.5(b), of the Transportation Development Act, the Tuolumne County Transportation Council has identified the transit needs of the jurisdiction, which have been considered a part of the transportation planning process; and,

Whereas, pursuant to Article 8, Section 99238.5 of the Public Utilities Code, the Tuolumne County Transportation Council advertised and held a public hearing on September 14, 2016 in order to receive public input regarding any unmet transit needs which might exist in the County; and,

Whereas, the Tuolumne County Transportation Council considered all testimony received on the matter of unmet transit needs in the Tuolumne County region and made findings based on their adopted definitions and criteria described in Resolution 515-15; and,

Whereas, for the 2017/18 Fiscal Year, the Social Services Transportation Advisory Council reviewed and recommended there are no unmet transit needs that are reasonable to meet in the Tuolumne County Region; and,

Whereas, pursuant to Section 99401.5, of the Transportation Development Act, the Tuolumne County Transportation Council has prepared the Unmet Transit Needs Findings Report to address comments received during the public participation process and make findings for Fiscal Year 2017/18.

<b>Now, therefore, be it resolved</b> that the Tuolumne County Transportation Council hereby adopts the
Unmet Transit Needs Findings Report for Fiscal Year 2017/18 finding that there are no unmet transit needs
that are reasonable to meet.
