Subject: Appointment of Paul Slemmons to the Tuolumne County Transportation Council (TCTC)
Citizen's Advisory Committee (CAC) as Representative of District 2

Background:

The Citizen's Advisory Committee provides input to the TCTC on all matters relating to the regional transportation system. Membership of the CAC consists of eight total members with staggered four-year terms. The Sonora City council appoints two members and the County Board of Supervisors appoints six members. Each Board member, with the exception of the District Four Supervisor, appoints one person from their respective district. The District Four Supervisor appoints two individuals, one from the Groveland area and one from the East Sonora area. The Board of Supervisors customarily ratifies each Board member's appointment.

Presently, vacancies exist in Supervisorial Districts 2, 4 (East Sonora) and 5. Staff has received an application from Mr. Paul Slemmons for appointment to be the District 2 Representative. The term for this vacancy expires on March 31, 2020. Staff is requesting that the Board appoint Mr. Slemmons to fill in the remainder of this term.

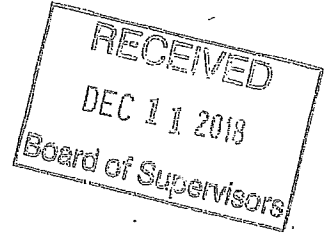
Recommendation:
